Independent Auditors' Report

To the Participants and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mathematica Group Holding Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of the Mathematica Group Holding Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is an employee stock ownership plan (ESOP) established effective January 1, 2005, as restated January 1, 2021. The Plan covers all employees, excluding employees covered under a collective bargaining agreement, leased employees, independent contractors, employees of departments 50, 51, 52, 53, 54, 55, 56, 57, 58, 59, 98 and nonresident employees, of Mathematica Group Holding Inc. and its wholly owned subsidiaries (collectively, the Company) who have completed six months of service.

The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Administrative Committee is responsible for oversight of the Plan. The Plan's Administrative Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Directors.

The Plan purchased Company common shares using the proceeds of a borrowing from the Company (Loan) and held the stock in a trust established under the Plan. The Loan was paid off in full during 2015 through fully tax-deductible Company contributions to the trust fund. As the Plan made each payment of principal, an appropriate percentage of stock was allocated to eligible employees' accounts in accordance with applicable regulations under the Code. Shares vested fully upon allocation.

The fair value of the Company shares as of year-end is determined annually by an independent valuation firm. As of December 31, 2024 and 2023, there were 701,559 and 713,207 shares allocated in the ESOP, respectively. For 2024, the ESOP expense resulted in an additional 42,468 shares, allocated on December 31, 2024.

In 2024, the Company repurchased 58,232 shares of its common stock at fair value under the ESOP trust agreement for eligible employee investment diversifications, in-service distributions, segregation or Required Minimum Distributions, as defined by the ESOP provisions, for a total of \$24,984,484. The Company redeemed 53,877 shares, for a total of \$23,116,045 at fair value, and repurchased 4,355 shares, for a total of \$1,868,439 at fair value. The repurchased shares entered at the ESOP trust of which 4,355 shares were purchased by eligible employees through the ESOP-Directed Profit Sharing Plan (PSP) Contribution Account, for \$1,868,439. In 2024, the Company repurchased 249 shares of its common stock at fair value under ESOP trust agreement for required minimum distributions to recycle to ESOP participants, as defined by the ESOP provisions, for a total of \$106,845.

Contributions

In 2015, the Plan was amended to permit participants to direct Company matching contributions from the Mathematica Group Holding Inc. Profit Sharing Plan toward the purchase of common stock of Mathematica Group Holding Inc. held in the Plan. Participants elected to purchase shares of Mathematica Group Holding Inc. common stock totaling \$666,571 and \$1,878,400 as of December 31, 2024 and 2023, respectively, and the Plan has recorded an ESOP directed PSP contribution receivable due from the Company. Mathematica Group Holding Inc. shares were purchased by the Plan from the pool of recycled shares available from departing participants that received distributions. Purchased shares were allocated to electing participants account balances in 2024 and 2023 at the fair value of the stock as of December 31, 2024 and 2023.

Dividends

The Company's Board of Directors may authorize an S-Corp distribution that would be paid to the Plan. S-Corp distributions is a distribution of earnings. If it is pass-through to the participant, it would be eligible for rollover and taxed as ordinary income. If the S-Corp distribution was done in the form of stock, it would stay in the trust and not pass-through to participants due to the restrictions of S-Corp Stock (no more than 100 holders).

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with, on the last day of each plan year, an allocation of the Company's common stock shares released by the Trustee. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Also, for participants who retire at age 65 or later during the plan year, die or become disabled, a contribution will be made on their behalf. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated, as defined in the plan agreement, to each participant's account based on the ratio of the participant's account balance to all participants' account balances.

Vesting

Participants are immediately vested in all contributions plus actual earnings thereon; therefore, there are no forfeitures in the Plan.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by TI-Trust, Inc., the Trustee, prior to the time that such rights are to be exercised. The Trustee will vote the shares of the Company stock which are not allocated to any participant's account and shares that have been allocated to the participant's account but for which no voting directions have been received in the same proportion as the trustee vote the shares for which they have received voting instructions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of Individual Retirement Account (IRA). Distributions are made in shares, whole and fractional, which then forces out an immediate conversion to cash. The amount to be distributed is based upon the immediately preceding valuation date.

The Trustee and the Company have the right of first refusal to acquire any shares of the Company stock distributed to the participant, which the participant desires to sell. Also, participants have the right to require the Company to repurchase participant shares of the Company stock, which have been distributed under the terms of the Plan.

The Company's Board of Directors may authorize upon recommendation of the Administrative Committee to segregate prior participants Company stock or transfer account share and convert the shares to cash. If the segregation is authorized by the Board of Directors, participants who do not elect to receive a distribution during the Plan's distribution window for the plan year following the plan year in which the employee terminates employment will be segregated from the ESOP and their Company stock and transferred account shares will be converted to cash based on the value of a share of Company stock determined as of the year-end valuation date for the plan year in which the termination of employment occurs.

Put Option

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants who are at least 55 years old and have participated in the Plan for at least 10 years (a Qualified Participant). During each of the first five years of eligible diversification, a Qualified Participant may withdraw up to 25% of the value of their investment in Company common stock, less any shares previously diversified, and transfer the amount as a rollover into another qualified plan or as a cash withdrawal. In the sixth year, the percentage amount that can be withdrawn increases to 50%. The election to diversify is made subsequent to year-end based upon the shares of Company stock in the participant's account at year-end.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at values that approximate fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The common stock of the Company is unregistered and does not trade in an established market. The common stock of the Company is valued at fair value as determined annually by an independent appraiser. Because of the inherent uncertainty of any valuation estimation process, the estimated fair value may differ significantly from the value that would have been used had a ready market for the securities existed and the difference could be material.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Recent Regulatory Updates

The Setting Every Community Up for Retirement Enhancement (SECURE) Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Subsequent Events

Subsequent events were evaluated through October 7, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Company common stock: Valued at \$397.28 and \$429.05 per share at December 31, 2024 and 2023, respectively, as determined by an independent appraiser and therefore the value of the common stock is considered a Level 3 value due to the significant unobservable inputs inherent in a single independent appraisal. The valuation uses both the discounted cash flow and guideline public company methodologies, which utilize projected cash flows and reflects the risk adjusted value inherent in long-term prospects of the business.

The discounted cash flow methodology utilizes a 10-year model that discounts projected annual debt-free cash flows of the Company. This methodology reflects the risk adjusted value inherent in the long-term prospects of the business based on a forecast discussed with management. The guideline public company methodology is intended to demonstrate how investors value companies that participate in similar markets and are affected by similar economic factors. Comparable company multiples have been discounted for advantage over the Company such as access to debt and equity markets, size and product diversification.

Money market fund and certificate of deposit: Valued at the quoted net asset value (NAV) of shares held by the Plan at year-end.

Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

6. Related-Party and Party in Interest Transactions

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

The Plan invests in Company common stock. These are related party and party in interest transactions. As described in Note 2, the Company may pay plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

7. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to plan provisions. Upon termination of the Plan, the Administrative Committee directs the Trustee to pay all liabilities and expenses of the Plan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the plan agreement and the IRC.

8. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated November 28, 2016, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

As of December 31, 2024 and 2023, the Plan had investments of \$261,942,579 and \$296,493,679, respectively, that were concentrated in Company stock.
