Note 1. Summary of significant accounting policies

Basis of accounting

The financial statements of the Walt's Food Center 401(k) Profit Sharing Trust (the "Plan") are prepared using the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis, and related fees are charged directly to the borrowing participant's account when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. During the year ended December 31, 2024, delinquent loans reclassified as benefit payments were \$568 (none for 2023).

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. All of the Plan's investments are participant directed.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Note 2. Description of Plan

The following Plan description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Walter Lagestee, Inc. (the "Employer") and covers all full-time employees who are at least 21 years of age and have completed one year of service. Participants who are at least 18 years of age but less than 21 shall accrue years of service with the Plan for the purpose of determining vesting in future Employer contributions. The Plan is governed by a Board of Trustees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to the maximum amount allowed under the Internal Revenue Code, and those who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan, and the Plan allows participants to designate a portion of their contribution as a Roth elective deferral. Further, the Plan provides a safe-harbor matching contribution from the Employer equal to 100% of the first 3% of a participant's contributions, plus 50% of a participant's contributions between 3% and 5% of their eligible compensation. The Plan also allows for the Employer to make an additional contribution, solely at the discretion of the Employer's Board of Directors.

Participants' accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer contribution, (b) Plan earnings, (c) forfeitures of terminated participants' nonvested accounts, and charged with an allocation of any administrative expenses paid by the Plan. Employer contributions are allocated using a factor of the participants' annual wages. Earnings, forfeitures and administrative expenses are allocated based upon participant account balances, as defined in the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's discretionary contribution portion of their accounts plus actual earnings thereon commences as of December 31, next following the completion of one year of service, as defined in the Plan. Participants normally become fully vested in this discretionary contribution after six years of service. In the event of death, disability or retirement at designated ages, a participant's account becomes fully vested.

Note 2. Description of Plan (continued)

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at the rate of 9.50%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Payment of benefits

Upon retirement, termination of service, death, total or permanent disability, or reaching age 70½, participants are eligible for lump-sum benefit payments based upon their vested interest in their account.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3 and \$61, respectively. These accounts may either be reallocated to participants, used to reduce employer contributions, or used to pay administrative expenses of the Plan. In 2024, forfeitures of \$206 were used to reduce employer contributions (\$2,649 in 2023). Also, in 2024 forfeitures of \$62 were used to pay administrative expenses (\$897 in 2023).

Note 3. Investments

As of December 31, 2024, Voya Retirement Insurance and Annuity Company ("VRIAC") holds the funds for the Plan and maintains an individual account for each participant. Contributions made on a participant's behalf are directly allocated to that participant's account and are invested, based on the individual's direction, in pooled separate accounts and/or guaranteed investment contracts.

Note 4. Fair value measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value at the reporting date.

Note 4. Fair value measurements (continued)

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There were, however, no investments for 2024 or 2023 whose fair values were measured using the fair value hierarchy.

*Investment measured at net asset value*

The investments measured at net asset value (NAV) represent units of pooled separate accounts maintained by the trustee, VRIAC, and are comprised of investments in various mutual funds. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments, nor are there participant redemption restrictions for these investments. Investments measured at net asset value are not classified in the fair value hierarchy described above.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation (depreciation) in fair value of investments.

It is the policy of the Plan to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3.

Note 5. Guaranteed investment contract with insurance company

The Plan entered into a fully benefit-responsive investment contract with VRIAC who maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract meets the fully benefit-responsive investment contract ("FBRIC") criteria and, therefore, is reported at contract value in the statements of net assets available for benefits. Contract value is the relevant measure attribute for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VRIAC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise, and there is no maturity date on the contract. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1%. Such interest rates are reviewed on an annual basis.

Certain events limit the Plan's ability to transact at contract value with issuer. Such events include: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (e) premature termination of the contract. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a breach of a material obligation under the contract, or (d) a material misrepresentation.

Note 6. Plan termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Date of management's review

Subsequent events were evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

Note 9. Information prepared and certified by the trustee

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by VRIAC, the trustee of the Plan.

Note 10. Related party transactions

Certain administrative expenses have been paid by the Employer on behalf of the Plan. These expenses, however, are not material to the financial statements.

Certain employees of the Employer have been appointed as Trustees of the Plan. These employees are also participants in the Plan. They do not receive any compensation from the Plan for their services as Trustee.

Note 11. Income tax status

The Internal Revenue Service ("IRS") has determined and informed the Plan's third party administrator by a letter dated June 30, 2020, that the non-standardized pre-approved Plan and the related trust are designed in accordance with applicable provisions of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, including an amendment in 2022 in order to implement the SECURE Act, the CARES Act, and other law changes, the Trustees and Plan administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax position that more likely than not would not be sustained upon examination by the IRS. As the Plan is tax-exempt, the Plan administrator has concluded that there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.
