We have performed audits of the financial statements of the Wipaire, Inc. ## Wipaire, Inc. Profit Sharing Plan Notes to Financial Statements

### NOTE 1 - PLAN DESCRIPTION

The following description of the Wipaire, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established with an effective date of August 1, 1978, by Wipaire, Inc. (the "Sponsor"). The Plan effectively covers employees of Wipaire, Inc. and affiliates Fire Boss, LLC and Advanced Flight Training & Leasing, (collectively, the "Employer"). The Plan was most recently restated effective July 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Sponsor is the administrator of the Plan ("plan administrator") and has appointed several employees and an officer of Wipaire, Inc. to serve on a committee ("Investment Committee") to carry out the duties and responsibilities of the plan administrator. The Employer has engaged Strategic Retirement Partners ("investment advisor") to provide advice on investments and Plan administration.

#### **Eligibility**

Effective July 7, 2023, employees of Wipaire, Inc., Fire Boss, LLC, and Advanced Flight Training & Leasing, LLC are eligible to participate in the Plan upon attaining age 19 and completing 30 days of service. Prior to July 7, 2023, employees were eligible to participate in the Plan upon attaining age 21 and completing 30 days of service. Employees commence participation in the Plan on the first day of the month immediately following or coinciding with the date the employee meets the eligibility requirements of the Plan. Nonresident aliens and members of collective bargaining units, unless the bargaining agreement provides for participation, are not eligible to participate in the Plan.

#### **Contributions**

Participants may elect to make salary contributions, on a pre-tax or after-tax (Roth) basis, up to the maximum allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Employer may make discretionary profit-sharing contributions. There were no discretionary profit-sharing contributions made during the years ended December 31, 2024 and 2023. Employees must be employed on the last day of the Plan year and work 1,000 hours during the Plan year to be eligible for the profit-sharing contribution. Matching contributions were equal to 100% of the elective contributions made by participants, up to 4%. December 31, 2024. Contributions are subject to certain limitations.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in the designated default fund until changed by the participant. The provision includes an automatic increase of 2% annually, up to 14%.

### NOTE 1 - PLAN DESCRIPTION (CONTINUED)

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, employer matching contributions, rollover contributions, an allocation of employer profit-sharing contributions, Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participant accounts are valued daily. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are always fully vested in their contributions plus actual earnings or losses thereon. Participants vest in employer contributions over a graded period of five years, starting with 20% vesting after one year of service and 100% vesting after five years of service. The Plan also provides for 100% vesting at the normal retirement date as defined in the Plan, or at termination if due to death or disability of the participant.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note terms range from one to five years or up to 30 years for the purchase of a primary residence. The notes are secured by the vested balance in the participant's account and bear interest 1% above the prime rate on the date the note is requested. Principal and interest is paid ratably through biweekly payroll deductions. A participant may have no more than two outstanding notes at any one time. If note payments by participants are delinquent, they are considered a deemed distribution in the Plan year they are delinquent.

#### **Payment of Benefits**

Under the terms of the Plan, participants may receive distributions in the form of substantially equal installments, a partial withdrawal, or a lump sum from the Plan upon a participant's termination of employment, retirement, disability, or death. The Plan generally requires lump sum distributions of account balances of less than \$7,000 upon termination. Automatic distributions greater than \$1,000 but less than \$7,000 without the participants' consent will be paid in a direct rollover to an Individual Retirement Account (IRA). Noted prior to April 2024, this threshold was \$5,000. The Plan also allows in-service distributions in the event of financial hardship or if the participant has attained the age of 59½.

#### **Forfeitures**

Forfeitures within the Plan can be allocated to participants who are entitled to share in the contribution for that Plan year in the same manner as the employer discretionary profit-sharing contributions. The Plan also allows forfeitures to be used to pay Plan expenses, reduce the funding of employer contributions, added to employer contributions, and used to reinstate previously forfeited account balances. At December 31, 2024 and 2023, forfeited accounts totaled \$2,185 and \$1,160, respectively. For the years ended December 31, 2024 and 2023, \$27,011 and \$9,001, respectively, were allocated as forfeitures to eligible participants, used to pay Plan expenses or reduce employer contributions.

#### **Investment Options**

Upon enrollment in the Plan, a participant may direct contributions in various investment options. Participants may change their investment options daily.

### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor, trustees, and insurance company. See Note 4 for discussion of fair value measurements.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The fully benefit-responsive investment is presented on the face of the statements of net assets available for benefits at contract value, which approximates fair value. Contract value represents contributions made under the contract, plus interest at the contract rate, less withdrawals and less funds used to pay administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year.

#### **Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### **Notes Receivables from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### Payment of Benefits

Benefits are recorded when paid.

#### Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Funding Policy

Employer discretionary matching contributions are generally remitted to the Plan at the same time as employee deferrals. Employer discretionary profit-sharing contributions are remitted to the Plan generally in March following the end of the Plan year.

### NOTE 3 - CERTIFICATIONS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (trustee of the Plan).

### NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE 4 - FAIR VALUE MEASUREMENTS (CONTINUED)**

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* Valued using the NAV of units held by the Plan at year end. The NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 5 - GUARANTEED INVESTMENT CONTRACT

The Plan invests in a traditional fully benefit-responsive guaranteed investment contract with American United Life Insurance Company (AUL). AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on an annual basis for resetting.

The guaranteed investment contract can be terminated by giving notice and electing form of payment outlined in the contract.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Examples of such events include the following:

1. Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan)
2. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions
3. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan
4. Failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA
5. Premature termination of the contracts

No events probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants are present.

### **NOTE 5 - GUARANTEED INVESTMENT CONTRACT (CONTINUED)**

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

### **NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

The Sponsor has been designated as the plan administrator and plan sponsor. Certain employees provide administrative services to the Plan. These services are provided at no cost to the Plan. The Plan pays certain administrative expenses to its service providers. These transactions represent party in interest transactions.

The fully benefit-responsive guaranteed investment contract is managed by AUL. AUL is a member with OneAmerica Retirement Services. OneAmerica Retirement Services LLC is the recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Notes receivable from participants also qualify as party in interest transactions.

### **NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### **NOTE 8 - TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated August 19, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
