We have performed audits of the financial statements of Alivia Care, Inc. 403(b) Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ending December 31, 2024, and the related notes to the financial statements.

## **Note 1. Description of Plan**

The following description of the Alivia Care, Inc. (Organization) 403(b) Plan (formerly the Community Hospice of Northeast Florida, Inc. (Hospice) 403(b) Retirement Plan) (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. In 2020, the articles of incorporation of the Hospice were amended and restated by vote of the Board of Directors such that Alivia Care, Inc., a Florida not-for-profit corporation, became the parent and sole member of the Hospice. Additionally, the plan sponsor was amended to be Alivia Care, Inc., and the Plan name was changed as indicated above.

### **General**

The Plan is a defined contribution plan covering all employees of the Organization. The plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Management controls and manages the operations of the plan. The Variable Annuity Life Insurance Company (VALIC), Transamerica Financial Life Insurance Company Inc. (Transamerica), and State Street Bank and Trust Company (State Street) are the trustees of the Plan and manage all of the Plan's assets.

### **Contributions**

Employees are eligible to contribute pretax deferrals of compensation on the first day of employment, as defined by the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan trustee. Contributions are subject to certain limitations. Participants may rollover contributions from other qualified plans.

The Organization may make annual non-matching contributions to the Plan as a percentage of participant compensation subject to the discretion of the Board of Directors. The Organization may make a matching contribution as a percentage of participant elective deferrals, also at the Board's discretion. Employer contributions are not allocated to an employee's account unless the employee has completed a year of service. For the year ended December 31, 2024, nonmatching contributions equaled 3% of the participants' compensation. For executives who have at least five years of service, the Organization makes nonmatching contributions equal to 5.4% of the participants' compensation. There were no matching contributions by the Organization for the year ended December 31, 2024.

### **Investment Options**

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers pooled separate accounts and insurance investment contracts as investment options for participants.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Organization's contributions, Plan earnings (losses), and charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and allocations of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Organization contributions portion of their accounts plus earnings thereon is based on years of continuous service according to the following schedule:

Less than 1 year of service	0%
1 but less than 2 years of service	20%
2 but less than 3 years of service	40%
3 but less than 4 years of service	60%
4 but less than 5 years of service	80%
5 or more years of service	100%

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their employee deferral or rollover accounts. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. At December 31, 2024, outstanding loans bore interest rates of 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment and annuity options as provided by the Plan. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59½.

***Forfeiture Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$179,187 and \$93,861, respectively. These accounts may be used to reduce future employer contributions. During 2024, forfeitures of \$129,170 were used to reduce employer contributions.

***Plan Servicing Credits***

The Plan's services agreement with Transamerica provides for a revenue credit arrangement, whereby the Plan is credited for certain excess revenues earned in connection with Plan services. During 2024, approximately \$177,800 in revenue credits were earned, which is reported as other income in the statement of changes in net assets available for benefits. Approximately \$102,500 was reallocated to participant accounts on a pro-rata basis and \$40,500 was used to pay administrative expenses in 2024. At December 31, 2024 and 2023, approximately \$112,300 and \$72,000 was available for use, respectively.

**Note 2. Summary of Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (GAAP).

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustees. See Note 3 for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income on notes receivable from participants is recorded when received. All other interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefit payments are recorded upon distribution.

***Administrative Expenses***

Certain administrative expenses, including auditing and consulting fees, are paid by the Organization on behalf of the Plan and are not included in the statement of changes in net assets available for benefits. Certain administrative functions are performed by employees of the Organization. No such employee received compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

***Subsequent Events***

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Pooled separate accounts***

The Plan invests in pooled separate accounts for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value (NAV) per share, as determined by the trustees, as the estimated fair value. Because quoted prices in active markets for identical assets are not available, these prices are determined using observable market information such as quotes from less active markets and/or quoted prices of securities with similar characteristics. As per GAAP, as these investments are measured at NAV, they have not been classified within the fair value hierarchy.

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

\*The investment strategy for each individual pooled separate account is to achieve the investment return provided by the individual underlying investments that are traded on active markets as indicated by the name of each pooled separate account.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Fully Benefit-Responsive Investment Contracts**

The Plan holds investment contracts with VALIC. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The Plan's investment contracts are classified as traditional investment contracts totaling \$554,045 and \$575,169 at December 31, 2024 and 2023, respectively.

The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers. The contracts have a minimum crediting rate of 3.00%. Such interest rates are reviewed on a monthly basis for VALIC for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with issuers. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 5. Unaudited Information Certified by Trustees**

The accompanying financial statements include the following unaudited information as of December 31, 2024 and 2023 that was obtained from data prepared and certified to be complete and accurate by the Plan's trustees:

**Note 6. Exempt Party-in-Interest Transactions**

VALIC, Transamerica, and State Street Bank are the trustees of the Plan and manage all of the Plan's assets. The Plan pays trustee fees and asset management fees throughout the plan year. Fees paid to the trustees for the year ended December 31, 2024 totaled \$145,619. Other fees paid by the Plan of \$38,743 include investment advisory and professional audit fees.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions, as well as allowable participant contributions, at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Organization may determine.

**Note 8. Tax Status**

The plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Internal Revenue Code (IRC) to maintain its tax exemption. The Plan has not applied for an IRS determination letter, as that program has only recently become available to 403(b) Plans. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
