### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Moroso Performance Products, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

## NOTES TO FINANCIAL STATEMENTS

### 1. DESCRIPTION OF PLAN:

The following description of the Moroso Performance Products, Inc. (“Company”) 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan was established on October 1, 1989 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan was adopted under the provisions of Section 401(a) of the Internal Revenue Code (“Code”) with a cash or deferred arrangement qualified under Section 401(k) of the Code. Pursuant to the requirements of Section 401(a) 27 of the Code, the Plan is also a profit sharing plan. The Plan is a defined contribution plan that covers all eligible employees of the Company who have at least three (3) months of service and have attained the age of 18.

The Plan is administered by the Company and third-party advised by Ascensus Trust Company (“Ascensus”). Effective June 26, 2023, the Plan removed Newport Trust Company (“Newport”) as the Trustee and appointing Ascensus as the successor Trustee. The assets of the Plan are also held and invested by Ascensus.

2. *Contributions.* Contributions to the Plan include (i) salary reduction contributions authorized by the participants, (ii) matching contributions made by the Company, (iii) non-elective contributions made by the Company, and (iv) rollovers from new participants from other qualified plans.

Each participant may authorize the Company to contribute into the Plan, on a pre-tax basis or on an after-tax basis as Roth contributions, a percentage of their annual salary, up to the maximum amount permitted by law for each Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may make a discretionary matching contribution declared for the year by the Company’s Board of Directors. The Company elected to contribute 50% of the first 6% of compensation that a participant contributes to the Plan for the year ended December 31, 2024. In addition, the Company may make an additional discretionary profit sharing contribution at the discretion of the Board of Directors to eligible participants. There were no additional discretionary profit sharing contributions for the year ended December 31, 2024. Total participant contributions in any calendar year are limited to the applicable limit under Internal Revenue Code Section 402(g). The Plan also provides that certain limitations may be imposed on participants’ contributions in order to comply with statutory requirements.

3. *Participant Accounts/Benefits.* Individual accounts are maintained for each plan participant to reflect the participants’ contributions, related matching contributions, and discretionary Company contributions. Income and loss are allocated to the participants’ accounts based on the ratio of the account balances of the individual to the aggregate of all account balances within the Plan.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. DESCRIPTION OF PLAN (CONTINUED):

4. *Vesting.* Participants are immediately vested in their deferral, rollover and matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant vests in the Company's discretionary profit sharing contributions according to the following schedule:

Less than 2 years	0%
At least 2 years, but less than 3 years	20%
At least 3 years, but less than 4 years	40%
At least 4 years, but less than 5 years	60%
At least 5 years, but less than 6 years	80%
6 years or more	100%

5. *Notes Receivable from Participants.* Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% as of December 31, 2024, which is prime rate plus 1% point as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.
6. *Investment Options.* Upon enrollment in the Plan, a participant may direct their contributions into any of the funds offered by the Plan, which are held at Ascensus. These funds include a variety of investment options with various objectives and degrees of financial risk.
7. *Payment of Benefits.* Upon termination of employment for any reason, including death, disability or retirement, the participant or their beneficiary will receive an amount equal to the value of the participant's vested interest in his or her account. An election is made by the participant or their beneficiary as to the form of payment (direct rollover or cash payment). In the absence of an executed election form, the Plan distributes benefit amounts less than \$1,000 in cash while amounts between \$1,000 and \$5,000 shall be rolled over into an individual retirement account; amounts greater than \$5,000 remain credited to the participant's account until an election is made.

The Plan also provides for in-service withdrawals by participants who have attained the age of 59 ½. Upon financial hardship, a participant is entitled to the value of his or her deferral accounts, but not the earnings thereon, which is payable immediately in a lump-sum distribution.

8. *Forfeited Accounts.* At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$31 and \$25, respectively. These accounts will be used to pay Plan expenses or reduce future employer contributions. In 2024 and 2023, there were no expenses that reduced forfeited non-vested accounts.

### 2. SUMMARY OF ACCOUNTING POLICIES:

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

### 2. SUMMARY OF ACCOUNTING POLICIES (CONTINUED):

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Plan Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Use of Estimates** - The preparation of financial statements in conformity with the accrual basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Payment of Benefits** - Benefits are recorded when paid.

**Subsequent Events** - The Plan has evaluated events and transactions for potential recognition of disclosure through October 6, 2025, which is the date the financial statements were available to be issued.

### 3. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**3. FAIR VALUE MEASUREMENTS (CONTINUED):**

*Common/Collective Trust:* Valued at the NAV of units of a commingled trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates full redemption of the collective trust, the issuer reserves the right to require twelve month's notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

### 4. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE:

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus and Newport, the current and prior trustees of the Plan, respectively, have certified to the completeness and accuracy of all investments and notes receivable reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the schedule of assets (held at end of year) for investment purposes as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### 5. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### 6. TAX STATUS OF THE PLAN:

The Plan has adopted a nonstandardized prototype plan that received a favorable opinion letter on November 30, 2020 from the Internal Revenue Service (IRS) that it was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

### 7. PARTY-IN-INTEREST:

Certain Plan investments are managed by affiliates of Ascensus. Ascensus is a trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Other parties-in-interest include record-keepers and professional service firms who provide services to the Plan. Administrative expenses paid by the Plan to parties-in-interest totaled \$21,364 for the year ended December 31, 2024. Certain employees of the Company who participate in the Plan perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants are also party-in-interest transactions.

### 8. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
