### **NOTE A -- Description of plan and significant accounting policies**

The following brief description of MARC Development Centers DC Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Madison Area Rehabilitation Centers, Inc., (the employer) has adopted, with subsequent amendments, the TIAA ERISA 403(b) Volume Submitter Plan, under the name, MARC Development Centers DC Retirement Plan. The initial effective date of the Plan was July 1, 1973, with the most recent restatement dated October 1, 2023.

#### **General**

The Plan is a defined contribution plan covering substantially all employees who work 20 or more hours per week and are 20 years of age. Participants meeting eligibility requirements may enter the Plan on the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Fiduciary Committee oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan's federal identification number is 39-0968930, and the Plan's number is 002.

#### **Contributions**

Prior to October 1, 2023, the plan did not allow participants to make contributions, including catch-up contributions, or contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Beginning October 1, 2023, as a result of the Plan merger (Note J) participants may contribute 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective both before and after October 1, 2023, the employer makes contributions equal to 10% of participants' pay each pay period for employees that have completed two consecutive years of service, as defined in the Plan. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

#### **Participant accounts and "rollovers"**

Each participant's account is credited with the participant's contribution, employer contributions and an allocation of Plan earnings, reduced for withdrawals. Allocations of Plan earnings are determined and posted to each participant account on a daily basis in accordance with the proportion of a participant's account to all participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Prior to October 1, 2023, the Plan did not permit the rollover of funds from other qualified plans to a participant's account. Beginning October 1, 2023, the Plan permits the transfer of funds from other qualified plans to a separate participant's rollover account.

### **NOTE A -- Description of plan and significant accounting policies (Continued)**

#### **Vesting**

Participants are immediately vested in their contributions and employer contributions, plus actual earnings thereon.

#### **Notes receivable from participants**

Effective October 1, 2023, as a result of the Plan merger (Note J), participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a fixed rate that is determined as 1% over the Prime Rate set by the Wall Street Journal at the time the loan is originated. Principal and interest is paid ratably through monthly payroll deductions.

Prior to the 2023 Plan merger, participants could not borrow from their fund accounts.

#### **Benefits**

On termination of employment or retirement (age 65), the participant's account balance is distributed as requested by the participant or the beneficiary, in lump sum or annuity contract payments. If a participant's account balance is less than \$5,000 at the time of death, the beneficiary will generally have some options regarding the form of distribution that are available to participants. If the participant's balance is greater than \$5,000, the beneficiary may be required to take distributions in the form of a life annuity, unless waived by the participant. The beneficiary may also have the option of rolling their distribution into an IRA. Individual investment options that were selected by participants for their contributions may contain additional limits on when a distribution can be taken, the form of distribution available, as well as the right to transfer among approved investment options. The Plan permits in-service distributions at age 59 ½.

Beginning October 1, 2023, a participant with an account valued at less than \$5,000 require a mandatory distribution. If the participant makes no election for the mandatory distribution, then the amount will be automatically rolled over into an IRA. The Plan permits hardship distributions if certain criteria are met.

A summary of significant accounting policies follows:

#### **Basis of accounting**

The financial statements of the Plan are prepared in conformity with accounting standards generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits or a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

### **NOTE A -- Description of plan and significant accounting policies (Continued)**

#### **Use of estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment valuation and income recognition**

The Plan's investments (except for fully benefit-responsive investment contracts, which are reported at contract value) are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Fiduciary Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Administrative expenses**

Certain expenses of maintaining the Plan are paid directly by the employer and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

#### **Notes receivable from participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

#### **Subsequent events**

These financial statements have not been updated for subsequent events occurring after October 6, 2025, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Pooled separate account. The TIAA Real Estate account is based on the fund's net asset value (NAV). Underlying holdings are primarily valued using independent appraisals or independent pricing sources. Although the underlying assets of the fund cannot be quickly sold and converted to liquid assets, the TIAA general account provides the fund with a liquidity guarantee whereby TIAA ensures that the fund has funds available to meet participant redemption, transfer, or cash withdrawal requests. The net asset value of the separate account is not publicly quoted.
- Variable annuity accounts. Accumulation units held by the Plan in the variable annuity accounts are based on each account's NAV. The accounts are not exchange traded. Data for NAV's provides sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources.
- Guaranteed investment contract. Investments in the insurance company general account are valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer. Funds under the investments contract that have been allocated and applied to purchase annuities (that is, the insurance company is obligated to pay the related pension benefits) are excluded from the Plan's assets. All these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs. The fair value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals.
- Registered investment companies. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The reason for the transfers into and out of Level 3 were due to participants directing the investment of their contributions between various funds offered by the Plan.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments. Unrealized gains (losses) from the guaranteed investment contract are not reported in the statement of changes in net assets available for benefits as the contract is recorded at contract value for presentation in the net assets available for benefits.

### NOTE D -- Guaranteed investment contract with insurance company

The Plan entered into a traditional non-benefit-responsive guaranteed investment contract with TIAA-CREF. TIAA-CREF maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

### **NOTE D -- Guaranteed investment contract with insurance company (Continued)**

When participants choose to allocate a portion of their retirement savings into the investment contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a minimum rate of interest, is guaranteed by TIAA-CREF's claims-paying ability. The investment contract also provides the potential for additional interest if declared by TIAA-CREF's Board of Trustees. Additional interest, when declared, remains in effect for the "declaration year," which begins each March 1 for accumulating annuities and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years.

The investment contract is offered through a variety of contracts, including Group Retirement Annuities (GRA) offered by the Plan. The type of contract meets the criteria to be considered non-benefit responsive, through which a participant invests in the investment contract determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional amounts paid, the degree of liquidity of the participant's account and the options for receiving income upon retirement.

All GRA contracts allow lump sum withdrawals if withdrawn 120 days from termination of employment and are subject to a 2.50% surrender charge. As of December 31, 2024 and 2023, the crediting interest rates for GRA contracts were approximately 5.38% and 6.25%, respectively.

### **NOTE E -- Group annuity contracts with insurance company**

The Plan entered into traditional fully benefit-responsive guaranteed investment contracts with TIAA-CREF totaling \$884,329 and \$381,658 as of December 31, 2024 and 2023, respectively. TIAA-CREF maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contracts meet the fully benefit-responsive investment contract criteria and are therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA-CREF, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The crediting interest rate is based on a formula established by the contract issuer guaranteed between 1.00% to 3.00%. The crediting rate is reviewed on an annual basis for resetting.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

### **NOTE F -- Party-in-interest transactions**

TIAA-CREF is the asset custodian of the Plan as of and for the year ended December 31, 2024, and is therefore designated as a fiduciary and party-in-interest. These party-in-interest transactions occur in the course of ordinary business and are exempt transactions.

TIAA-CREF provides certain administrative services to the Plan pursuant to a Master Plan Services Agreements (MSA) between the employer and TIAA-CREF. TIAA-CREF receives revenue from mutual fund service providers for services TIAA-CREF provides to the funds. This revenue is used to offset certain amounts owed to TIAA-CREF for its administrative services to the Plan. If the revenue received by TIAA-CREF from such mutual fund service providers exceeds the amount owed, TIAA-CREF remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were excess amounts totaling \$6,268, which is included in other income on the Statement of Changes in Net Assets Available for Benefits. The Plan or Plan Sponsor may make a payment to TIAA-CREF for administrative expenses not covered by revenue sharing.

Fees were also paid by the Plan to RetirePlus Advisors for advisory services rendered for the year ended December 31, 2024. These transactions also qualify as party-in-interest transactions.

### **NOTE G -- Tax status**

The TIAA ERISA 403(b) Volume Submitter Plan, referred to in Note A, that the Plan has adopted effective October 1, 2023, obtained its latest opinion letter on August 7, 2017, in which the Internal Revenue Service stated that the volume submitter plan, as then designed, was acceptable under Section 403 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

### **NOTE H -- Plan termination**

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **NOTE I -- Concentration of market risk**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that these changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

### **NOTE J -- Plan restatement and amendment**

Effective October 1, 2023, the Plan was restated. The restatement includes the merger of the Madison Area Rehabilitation Centers, Inc. TDA plan. MARC Development Centers DC Retirement Plan was the surviving Plan of the merger.

The Plan has made certain elections for the Secure Act 2.0 provisions effective prior to January 1, 2025, which laws address, among others, involuntary cash-out distributions' limits and eligibility requirements for long-term part-time employees. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance. The involuntary cash-out distribution amount changed from \$5,000 to \$7,000 on April 1, 2024.
