Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of The Farmers Automobile Insurance Association 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Notes to Financial Statements – Years Ended December 31, 2024 and 2023

1. Plan Description

The following description of The Farmers Automobile Insurance Association 401(k) Savings Plan provides general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General – The Plan is a trustee defined-contribution plan covering all eligible employees of The Farmers Automobile Insurance Association (FAIA) and Pekin Life Insurance Company (PLIC). New employees, who meet the eligibility criteria and have obtained the age of 18, are automatically enrolled in the Plan on the first working day of the month after 30 days of employment and are eligible after a 30-day notice of enrollment. Non-eligible employees, who subsequently meet the eligibility criteria and have obtained the age of 18, are eligible after the 30-day service requirement and are enrolled the first day of the subsequent month. The Plan is subject to provisions of the Employee Retirement Income Security Act (ERISA) of 1974, as amended.

Contributions – Each year participants, age 49 or under, may contribute up to 60.0 percent of pre-tax and post-tax annual compensation, as defined in the Plan, or \$23,000 in 2024 per the Internal Revenue Service maximum. Participants who are projected to be 50 years of age or older by the end of the taxable year, and who are making deferral contributions, may also make a catch-up contribution of up to \$7,500 or the maximum set by the Secretary of Treasury, whichever is less. Participants may also contribute distributions from other qualified defined-benefit or contribution plans. At the discretion of the Trustees, FAIA and PLIC (collectively, the Plan Sponsors) may contribute a matching percentage of the participants' contributions to the participants' accounts. In 2024 and 2023, the Plan Sponsors elected to match 25.0 percent of the employee's contribution up to a maximum match of \$400 to employees hired prior to January 1, 2013. Employees hired after January 1, 2013, may receive, at the discretion of the Trustees, a contribution from the Plan Sponsors based on a percentage of eligible earnings and a match of the employee's percentage of contribution from the Plan Sponsors. Contributions are subject to certain limitations. For 2024 and 2023, the Plan Sponsors contributed 3.0 percent and 2.0 percent, respectively, of employees' eligible earnings and a 75.0 percent match of the employees' percentage of contribution not to exceed 7.0 percent of employees' eligible earnings. Each year on July 1, participants with a deferral rate greater than zero (who are not suspended from making Deferral Contributions) will have that deferral increased annually by 1.0 percent.

Certain non-grandfathered participants hired prior to January 1, 2013, were no longer eligible to accrue pension benefits beyond December 31, 2017 under The Farmers Automobile Insurance Association Retirement Plan. These participants were previously not eligible for the discretionary contribution and were subject to the maximum matching contribution of \$400. Beginning with 2018, this pool of non-grandfathered participants were eligible to receive the same 401k contributions and benefits as those hired after January 1, 2013.

Participants' Accounts – Each participant's account is credited with the participant's contribution, any matching and discretionary contributions from FAIA or PLIC, and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Certain expenses of maintaining the Plan are paid directly by the Plan Sponsors and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the portion of their accounts related to FAIA's and PLIC's discretionary and matching contributions plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after three years of service.

Investment Options – Upon enrollment in the Plan, a participant may direct contributions in one percent increments to any of the thirty-one professionally managed investment funds. Participants may change their investment options at any time during the year, but the frequency rate of change may be restricted per fund based on the individual fund requirements.

Notes Receivable from Participants – Participants may borrow from their fund accounts provided that the loan is not in excess of 50.0 percent of the vested account balance. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50.0 percent of their vested account balance. The notes receivable are secured by the balance in the participant's account, bear interest at a rate determined by the Plan Administrator (FAIA) to be reasonable, and the repayment period may not exceed five years unless it is for the purchase of the participant's principal residence in which case the notes receivable repayment period may not extend beyond ten years from the date of the notes receivable. Principal and interest are paid ratably through payroll withholdings. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits – On termination of service due to death, disability or retirement, a participant (or beneficiary or beneficiaries in the case of death) is eligible to request a distribution of the participant's vested account balance. Distributions are payable in the form of lump sum distributions, non-rollover distributions, or direct rollover distributions. Effective February 5, 2018, the Plan allows for in-service distributions if a participant has reached age 59 1/2 and hardship distributions subject to the Plan provisions.

Forfeited Accounts – At December 31, 2024 and 2023, forfeited non-vested accounts of terminated participants totaled \$165 and \$6,349, respectively. These accounts will be used to reduce future employer contributions. For 2024 and 2023, employer contributions were reduced by \$196,285 and \$136,962 from forfeited non-vested accounts.

2. Summary of Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Administrative expenses are included in Distributions to Participants.

3. Party-In-Interest Transactions

Plan investments are shares of mutual funds which are purchased through and in the custody of Fidelity Management Trust Company (Fidelity). Fidelity is also the trustee and investment advisor as defined by the Plan. Participant account balances and other Plan records are maintained by Fidelity. Recordkeeping fees and trustee fees qualify as party-in-interest transactions. In 2024 and 2023, recordkeeping fees were deducted from participants' accounts and trustee fees were waived by Fidelity.

4. Plan Termination

Although they have not expressed any intent to do so, FAIA and PLIC have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100 percent vested in their employer contributions.

5. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan's service provider by a prototype letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' balances and the amounts reported in the statements of net assets available for benefits.

7. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market

Quoted market prices reported on the active markets on which the money market fund is traded.

Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of The Farmers Automobile Insurance Association 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.


