### 1. Description of the Plan

The following brief description of the Whitebridge Pet Brands, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### *General*

The Plan was adopted by Whitebridge Pet Brands, LLC (the Company), effective January 1, 2016, and restated effective November 1, 2024. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Eligibility*

All employees, excluding unions employees, leased employees and nonresident aliens, are eligible for participation upon age 21 and the completion of 90 days of service. Eligible Participants may enter the Plan on the first day of the calendar month following the date in which the Participant satisfies the service requirements.

#### *Contributions*

Each year, eligible employees may elect to contribute, on a pre-tax basis or after-tax basis (Roth), up to 100% of their eligible compensation, as defined by the Plan, through payroll deductions, not to exceed the limit under the Internal Revenue Code (IRC). In addition, eligible Participants who have attained age 50, before the close of the Plan year, are permitted to make catch-up contributions up to the maximum allowed under the IRC. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a discretionary matching contribution, determined each Plan year. In addition, the Company may make a non-elective safe harbor contribution of 3% of compensation (effective November 1, 2024) (collectively, Company contributions). There were Company safe harbor contributions of \$461,199 for the 2024 Plan year, and no discretionary matching contributions.

#### *Participant Accounts*

Each Participant's account is credited with the Participant's salary deferral contributions, allocations of any Company contributions, and his/her share of the Plan's income (loss). The Plan's income (loss), with respect to each investment fund, is allocated based on the proportion that each Participant's account balance invested in such fund compared to the total of all Participants' account balances invested in such fund.

#### *Vesting*

Participants are immediately vested in the value of their salary deferrals, and rollovers, plus related investment earnings (losses). Any Company contributions and discretionary matching contributions vest according to the following schedule:

### 1. Description of the Plan

#### *Vesting (cont.)*

Participants must be credited with a minimum of 1,000 hours to complete a year of vesting service.

A Participant will become fully vested in any Company contributions, regardless of length of service, in the event of death or disability, the Plan is terminated or contributions to the Plan are discontinued, or upon attainment of age 65.

#### *Payment of Benefits*

Participant accounts may be withdrawn upon retirement, death, or termination of employment. Participants may elect to have distributions paid in a lump-sum and are either paid directly to the Participant or rolled over to another qualified retirement plan. Installments are permitted only for required minimum distributions. The Plan also allows for in-service withdrawals at age 59½, along with withdrawals in the event of a financial hardship.

#### *Forfeitures*

The Plan allows forfeitures to be used to reduce Company contributions or pay Plan expenses. Unused forfeitures available for use at December 31, 2024 and 2023 were \$0 and \$9,128, respectively. The Company utilized \$23 of forfeitures to pay Plan related expenses for the year ended December 31, 2024. Additionally, \$9,227 of forfeitures were used to reduce 2023 Company contributions that were funded in April 2024.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### *Investment Valuation and Income (Loss) Recognition*

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market Participants at the measurement date. See Note 4 for information on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income (loss) is recorded on the accrual basis. Net appreciation/(depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Contributions*

Contributions from Plan Participants and the contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### *Plan Expenses*

Certain administrative expenses related to distributions and other Participant-initiated transactions are charged to the account of the Plan Participant. Other administrative expenses and investment management fees are paid from the Plan's forfeitures and through reductions of investment returns under the Plan's investment options.

#### *Payment Benefits*

Benefit payments to Participants are recorded upon distribution.

### 3. Certified Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, American Trust Custody, the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits for the period November 1, 2024 to December 31, 2024, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

Accordingly, Lincoln National Life Insurance Company (Lincoln) the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for as of December 31, 2023, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2024 through October 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

### 4. Fair Value Measurement

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below.

#### *Basis of Fair Value Measurement*

*Level 1* - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

*Level 2* - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

*Level 3* - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

#### *Basis of Fair Value Measurement (cont.)*

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Pooled Separate Account* - The fair value of the pooled separate account is based on the net asset value (NAV) of each account calculated by Mutual of America and is based on the NAV of the underlying investments. The NAV is used as a practical expedient to estimate fair value.

The Plan's investments at fair value as of December 31, 2024 and 2023 are made up entirely of a pooled separate account, which is measured at the NAV as a practical expedient. In accordance with GAAP, certain investments that were measured as such are not classified in the fair value hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation method is appropriate and consistent with other market Participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. The recordkeeping and custody functions for the underlying investments held by the Plan are performed by Mutual of America and American Trust Custody. Through October 31, 2024, the recordkeeping and custody functions for the underlying investments held by the Plan were performed by Lincoln. Usual and customary fees were paid for investment management services. These transactions, as defined by the Plan, qualify as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules.

### 6. Tax Status

In November 2024, the Plan that was based on a Non-Standardized Pre-Approved Profit-Sharing Plan with CODA sponsored by CCH Incorporated dba FT William (FT William) was moved to the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan (Pre-Approved Plan) sponsored by Mutual of America Financial Group (Mutual of America). The Internal Revenue Service (IRS) has opined and informed Mutual of America by a letter dated November 30, 2020, that the Pre-Approved Plan is designed in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

### **6. Tax Status (cont.)**

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants would become 100% vested in their Company contributions.

### **8. Risks and Uncertainties**

The Plan's investments include funds which invest in various types of investment securities and in various companies within various markets. Investment securities are exposed to several risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the Plan's statement of net assets available for benefits.

### **9. SECURE 2.0 Act of 2022**

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management continues to evaluate the impact of the adoption and implementation of this legislation on the Plan.

### **10. Delinquent Participant Contributions**

During 2022, employee withholdings of \$4,020 were not remitted timely to the Plan by the Company. The Company remitted the delinquent contributions to the Plan during 2023 and remitted the related lost earnings during 2024. These transactions constitute prohibited transactions as defined by ERISA.

### **11. Subsequent Events**

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through the date of issuance, October 03, 2025, and has determined that, except for the matters noted below, no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on these financial statements.
