INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of the
GFC Retirement Plan

Opinion

We have audited the accompanying financial statements of GFC Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of GFC Retirement Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of GFC Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.



1. DESCRIPTION OF PLAN

The following description of the Goppert Financial Corp (GFC) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document for more complete description of the Plan's provisions.

General — The Plan is a defined contribution plan covering all employees of two controlled groups constituting the Goppert Financial Corp (“Company”) and Country Agencies & Investments, Inc. who are age eighteen or older, have six months of service as of the plan entry date, and who are not excluded employees as defined in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Contributions — Each year, participants may contribute up to 25% of pretax annual compensation, not to exceed maximum amounts as defined in the Plan and as stated in the Internal Revenue Service Code. In 2024 and 2023, participants may contribute a portion of pretax annual compensation, not to exceed \$23,000 and \$22,500, respectively.

Participants over age 50 are eligible to defer an additional \$7,500 for 2024 and \$7,500 for 2023, as a catch-up contribution, under the Economic Growth and Tax Relief Reconciliation Act of 2001 (EGTRRA). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company matches 25% of the first 6% of base compensation that a participant contributes to the Plan. Additional discretionary profit sharing amounts may be made subject to the Company’s board of directors.

Credit Risk — The Plan evaluates its receivables for potential credit losses. At year end, the Plan did not consider any open accounts receivable as potential bad debts.

Participant Accounts — Each participant's account is credited with (a) the participant's contribution and allocations of (b) the Company's contribution and (c) Plan earnings, and charged with an allocation of (d) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's accounts.

Vesting — Participants are vested immediately in their contributions plus actual earnings thereon and any amounts rolled over into the Plan. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after one year of credited service.

Distributions — Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account, or annual installments over a ten-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution.

Allowance for Bad Debt — The Plan Trustees considered recording an Allowance for Bad Debt, for the Company's Profit Sharing Match that was made in April of 2024. Based on the complete subsequent receipt of the amount recorded as receivable at December 31, 2024, no allowance for bad debt was considered necessary.

Participant Loans — Loans are no longer available under the plan.

Participant Investment Rollovers — Participants are allowed to transfer or rollover funds into the Plan from other qualified or 401(k) plans.

Payment of Benefits — Upon termination of service for reasons other than death, a participant may elect to continue in the plan, elect a direct rollover to another qualified plan or receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If a participant dies, then the value of his or her account will be used to provide a death benefit to his or her beneficiary.

Forfeited Accounts — At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,713 and \$1,155, respectively. Employer contributions were reduced by \$6,713 and \$1,155 from forfeited, non-vested accounts for 2024 and 2023, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America, except for distributions paid to participants which are prepared on the cash basis of accounting.

Use of Accounting Estimates — The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition — The Plan's investments are reported at fair value. See Note 5 for discussion of fair value measurements. Quoted market prices are used to value investments. Shares of mutual funds are valued at net assets value of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions — Contributions from employees and the Company are recorded in the period in which the Company makes the payroll deductions from participant earnings.

Distributions - Distributions are recorded when paid. At December 31, 2024 and 2023, there were no benefits processed and approved for payment, but not paid.

Expenses — The majority of the expenses incurred for maintaining the Plan are paid by the Company. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee's fees are paid directly by the Company. Investment management fees are paid by the Plan and were \$98,589 and \$87,018 for 2024 and 2023, respectively.

7. TAX STATUS

The Plan obtained its latest determination letter on August 30, 2001, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan has been amended since receiving the determination letter. However, the plan administrator and the plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan administrator believes the Plan, as currently designed and operated, is qualified and the related trust is tax-exempt as of the financial statement date.

8. TRANSACTIONS WITH PARTIES IN INTEREST

Certain plan investments are shares of mutual funds and other investments that are held and purchased through parties related to the custodian, Charles Schwab and its affiliates. Therefore, those transactions qualify as party-in-interest transactions. Fees paid by the plan for the investment management services amounted to \$64,018 for the year ended December 31, 2024. The fees were paid to the investment management advisor, the plan's recordkeeper and to the custodian

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investments in general are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts and the amounts reported in the statements of net assets available for benefits.

10. SUBSEQUENT EVENTS

Management has evaluated subsequent events from the date of the financial statements through October 1, 2025, the date the financial statements were available to be issued, and determined there are no other items to disclose or adjust.
