## Independent Auditors' Report

To the Trustees of the

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Great Lakes Dental Technologies, Ltd. 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). **1. Description of the Plan**

The following description of the Great Lakes Dental Technologies, Ltd. 401(k) Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**– The Plan is a defined contribution plan with a 401(k) feature covering substantially all employees of Great Lakes Dental Technologies, Inc. (the “Plan Administrator”). An employee must complete one month of service in order to become a participant in the Plan and begin making elective deferrals. There is no age requirement.

The Plan was established effective January 1, 1992 and was most recently restated to comply with statutory regulations effective February 17, 2022. The Board of Trustees is responsible for oversight of the Plan. The 401(k) Savings Plan Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Board of Trustees.

**Contributions** – Participants may elect to make salary-reducing contributions to the Plan of a specific percentage or dollar amount up to 80% of their annual compensation as a pretax or Roth after-tax contribution, limited by the amount imposed by law. Participants may also defer up to 100% of cash bonuses paid by the Plan Administrator, subject to Internal Revenue Service (“IRS”) limitations. The Plan includes an auto-enrollment provision whereby all employees are automatically enrolled in the Plan unless they elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation with annual 1% increases up to a maximum of 10% and their contributions invested in a default investment option until changed by the participant. Elective deferral contributions shall be limited as needed to meet nondiscrimination tests. Participants may also contribute amounts representing distributions from other qualified retirement plans. There is no employer matching contribution at the present time. The Plan Administrator may make a discretionary profit-sharing contribution; participants must be employees of the Plan Administrator as of the last day of the year in order to receive a discretionary profit-sharing contribution. There were no discretionary contributions during the years ended December 31, 2024 and 2023.

**Participant Accounts** – An account is maintained for each participant in the Plan. Each participant’s account is credited with the participant’s contributions and earnings on the participant-directed investments. Each participant’s account is reduced by the payment of benefits and an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined.

**1. Description of the Plan (continued)**

***Vesting*** – Participants are fully vested in their salary deferral contributions, rollover contributions, and actual earnings thereon. Vesting in discretionary profit-sharing contributions and actual earnings thereon is based on years of service. Participants are 20% vested after two years of service and vest ratably at 20% per year thereafter. Accordingly, participants are fully vested in discretionary profit-sharing contributions after six years of service. Forfeitures resulting from non-vested accounts may be used to pay Plan expenses, offset Plan Administrator contributions or be reallocated to participant's accounts.

***Notes Receivable from Participants*** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by any outstanding loan balance. A participant may have no more than two loans outstanding at one time. The loans are secured by the balance in the participant's account and bear interest at rates between 4.25% and 9.50%, which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is collected weekly through payroll deductions.

***Payment of Benefits*** – Participants may elect to withdraw their funds from the Plan upon retirement, death, disability or attaining age 59 ½. A participant may elect to receive installment distributions or a lump-sum distribution in an amount equal to the vested balance of their account. Participants may apply for a hardship withdrawal by certifying to the Plan Administrator all of the required criteria with documentation substantiating the hardship.

***Tax Status*** – The Plan obtained an opinion letter from the IRS dated June 30, 2020, which states that the Plan is designed in accordance with applicable provisions of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

***Plan Termination*** – Although it has not expressed any intent to do so, the Plan Administrator has the right under the Plan agreement to terminate the Plan at any time, subject to the provisions of ERISA. In the event that the Board of Trustees determines that the Plan should be discontinued or terminated, participants would become 100% vested in any Plan Administrator contributions.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting*** – The financial statements of the Plan are prepared on the accrual basis of accounting.

***Notes Receivable from Participants*** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

***Valuation of Investments*** – Investments are stated at fair value as certified by the custodian, Principal Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded on the modified cash basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Administrative Expenses*** – Certain expenses of maintaining the Plan are paid directly by the Plan Administrator and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and requests for distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation in fair value of the investments.

***Party-In-Interest Transactions*** – Certain Plan investments are managed by Principal Trust Company. Principal Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping services included in administrative expenses amounted to \$2,850 and \$2,279 for the years ended December 31, 2024 and 2023, respectively. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments as they are paid through revenue share, rather than a direct payment.

***Risks and Uncertainties*** – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Use of Estimates* – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

*Subsequent Events* – The Plan Administrator has evaluated subsequent events, for recognition or disclosure, through October 6, 2025, the date the accompanying financial statements were available to be issued, and determined that no additional recognition or disclosure was necessary.

**3. Information Certified by the Custodian (Unaudited)**

As permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan has elected to utilize the certification of certain financial information by Principal Trust Company.

The Plan has obtained a certification from Principal Trust Company that the following information is complete and accurate as of December 31, 2024 and December 31, 2023 and for the years then ended:

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security. There were no assets of the Plan that utilized Level 2 inputs as its primary basis for calculating fair value as of December 31, 2024 or 2023.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity’s own assumptions about the assumptions that market participants would use in pricing the asset or liability. There were no assets of the Plan that utilized Level 3 inputs as its primary measure of fair value as of December 31, 2024 or 2023.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. Fair Value Measurements (continued)**

*Pooled Separate Accounts:* Valued at the NAV of units held by the account. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities.

*Common Collective Trusts:* Valued at the NAV of units of a common collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

Were the Plan to initiate a full redemption of a common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust for 12 months.

The preceding methods described may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
