## INDEPENDENT AUDITORS' REPORT

To the Plan Sponsor and Management of the  
Sabel Steel Service, Inc. Money Purchase Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Sabel Steel Service, Inc. Money Purchase Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion on the Financial Statements**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ## **1. DESCRIPTION OF THE PLAN**

The following description of the Sabel Steel Service, Inc. (the Company or the Employer) Money Purchase Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering all hourly employees of the Company who are not covered under any qualified profit sharing or pension plan to which the Company contributes. Employees are eligible for membership in the Plan when they have attained age 18 and have 3 months of eligible service. The Plan is subject to certain provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Contributions**

Employees may voluntarily elect to contribute to the Plan but are not required to do so to participate. Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer contributes a negotiated rate per hour of service worked by the eligible participant. Effective July 1, 2017, the negotiated rate per hour for the Employer contribution increased to 80 cents. A covered employee may contribute up to a like amount per hour to the Plan. A covered employee may also contribute up to an additional 20 cents per hour and the Company will match such amount.

### **Participant Accounts**

Employee accounts are maintained for each participant. Each participant's account is credited with the participant's contribution, employer contribution, and an allocation of expenses and investment income as of each valuation date.

### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants' rights to amounts contributed to the Plan by the Company vest after three years of service. The Plan also provides that participants become 100% vested when they reach age 65, or in the event of death, total disability, or upon termination of the Plan. If a participant's employment is terminated before the participant has completed three years of service, the account balance applicable to employer contributions is forfeited.

### **Payment of Benefits**

Employees may withdraw any part of their voluntary contributions. Such a withdrawal, however, is limited to once in any twelve-month period. Vested employer contributions within employees' accounts may not be distributed before age 65, except in the case of death, disability, separation from employment of the Company, or early retirement for participants who attain age 55 and have participated for at least ten years. There is a 1 year break in service required for withdrawing participants to receive employer contributions. Distributions can be made in one lump sum or on an installment basis.

**Forfeitures**

Forfeited nonvested amounts may be used to reduce Company contributions to the Plan. Forfeited nonvested accounts totaled \$25 and \$3 for years ended December 31, 2024 and 2023, respectively. During 2024, forfeited nonvested accounts of \$29,389 were used to reduce the Company contribution.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates in the Preparation of Financial Statements**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administration fees are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

### **3. CERTIFIED INFORMATION**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments at December 31, 2024 and 2023 and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company, the trustee.

### **4. FAIR VALUE MEASUREMENT**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs which are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Guaranteed interest account:* Fair value represents contract value adjusted to reflect current market interest rates and is the amount Plan participants or sponsors would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination or retirement.

*Pooled separate accounts:* Valued at the Net Asset Value (NAV) of shares held by the Plan at year-end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are guaranteed interest accounts and units of pooled separate accounts managed by Principal Life Insurance Company. Principal Life Insurance Company is the trustee (see Note 3), as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made a direct payment to the third party administrator of \$24,863, which was not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

## **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

## **7. TAX STATUS**

The Company adopted a nonstandardized pre-approved money purchase plan with a cash or deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which rated that the Plan and related trust are designed in accordance with applicable sections of the IRS. The Plan has not received a determination letter specific to the Plan itself. Although the Plan has been amended since reviewing the determination letter, the plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the IRS.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **9. MINIMUM FUNDING REQUIREMENTS**

The Plan has met the minimum funding requirements.

## **10. TERMINATING PARTICIPANTS**

Net assets available for benefits as of December 31, 2024 and 2023 include amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not been paid. These amounts were \$130,995 and \$173,461 as of December 31, 2024 and 2023, respectively.
