Opinion

We have audited the accompanying financial statements of the Great Lakes Dental Technologies, Ltd. Notes to Financial Statements

1. Description of the Plan

The following description of the Great Lakes Dental Technologies, Ltd. Employee Stock Ownership Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General– Great Lakes Dental Technologies, Inc. (“Plan Administrator”) established the Great Lakes Orthodontics, Ltd. Employee Stock Ownership Plan effective as of January 1, 1990. Effective January 1, 2020, the Plan was renamed the Great Lakes Dental Technologies, Ltd. Employee Stock Ownership Plan to conform with the Plan Administrator’s name change. The Plan operates as an employee stock ownership plan (“ESOP”) and is designed to comply with Section 4975(e)(7) and the regulations there under of the Internal Revenue Code of 1986, as amended (“Code”) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan is administered by a committee appointed by the Plan Administrator’s Board of Directors. The Plan’s assets are held in the Great Lakes Dental Technologies, Ltd. Employee Trust.

Eligibility– Employees of the Plan Administrator are generally eligible to participate in the Plan after they have attained age 18 and completed one year of service, as long as they worked at least 1,000 hours during such Plan year. Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Plan Administrator contributions for such year.

Funding Policy– The Plan Administrator may make discretionary contributions of cash or shares of the Plan Administrator’s common stock. The contributions are then allocated to the participant accounts based on eligible compensation. Employee contributions are not permitted.

Participant Accounts– The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Plan Administrator's stock contributions and forfeitures of terminated participants’ non-vested accounts. Only those participants who are eligible employees of the Plan Administrator as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant’s account based on the ratio of the participant’s account balance. The Plan was restated and amended as of January 1, 2022 to change the timing of the allocations of plan earnings to after the forfeitures were applied which were previously allocated prior to forfeitures being applied.

1. Description of the Plan (continued)

Vesting – If a participant's employment with the Plan Administrator ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Plan Administrator. Participants vest 20 percent per year of credited service, as defined in the Plan document, commencing upon completion of their second year of service and are 100 percent vested after six years of service. Vesting is immediate upon death, termination of employment due to disability, or attainment of retirement age, as defined in the Plan document.

Put Option – Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trade limitations, includes a put option. The put option is a right to demand that the Plan Administrator buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Payment of Benefits – The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. For accounts less than \$10,000, a lump-sum distribution is made, while accounts in excess of \$10,000 are paid in five annual installments. Benefits are provided for normal retirement at attained age of 65, upon death (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), and termination of employment with the Plan Administrator. The amount to be distributed is based upon the account valuation date immediately preceding the distribution. Distributions are made in cash.

Under the provision of the Plan, the Plan Administrator is obligated to repurchase participant shares that have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations.

Diversification – Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Plan Administrator stock into investments which are more diversified.

Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may elect annually to diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution.

1. Description of the Plan (continued)

Participants who are at least age 45 with at least 10 years of participation in the Plan and do not terminate before March of the current Plan year may elect to diversify a portion of their accounts. Participants may elect to distribute up to 25 percent of the total number of shares of Plan Administrator stock allocated to the participant's account as of the end of the Plan year immediately preceding the participant's first year of eligibility for the diversification. The Plan limits the amount of this election in a Plan year.

Forfeitures – The non-vested balances of participants who have ceased employment with the Plan Administrator are forfeited upon the occurrence of a five-year break in service. Forfeited accounts shall be allocated in the same manner as employer contributions.

Voting Rights – Trustees are entitled to exercise voting rights attributable to shares of Plan Administrator stock, except for certain Plan Administrator matters such as merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of the trade or business, or such similar truncations. For these certain Plan Administrator matters, each participant is entitled to direct the Trustees to exercise voting rights attributable to the shares allocated to his or her accounts. In addition, for these certain Plan Administrator matters, the Trustees exercise voting rights attributable to shares for which the Trustees do not receive direction from the participant.

Tax Status - The Plan Administrator has adopted the Principal Financial Group ESOP/KSOP Pre-Approved Plan. Principal Financial Group obtained a letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan document satisfies the applicable provisions of the Code. Although the plan has been amended since the preapproved plan received the determination letter, the Plan Administrator and the Plan's tax counsel believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Code and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Plan Termination – Although it has not expressed any intent to do so, the Plan Administrator reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to each participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Employee Benefits Administration Committee shall direct the Trustees to pay all liabilities and expenses of the trust fund.

2. Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Valuation of Investment and Income Recognition – The investment is stated at fair value as determined by an annual independent valuation. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation includes the Plan’s gains and losses on shares bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Plan expenses are paid by the Plan Administrator.

Use of Estimates – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent Events – The Plan has evaluated subsequent events, for recognition or disclosure, through October 6, 2025, the date the accompanying financial statements were available to be issued, and determined that no additional recognition or disclosure was necessary.

4. Fair Value Measurements

ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. Also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Great Lakes Dental Technologies, Inc. Common Stock: The fair value of the Plan Administrator's common stock held by the Plan is valued at fair value based upon an annual independent appraisal on a going concern basis.

The valuation process involves the selection of an independent appraiser on an annual basis. Plan management accumulates the data for the appraiser from historical and projected financial information of the Plan Administrator. The appraiser prepares a report of estimated per-share value that a participant will receive upon distribution. The appraiser's report is reviewed and approved by Plan management, the Trustees and the Board of Directors.

The methods described in the table above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at December 31, 2024.
