## Notes to Financial Statements

### 1. Description of Plan

Celtra Technologies, Inc. and Celtra, Inc. (collectively, the "Employer") established the Celtra 401(k) Plan (the "Plan") on January 1, 2012 as restated on November 6, 2023. The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering all employees of the Employer, who are at least 21 years of age, except non-resident aliens with no U.S. sourced earned income, interns, part time employees, and those employees whose employment is governed by a collective bargaining agreement, ("Participants"). Interns and part-time employees will be eligible to participate in the Plan once they have attained 21 and have completed 1,000 hours of service within a plan year.

Fidelity Management Trust Company ("FMTC" or the "Custodian") provides asset custodian services. Fidelity Workplace Services, LLC ("FWS" or the "Recordkeeper"), an affiliate of FMTC, provides recordkeeping services and executes investment transactions. Fidelity Investments, an affiliate of FMTC, manages the investments in the Plan.

#### *Plan Administration*

The Employer is the plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Individual participant accounts may be charged directly for administrative expenses, if not paid by the Employer. Individual participant accounts are charged directly for loan recordkeeping, if applicable.

#### *Contributions*

Each year, participants may contribute up to 100% of their eligible compensation, as defined by the Plan, subject to a dollar limitation established by the Internal Revenue Code ("IRC"). Participants may make pre-tax or Roth contributions to their accounts. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. In addition, Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("Participant Rollovers").

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and their contributions invested in American Funds Target Retirement Date until changed by the participant.

The Employer, at its discretion, may elect to make a matching contributions as determined by the Board of Directors. To be eligible for the employer matching contribution, Participants must be contributing to the plan. For the year ended December 31, 2024, the Employer elected to make matching contributions equal to 50% of each participant's elective deferrals up to 6% of the Participant's eligible compensation deferred. For the year ended December 31, 2024, the Employer made contributions of \$220,614.

The Employer, at its discretion, may make an employer non-elective contribution to the Plan as determined by its Board of Directors. Employer non-elective contributions are allocated based on Participant's compensation. Participants must be employed on the last day of the Plan year and must have completed 1,000 hours of service during the Plan year. Exceptions for participants not employed on the last day of the Plan year are death and total and permanent disability. For the year ended December 31, 2024, the Employer elected not to make a non-elective contribution.

## Notes to Financial Statements

### 1. Description of Plan (continued)

#### *Participant Accounts*

Each participant's account is credited with the Participant's contributions, Employer matching contributions and an allocation of the Plan's earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on Participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

#### *Vesting*

Participants are vested immediately in their respective participant deferral contributions and Employer matching contributions. Vesting in the Employer non-elective contribution portion of their accounts is based on years of continuous service. A participant is 50 percent vested after 1 year of credited service and continues to vest in increments of 50 percent until 100 percent vested after 2 years of credited service. A participant becomes fully vested upon death, disability, or retirement while employed by the Employer.

#### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participants may only borrow from their pre-tax deferral or Roth 401(k) deferral accounts. A Participant may only have one loan outstanding at a time. The loans are secured by the balance in the Participant's account. The loan interest rate, determined daily, is set at 1 percent above the Wall Street Journal Prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to five years or greater for the purchase of a primary residence. Loans to Participants are reported as notes receivable from participants at the unpaid principal balance plus any accrued but unpaid interest.

The interest rate for the outstanding loan as of December 31, 2024 was 9.50% and matures in July 2029.

#### *Payment of Benefits*

On termination of service due to death, disability, retirement, termination of service, or other reasons, a Participant may elect to receive a lump sum amount equal to the full or partial value of the Participant's vested interest in his or her account. The payment can either be a cash distribution to the Participant, subject to income tax withholdings, or a cash rollover to an individual retirement account or another qualified plan as defined. If a Participant's vested account is more than \$1,000 but less than \$7,000, the plan administrator, after notification, may distribute the benefit into an individual retirement account. If the vested account balance is less than \$1,000, the plan administrator, after notification, may distribute the account balance to the Participant.

In-service withdrawals from a Participant's account are permitted due to financial hardship, upon reaching age 59 1/2 or out of a Participant's rollover account. The minimum hardship withdrawal amount is \$1,000.

### 1. Description of Plan (continued)

#### *Forfeitures*

A Participant who leaves the Employer will forfeit any non-vested balances at the earlier of 1) the last date of the plan year in which the Participant has been separated from the Employer for five years or 2) the day in which the Participant requests a full distribution of their vested account balance. As the Employer's discretion, forfeited balances may be used to first pay administrative expenses, then to reduce the Employer's contributions, allocate to participants, or add to any Employer discretionary contributions. At December 31, 2024 there were no unallocated forfeited amounts. At December 31, 2023, forfeited nonvested accounts totaled \$5,958. During 2024, plan administrative expenses were reduced by \$7,567, from forfeited nonvested accounts, in accordance with plan provisions.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### *Use of Estimates*

The preparation of financial statements in accordance with U.S GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. Related fees are recorded as administrative fees and expensed when incurred. If a Participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the Participant loan balance is reduced, and a benefit payment is recorded as soon as a distributable event occurs.

### 2. Summary of Accounting Policies (continued)

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### *Subsequent Events*

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which is September 15, 2025.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**3. Fair Value Measurements (continued)**

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. Information Certified by Custodian (Unaudited)**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, the Custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

### **5. Related-Party and Party In Interest Transactions**

Plan investments include funds that are managed by an affiliate of FMTC. Therefore, these transaction qualify as exempt party-in-interest transactions. Administrative fees of \$16,780 were paid to FMTC during 2024. Administrative fees of \$17,755 were paid to Gallagher Fiduciary Advisors, LLC, the Employer's investment advisor, during 2024. Additionally, the Plan issues loans to Participants, which are secured by the Participant's account balances. These transactions qualify as party in interest transactions.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of such termination, Participants will become fully vested in their accounts. Any unallocated assets of the Plan will be allocated to Participant accounts and distributed in such a manner as the Employer may determine.

### **7. Tax Status**

The underlying volume submitter profit sharing plan has received its latest opinion letter from the Internal Revenue Service ("IRS"), dated June 30, 2020, stating that the form of the plan is qualified under section 401(a) of the IRC and that the plan, as then designed, was in compliance with the applicable requirements of the IRC. Any employer adopting this form of the plan will be considered to have a plan qualified under section 401(a) of the IRC. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt as of the date of this report.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. It is the Plan's policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of the Plan is considered to be a tax position. No such uncertain tax positions have been recognized by the Plan.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### **9. Delinquent Participant Contributions**

For the year ended December 31, 2024, the Employer did not remit certain participant contributions and loan payments to the Plan on a timely basis as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions, which totaled \$18,036, are considered prohibited transactions. Subsequent to year end, the Employer will be funding Participants' accounts participants for lost earnings resulting from the delay in remitting the contributions.
