**Note 1 – Description of Plan**

The following description of the National Lime & Stone Company Employees' 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan covering all eligible employees of National Lime & Stone Company (the Company and Plan Administrator), as defined in the Plan document.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant's account is credited with the participant's contribution, employer contribution (as applicable), and an employer discretionary contribution to certain eligible participants. Investment earnings (losses) are allocated based upon participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the vested value of the participant's account. All contributions and earnings are invested among the investments offered by the Plan, at the direction of the participant.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000, reduced by the excess, if any, of the highest outstanding balance of any other loans from the Plan during the preceding twelve-month period, or 50% of their vested account balance. Principal and interest is paid ratably through payroll deductions.

Contributions

Participants may contribute any percentage of their compensation up to the IRS dollar maximum. Unless newly hired employees elect otherwise, they will be automatically enrolled at a pre-tax contribution rate of 6% of their eligible wage. For all salaried employees and eligible hourly employees, the Company contributes to the Plan 2% of an employee's eligible wage and matches 50% of an employee's elective deferral contributions up to a maximum matching contribution of 3% of an employee's eligible wage. Eligible employees may also contribute amounts representing distributions from other qualified plans.

Payment of Benefits

Participants are eligible to retire at age 65. Upon termination of employment a participant's account is payable by lump sum, as defined by the Plan document. Participants are eligible for in-service distributions upon attainment of age 59 1/2.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Company discretionary contributions and Company match contributions, plus actual earnings (losses) thereon, are immediately vested for certain eligible participants, and vest based on years of continuous service for other participants, as defined in the Plan document. A participant is 100% vested in all contributions after six years of credited service.

Forfeitures

Forfeited balances of terminated participants' nonvested accounts may be used to pay plan expenses or to reduce future Company contributions. If the participant is reemployed before incurring five consecutive one-year breaks in service, the Plan must reinstate the participant's nonvested accumulated benefits in his or her account balance under certain circumstances as defined in the Plan document. Forfeitures used to reduce the Company's contributions or pay plan expenses totaled \$6,442 and \$3,814 during 2024 and 2023, respectively. At December 31, 2024 and 2023, respectively, the forfeited account balance totaled \$1,348 and \$2,650.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

Administrative Expenses

Fees paid by the Plan for legal, accounting, trustee, and other costs of administering the Plan were rendered by parties-in-interest to the Plan.

**Note 2 – Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. There have been no changes in the valuation methods used. The Plan's assets are held by Charles Schwab Trust Bank (the Trustee).

Investment Valuation and Income Recognition (continued)

Mutual funds represent investments with various investment managers. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are valued at net asset value.

Common/collective trust funds (CCTs) represent investments with various investment managers. Units held in CCTs, including stable value funds, are valued at the net asset value (NAV). The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent outstanding loans and are measured at their unpaid principal balance plus accrued interest.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that could affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued.

**Note 3 – Investments**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) of investments, and interest and dividends for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Trustee.

**Note 4 – Fair Value Measurement**

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels within the fair value hierarchy. The three levels are described below:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Note 6 – Income Tax Status**

The Internal Revenue Service ruled on September 21, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan (the underlying document upon which the Plan is based) qualifies under Section 401 of the Internal Revenue Code (IRC) and the related trust is, therefore, not subject to tax under present income tax law. The Plan has since been amended. The Plan Administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
