### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Chippis, Caffrey & Dubilier, P.S.C. Profit Sharing and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ## Notes to the Financial Statements

### 1. Description of the Plan

The following description of the Chipps, Caffrey & Dubilier, P.S.C. Profit Sharing and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and became effective April 1, 1972, and was restated effective January 1, 2022. The Plan covers all eligible employees of Chipps, Caffrey & Dubilier, P.S.C. (the Plan Sponsor and Plan Administrator).

#### Eligibility

Employees are eligible to participate in the Plan once they have completed one year of eligible service and attain age 21. Eligible participants will automatically be entered into the Plan on the first day of each Plan year quarter following completion of the age and service requirements.

#### Contributions

Participants may contribute up to the maximum allowable annual contribution as defined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined contribution plans. The Plan Sponsor made discretionary matching contributions of 50% of employees' salary deferral amounts on the first 5% of employees' compensation during the Plan year ended December 31, 2024. The Plan Sponsor may also elect to contribute a discretionary profit sharing contribution, to be determined by the Plan Sponsor, not limited to current or accumulated net profits. The Plan Sponsor made a discretionary profit sharing contribution of \$406,266 during the year ended December 31, 2024. As required under the Plan, the Plan Sponsor also makes contributions to a designated safe harbor nonelective contributions account in the amount of 3% of employee's compensation, even if they do not defer any of their compensation under the Plan.

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution as well as an allocation of Plan earnings or losses, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan adoption agreement. Administrative expenses are charged to each participant's account when a benefit distribution is processed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. Description of the Plan, continued

### Vesting

Participants are vested immediately in their contributions and the Plan Sponsor's safe harbor matching contributions plus actual earnings thereon. Participants' vesting percentage will be 100 percent once retirement age is reached or the date the participant dies or becomes totally and permanently disabled. Before that date, participants are vested in the Plan Sponsor's discretionary matching and profit sharing contributions according to the following schedule:

### Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. If no such direction is made, participant accounts are invested in accordance with default investment alternatives as established under the Plan.

### Participant Loans

Participants may borrow a minimum of \$1,000, up to a maximum of the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate, which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant whose vested account balance is greater than \$5,000 may elect to receive either a single lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments over a specified period of time. On termination of service, a participant whose vested account balance is not greater than \$5,000 will receive his or her benefits as a single lump sum payment as soon as administratively feasible, as defined in the Plan agreement. Withdrawals of a participant's vested account balance are allowed after attainment of age 59½. Hardship withdrawals are permitted under the provisions of the Plan.

## 1. Description of the Plan, continued

### Forfeited Accounts

All forfeitures are applied to Plan Sponsor contributions and Plan expenses. As of December 31, 2024 and 2023, there were \$21,590 and \$11,519 of forfeited nonvested accounts, respectively. For the year ended December 31, 2024, there were forfeitures totaling \$18,423. Participant forfeitures of \$8,678 were used to reduce employer contributions during the year ended December 31, 2024.

### Risks and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

### Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan agreement. All other administrative expenses are paid by the Plan Sponsor.

## 2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

### Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

### Notes Receivable from Participants

Participant loans are classified as notes receivable from participants and measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the Plan adoption agreement.

### 2. Summary of Significant Accounting Policies, continued

#### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

#### Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through October 3, 2025, the date that the financial statements were available to be issued.

### 3. Information Certified and Provided by Custodian

The Plan's investment information included in this note and throughout the Plan's financial statements and supplemental schedule was prepared by or derived from information provided by Capital Bank and Trust Company (Capital Bank), the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Capital Bank that the investment information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to investment information in this note and which appears throughout the financial statements and supplemental schedule.

### 4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts primarily consist of money market funds, mutual funds and common stocks that are valued on the basis of readily determinable market prices.

*Stable value fund:* Valued at net asset value (NAV) of shares held by the Plan at year end. The underlying investments are designed to maintain a stable NAV. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

### **5. Related Party and Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Capital Bank. These transactions qualify as party-in-interest. Included in the administrative expenses of \$71,055 for the year ended December 31, 2024 is \$15,854 of fees paid by the Plan to Capital Bank for investment management services and withdrawal charges. The Plan pays additional direct fees to other third parties related to self-directed brokerage accounts which is also included in administrative expenses on the statement of changes in net assets available for benefits.

Additionally, indirect fees are paid to Capital Bank based on investment account values. The fees paid ranged from 0.04% to 0.81% of the investment account value. The fees reduce net appreciation in the value of investments on the statement of changes in net assets available for benefits.

### **6. Tax Status**

The Plan uses a non-standardized pre-approved profit sharing plan document sponsored by Retirement Management Services, LLC. A determination letter was received from the Internal Revenue Service (IRS), dated March 22, 2021, which states that the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### **7. Plan Termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100 percent vested in their allocated employer contributions.
