## **Independent Auditor's Report**

### ***Opinion***

#### Description of Plan

The following description of the Multicon Builders, Inc. Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

##### General

The Plan provides health, dental, vision and prescription drug benefits to employees and their dependents of Edwards Companies (Plan Sponsor), subsidiaries and/or affiliates, who participate. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Contributions

The cost of coverage is shared between the Plan Sponsor and the individual participants. Employee and COBRA contributions are determined by the trustees of the Plan in consultation with the Plan's third party administrator. The Plan Sponsor is responsible for funding the difference to enable claims to be paid in a timely fashion. The Plan Sponsor also pays for certain administrative expenses on behalf of the Plan and provides administrative support for the Plan.

##### Payment of Benefits

The Plan covers all eligible employees who meet the participation requirements of a Component Benefit Program as set forth in a Summary Plan Description or a Certificate of Insurance.

During 2024 and 2023, current claims of active participants and their dependents and beneficiaries are provided for under group insurance contracts with Anthem Blue Cross and Blue Shield (Anthem). Claim payments are recorded when paid by Anthem.

##### Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured medical benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

#### Summary of Significant Accounting Policies

##### Use of Estimates

The preparation of financial statements in conformity with another comprehensive basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported claims, claims payable and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Summary of Significant Accounting Policies (continued)

##### Basis of Accounting

The financial statements of the Plan are prepared using the modified cash basis of accounting. Therefore, contributions from participants and the employer are recognized as income when cash is received and claims, premiums, administrative and other expenses are recognized when paid. However, claims incurred but unpaid at year-end are reported as benefit obligations. The financial statements of the Plan are not intended to be a presentation in conformity with generally accepted accounting principles in the United States of America (GAAP). However, certain information is presented in accordance with GAAP.

##### Stop Loss

The Plan maintains insurance for stop-loss coverage for health claims at both an individual and aggregate level. Credits from stop-loss coverage during 2024 and 2023 were \$1,928,800 and \$675,311, respectively, and have been included within health care benefits paid in the accompanying financial statements.

#### Concentration of Credit Risk

Cash is held in an interest bearing checking account at one financial institution. The Plan occasionally maintains cash deposits in excess of federally insured limits.

#### Benefit Obligations

Benefit obligations at December 31, 2024 and 2023 are related to medical claims payable that are currently due and claims incurred but not yet reported to the Plan for active participants. The obligations are estimated primarily based on the most recent year's claims experience. Actual results could differ from the estimated benefit obligation.

#### Administrative Expenses

Anthem provides custodial and administrative services related to the medical benefit payments of the Plan. All medical benefit claims are managed, evaluated for propriety and disbursed by Anthem.

#### Plan Termination

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and non-discriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

#### **Tax Status**

The Trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code, and accordingly, the Trust's net investment income is exempt from income taxes. The Company has obtained a favorable tax determination letter from the Internal Revenue Service, and the Company believes that the Plan continues to qualify and to operate as designed.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Party-in-Interest Transactions**

The Plan pays Anthem certain third party administrator fees. Therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

#### **Subsequent Events – Date of Management's Evaluation**

Management has evaluated subsequent events through the date of the Independent Auditor's Report, the date on which the financial statements were available to be issued.
