

1. Description of Plan

The following description of the ACT1 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Advanced Concepts and Technologies International, LLC (the Company) except union employees, leased employees, and non-resident aliens. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan originated on December 27, 1999. The plan has been amended and restated to comply with the Further Consolidated Appropriations Act, 2020, including the SECURE Act provisions, the Coronavirus, Aid, Relief and Economic Security (CARES) Act, and the Consolidated Appropriations Act, 2021 (CAA). These provisions became effective on January 1, 2022.

Contributions

Employees are eligible to make deferrals to the Plan beginning the first day of the month following 30 days of service. Employees are eligible to receive a Company contribution upon completing six months of service. Beginning February 2024 eligibility for the Company contribution is the same as the employee deferrals.

Eligible participants may elect to contribute up to 100% of their compensation to the Plan, not to exceed the maximum annual dollar contribution restrictions of ERISA and the Internal Revenue Service. Additionally, the Company has the option of making a discretionary match up to a percentage of pay determined by the Company. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). For 2024, the Company contributed on behalf of each participant a safe harbor contribution of 100% of the participant's contribution for the first 3% of the participant's compensation, plus 50% up to the next 2% of compensation. Profit sharing contributions may also be contributed at the Company's discretion. For 2024, the Company decided not to make a profit sharing contribution.

Participant Accounts

Each participant account is credited with the participant's contributions and allocations of (a) Company contributions, (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations of earnings are based on participant gross wages or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants' vested account.

Participants direct the investment of the contributions into various investment options offered by the Plan. The Plan currently offers 31 mutual fund accounts and a stable value account.

Vesting

Participants are immediately vested in their voluntary and safe harbor contributions plus actual earnings thereon. Vesting in the profit-sharing contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of service. A participant receives credit for a year of service if they complete at least 1,000 hours of service at any time during the twelve consecutive month computation period.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$ 1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$ 50,000 reduced by the highest outstanding loan balance in the participant's account during the prior twelve-month period. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loans fund. The loans are secured by the balance in the participant's account and bear interest at prime rate. Principal and interest is paid ratably through semi-monthly payroll deductions. A participant may have up to three loans currently outstanding from the Plan at a time.

Payment of Benefit

On termination of service due to death, disability, retirement or other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, installment, or partial withdrawal. The Plan also allows for in-service withdrawals once the participant has attained age 59 1/2 and for hardship and disability requests, limited to the participant's vested account balance. Participant consent is required for distributions over \$ 5,000. Effective April 1, 2024, participant consent is required for distributions over \$ 7,000.

Forfeited Accounts

Forfeited nonvested accounts will be allocated to offset Plan expenses and employer contributions, or may be reallocated as company contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Loans to participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Certain loans are in default and for tax purposes are treated as deemed distributions. For financial reporting, these loans remain assets of the Plan until a distributable event occurs at which time the loan balance is formally offset against the participants accounts.

Payment of Benefits

Benefits are recorded when paid.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$ 21,173 and \$ 13,017, respectively. These accounts will be used to offset future Plan expenses and employer contributions. During the years ending December 31, 2024 and 2023, \$ 7,635 and \$ 7,413, respectively, was used to offset employer contributions.

Plan Expenses

Administrative expenses other than trustee fees of the Plan were absorbed by the company sponsor of the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other member requested services are charged directly to the participants account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information and certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. (the trustee of the Plan).

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Guaranteed Investment Contract with The Lincoln National Life Insurance Company

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with The Lincoln National Life Insurance Company (Lincoln) totaling \$ 1,167,087 for 2024 and \$ 1,692,859 for 2023. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.5%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

7. Tax Status

The Plan is using a Non-Standardized Pre-Approved Profit Sharing Plan with CODA document. The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the latest determination letter. However, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

9. Party-In-Interest Transactions

The Plan has not considered Company contributions to the Plan or benefits paid by the Plan to participants as party-in-interest transactions. The Plan holds investments in mutual funds of the trustee. Some fees incurred by the plan for investment management by the trustee of the plan were paid for by the Company.

10. Reconciliation of Financial Statements to Form 5500
