Report of Independent Auditors

Opinion

We have audited the financial statements of The Lilly Employee Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and statements of benefit obligations as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits and statement of changes in benefit obligations for the year ended December 31, 2024, and the related notes (collectively referred to as the “financial statements”).

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan at December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. Note 1 - Plan Description

General

The Lilly Employee Welfare Plan (the Plan) provides health and other benefits to substantially all active employees of Eli Lilly and Company (the Company and Plan Sponsor).

The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). More detailed information concerning the Plan may be found by consulting the Eli Lilly and Company U.S. Employee Handbook.

Benefits

The Plan is a welfare benefit plan established January 1, 1986. The Plan provides medical (including prescription drugs), holiday and vacation pay, severance, health and dependent care flexible spending accounts, and life insurance/death benefits to qualifying employees and to their beneficiaries and covered dependents.

The Plan consists of the following component plans:

- The Eli Lilly and Company Holiday and Vacation Plan
- The Lilly Long-Term Disability Plan
- The Eli Lilly and Company Health Plan
- The Eli Lilly and Company Flexible Benefits Plan
- The Eli Lilly and Company Health Care Flexible Spending Plan
- The Eli Lilly and Company Dependent Day Care Flexible Spending Plan
- The Eli Lilly and Company Limited Purpose Health Care Flexible Spending Plan
- The Eli Lilly and Company Life Insurance and Death Benefit Plan
- The Lilly Business Travel Insurance Plan
- The Lilly Severance Pay Plan
- The Eli Lilly and Company 2007 Change in Control Severance Pay Plan for Employees
- The Eli Lilly and Company 2007 Change in Control Severance Pay Plan for Select Employees
- The Severance Pay Plan for Eli Lilly Affiliate Employees in Puerto Rico

Contributions

For active employees that elect a Health Savings Account option, the Company contributes a specified amount each year into accounts that are established for each participant to cover costs for medical care and prescriptions. Employees may also contribute, up to a specified amount, pretax dollars into their accounts. As all unused dollars in each participant's account carry over from year to year and are kept by the participant upon retirement or termination, and as legal title of all contributions remains with the participant, employee contributions and employee account balances are not recorded in the accompanying financial statements.

For the Health Reimbursement Account option, the Company contributes a certain amount each year into participating employees' notional accounts that is used to cover the costs of medical care and prescriptions. If coverage is necessary beyond the amounts allocated by the Company, employees must cover a certain amount of the costs. Any unused dollars in the employees' accounts carry over from year to year. Unused dollars are forfeited upon termination of coverage.

Active employees contribute specified amounts, determined annually by the Company, toward their own coverage and, in most cases, to extend coverage to eligible dependents of the employee.

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded on a pay-as-you-go basis.

Note 1 - Plan Description (Continued)

Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to employees and to terminate the Plan, subject to the provisions set forth in ERISA. If the Company terminates or partially terminates the Plan, the VEBA trust (as defined in Note 2) will pay benefits that participants are entitled to receive under the terms of the Plan.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Claims and Premiums

Claim payments are recorded when paid. Certain premiums and claims are paid from the general assets of the Company; however, all premiums and claims of the Plan are recorded in the accompanying statement of changes in net assets available for benefits, regardless of whether they were paid from plan assets or from the general assets of the Company. Claims paid by the Company that are to be reimbursed by the Plan are recorded as a payable in the accompanying statements of net assets available for benefits.

Rebates

Rebates from prescription drug programs are recorded when earned from the provider and netted with claims paid in the accompanying statement of changes in net assets available for benefits.

Premium Claim Stabilization Reserve

At December 31, 2024 and 2023, the Plan had a receivable from American United Life Insurance Company (AUL) for claims incurred that were less than the premiums collected for the Supplemental and Dependent Life Insurance programs.

Claims Incurred But Not Reported

Plan obligations at December 31, 2024 and 2023 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Benefit Obligations

Amounts currently payable are primarily comprised of benefit claims paid by the claims administrators and reimbursed in the subsequent year, claims incurred but not reported as determined based on the previous year's claims and a provision for claims fluctuations, and benefit payments due to participants related to amounts contributed by employees to reimbursement accounts that remain unclaimed as of year-end.

Note 2 - Summary of Significant Accounting Policies (Continued)

Effective January 1, 2024, the income portion of the long-term disability leave benefit is now a fully insured benefit. The postemployment benefit obligation at December 31, 2023 represents an estimate of the insignificant obligation that remained for individuals moving from short-term disability to long-term disability at the end of 2023. As of December 31, 2024 the plan has no postemployment benefit obligation.

VEBA Trust

The Northern Trust Company (the Trustee) holds the Plan's investments in the Eli Lilly and Company Master Trust for Employee Benefits (VEBA I), which provides funding for active health and certain other benefits, including designated death, holiday, and vacation benefits.

Prefunded Vacation Benefits and Due to Plan Sponsor

At December 31, 2023, prefunded vacation benefits of approximately \$157.9 million represent amounts funded by the Company to VEBA I in 2023 relating to vacation benefits for the first half of 2024 that were reimbursed by the Plan to the Company in 2024. The Company did not similarly fund VEBA I as of December 31, 2024. Due to plan sponsor of approximately \$7.4 million and \$103.7 million as of December 31, 2024 and 2023 represents remaining fourth quarter vacation benefits from each respective year that will be reimbursed by the Plan to the Company in the first quarter of the subsequent year.

Income Tax Status

The trust funding the Plan has received an exemption letter from the Internal Revenue Service (IRS) dated January 15, 1985, indicating that, except for any unrelated business income, the trust is tax exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (the Code) as a Voluntary Employees' Beneficiary Association. The Plan and the trust are required to operate in conformity with the Code to maintain the tax-exempt status of the trust. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the related trust, except for any unrelated business income, is tax exempt. Unrelated business income essentially consists of investment income and is subject to unrelated business income taxes based upon the character of the income taxed (capital versus ordinary).

Accounting principles generally accepted in the United States of America require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Administrative Expenses

Certain expenses related to the medical and dental claims, as well as administrative and professional services for the Plan, are paid by the Plan. Certain other administrative expenses are paid by the Company.

Use of Estimates

The preparation of the financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Management evaluated subsequent events for the Plan through October 6, 2025, which is the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

ASC 820, *Fair Value Measurements*, defines fair value, establishes a framework for measuring fair value, and expands disclosures about fair value measurements. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). ASC 820 includes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Inputs other than quoted prices that are for the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement. Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based upon the lowest level input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation techniques and inputs used for each major class of assets and liabilities measured at fair value:

- Value of Interest in Common/Collective Trust Funds - Represents interests in pooled investment vehicles designed primarily for collective investment of employee benefit trusts. The fair value of the investment in this class has been estimated using the Net Asset Value (NAV) per unit as a practical expedient provided by the fund managers. Redemption is daily, and there were no unfunded commitments in this investment category.

Note 3 - Fair Value Measurements (Continued)

The valuation methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Note 5 - Parties-in-Interest

During 2024 and 2023, approximately \$9.3 million and \$8.1 million, respectively, of premiums were earned by AUL from the Plan, and approximately \$6.0 million and \$5.3 million, respectively, were received as reinsurance premium payments by ELCO Insurance Company Limited (ELCO), an indirect subsidiary of the Company. Certain plan assets are in investments managed by The Northern Trust Company. The Plan Sponsor funds the Plan for certain vacation benefits. The Plan uses these funds to periodically reimburse the Plan Sponsor for vacation benefits paid by the Plan Sponsor. The Plan has recorded a payable to the Plan Sponsor of approximately \$7.4 million and \$103.7 million at December 31, 2024 and 2023, respectively. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA and applicable regulatory guidance.
