Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of TK Elevator Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Note 1 - Plan Description

The following description of TK Elevator Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of certain subsidiaries, divisions, or affiliated entities of TK Elevator Corporation (the "Company"). All employees who have attained the age of 18, are not covered by a collective bargaining agreement (unless the agreement specifically provides for participation in the Plan), and are not nonresident aliens with no income from sources within the United States are eligible to participate in the Plan. Eligible employees hired or rehired on or after August 1, 2006 are automatically enrolled to contribute at 5 percent of compensation unless they elected otherwise within the allowable time period, as specified by the Company. For all other eligible employees, participation is voluntary and effective the first day of the first payroll period following the date the eligibility requirements discussed above are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employee contributions represent a percentage of such eligible participants' pretax earnings, as defined in the plan agreement, and are subject to the limits imposed by the Internal Revenue Code.

The Plan provides for nondiscretionary employer matching contributions of 100 percent of the first 5 percent of pay contributed by a participant. In addition to the regular employer matching contributions, participants may be entitled to have the Company make a true-up matching contribution on behalf of the participant. The true-up matching contribution, which is paid annually, is designed to make up for any matching contributions that the participant may not have received due to limits or restrictions on his or her pretax contributions.

The Company may also make an annual discretionary profit-sharing contribution to participants as of the last day of the plan year for those who have completed more than 500 hours of service during such year. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

Hourly employees of the Company's Middleton Plant, who are represented by the International Brotherhood of Boilermakers, Iron Ship Builders, Blacksmiths, Forgers, and Helpers Local S-251, making contributions to the Plan are entitled to an employer match equal to 100 percent of the first 5 percent of pay contributed by the participants, as previously described. In addition, based on the financial performance of the Middleton Plant, the Company may make additional matching contributions to employees hired prior to August 2, 2014 of up to 10 percent multiplied by participant contributions deferred, not to exceed 6 percent of compensation. In order to be eligible for the additional employer matching contribution, each participant must have made contributions during the plan year, have been credited with at least 500 hours of service during the plan year, and be an employee on the last day of the plan year. There were no such contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Participants with a company matching account or company profit-sharing account on or after January 1, 2004 and prior to January 1, 2000 are automatically 100 percent vested in those accounts. Participants first employed by the Company in a position covered by the Plan between January 1, 2000 and January 1, 2004 vest in matching and profit-sharing contributions 20 percent after one year of service and another 20 percent per year thereafter until they become fully vested after five years of service. Notwithstanding the above, a participant's profit-sharing contributions become 100 percent vested upon death, permanent disability, or reaching normal retirement age, as defined in the plan agreement.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Hardship Withdrawals

Participants may request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan document.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions. At December 31, 2024 and 2023, forfeited account balances totaled \$436,890 and \$218,421, respectively.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. In the event of plan termination, the trustee shall distribute all assets remaining in the Plan, after payment of any expenses properly chargeable against the Plan, to the participants in accordance with the value of the units credited to such participants as of the date of such termination. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company (Fidelity) or its affiliates. Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

Note 2 - Summary of Significant Accounting Policies (Continued)

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. The Managed Income Portfolio II common/collective trust fund has certain limitations on withdrawals and exchanges as follows:

Participant-directed: Withdrawals made in order to accommodate distributions to participants or transfers to noncompeting investments may be made on any business day. Transferred amounts must be held in a noncompeting investment option for 90 days before subsequent transfers to a competing fund can occur.

Non-participant-directed: Withdrawals directed by a plan sponsor must be preceded by a 12-month written notice to Fidelity. However, Fidelity may, at its discretion, complete any plan-level withdrawal before the expiration of such 12-month period. No such notice has been given to Fidelity.

There are no additional redemption notice requirements for the other common collective trust funds, and there are no unfunded commitments for any of the common collective trust funds.

Additionally, the Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include various investments in publicly traded securities and short-term cash, which are valued at quoted market prices. All other investments are valued based on quoted market prices. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 1, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
