**Note 1. Description of Plan**

The following description of Nashville Dental, Inc. 401(k) Plan (the Plan) is provided for general information purposes. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all full-time employees of Nashville Dental, Inc. (the Employer), who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute 100% of pre-tax annual compensation, as defined in the Plan. Participant contributions may also be made after-tax in the form of a Roth contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Employer may make discretionary-matching contributions or profit sharing contributions on a discretionary basis. Employees must be employed on the last day of the Plan year and be credited with 1,000 hours of service during the year to be eligible for the matching and profit sharing contributions. For the year ended December 31, 2024, the Employer made matching contributions of \$96,819 and profit sharing contributions of \$43,181. Contributions are subject to certain statutory limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of: (a) the Employer's contributions and, (b) Plan earnings (losses), and charged with their withdrawals and an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in the Employer's matching contributions. Vesting in the Employer's profit sharing contributions is based on years of continuous service as follows:

**Note 1. Description of Plan**

**Notes Receivable From Participants**

Notes receivable from participants are not permitted under the Plan.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement, or other reasons, a participant or his or her beneficiaries may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals prior to attaining age 59½ are not permitted, except in the event of retirement, disability, or as a hardship distribution. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

**Forfeitures**

As of December 31, 2024 and 2023, forfeited nonvested accounts total \$640 and \$584, respectively. Per the Plan Document, these amounts may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan.

**Note 2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (US GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits paid to participants are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment-related expenses are included in net change of fair value of investments.

**Note 3. Certification**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements, notes, and supplemental schedules was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (USA) (John Hancock), the custodian of the Plan. The Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to this information:

- Investments at fair value with the exception of the life insurance policy
- Net change in fair value of investments

**Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and that the Plan has the ability to access.

Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets.

Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The prior year period presentation was revised to move the classification of separate accounts within the fair value hierarchy table to better reflect the underlining funds as well as to reflect measurement at NAV practical expedient. There was no difference in fair value in making the revision. Following is a description of the valuation methodologies used for assets measured at fair value.

The following is a description of the valuation methodologies used for the Plan's assets measured at fair value:

*Pooled Separate Accounts:* Investments in the pooled separate accounts are stated at estimated daily net asset value (NAV), which has been determined based on the unit values of the funds. Each investment is valued at a daily-calculated unit value, which is determined by the organization sponsoring such funds by dividing the fund's net assets at fair value by its units outstanding at each valuation date. There are no liquidity or redemption restrictions that impact the value of NAV of underlying funds. These investments are classified within Level 2 of the valuation hierarchy.

*Life Insurance Policy:* This investment is the cash value of a life insurance policy for an individual participant. The value was determined by the underwriting insurance company's valuation models, which take into account the passage of time, mortality tables, interest rates, cash values for paid up additions, and dividend accumulation. The cash surrender value represents the guaranteed value the Plan would receive upon surrender of the policy at December 31, 2024.

**Note 4. Fair Value Measurements**

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at December 31, 2024 and 2023.

**Note 5. Party-in-interest Transactions**

Certain Plan investments are managed by John Hancock. John Hancock is the custodian as defined by the Plan and, therefore these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA. Fees incurred by the Plan for investment management services are included in investment income, as they are indirect fees paid through revenue sharing, rather than a direct payment.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan under the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions and related earnings thereon.

**Note 7. Tax Status**

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Access Retirement Services, LLC. The non-standardized pre-approved profit sharing plan practitioner has received an opinion letter from the Internal Revenue Service (IRS) as to the non-standardized pre-approved profit sharing plan's qualified status. The volume submitter plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code (IRC) and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, no uncertain positions have been taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to IRS examinations for the years prior to 2021.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Subsequent Events**

Management has evaluated subsequent events through September 29, 2025, the date on which the financial statements were available for issuance.
