## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Malco Tools, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

### Opinion

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting, and for determining that the modified cash basis of accounting is an acceptable basis for preparation of the financial statements in the circumstances. DECEMBER 31, 2024 AND 2023

**1. Description of the Plan**

The following description of the Malco Tools, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. The plan was amended effective June 1, 2024, to reflect the name change from Malco Products SBC Profit Sharing, Savings and Retirement Plan to Malco Tools, Inc. 401(k) Plan and to include an automatic enrollment feature at 6% of compensation, an automatic increase of 1% up to a maximum of 10% of compensation beginning January 1, 2025, and other administrative changes.

General - The Plan is a defined contribution plan covering all employees, except union employees, work study students and student interns, who have completed six months of service and reached age 18. Effective January 1, 2021, part-time employees who have three consecutive years of service with at least 500 hours of service in each of the three years are eligible for the Plan. The Plan is subject to the provisions of ERISA. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

Contributions - Participants may contribute as they elect under the terms and limits of Section 401(k) of the Internal Revenue Code. The amount of the employer's annual contribution to the plan is to be determined by the Company's Board of Directors but may not exceed the maximum deductible amount under the Internal Revenue Code. Employer contributions and forfeitures are allocated based upon participant compensation. The Company's matching contributions under Section 401(k) are limited to a percentage of a participant's contribution and a flat dollar limitation set at the discretion of the Board of Directors and further limited to the amount deductible under the Internal Revenue Code. During the years ended December 31, 2024 and 2023, the employer contributions received were 30 percent of participant contributions, up to a maximum of \$1,200 per participant. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's employer contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant becomes vested at a rate of 10% per year of service for the first two years and 20% per year thereafter with full vesting after six years of service. See Note 6 for vesting related to partial termination.

Notes Receivable from Participants - Participants may borrow from their fund accounts under the terms of the Plan and in accordance with IRS regulations. Each loan is secured by a pledge of the participant's vested interest. The loan interest rate is based on the prime rate charged by commercial lending institutions. Principal and interest are paid ratably through bi-weekly payroll deductions for a period not to exceed 60 months, except where funds are used to acquire a principal residence.

Payment of Benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeitures - At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,746 and \$1,384, respectively. These accounts will be reallocated to participants in the Plan.

NOTES TO FINANCIAL STATEMENTS

**2. Summary of Accounting Policies**

Basis of Accounting - The financial statements of the Plan are prepared on the modified cash basis of accounting. Under this basis of accounting, additions to net assets are generally recorded when received and deductions are generally recorded when paid. Investments are recorded at fair value, resulting in the modification to cash basis. This basis of accounting is a comprehensive basis other than generally accepted accounting principles.

Use of Estimates - The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when received. Net appreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year.

Contributions - Contributions from Plan participants and employer contributions are recorded in the year in which the contributions are received by the Plan.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the cash basis. Related fees are recorded as administrative expenses and expensed when they are paid. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a reduction to contributions when distributed.

Payment of Benefits - Benefits are recorded when paid.

Expenses - It has been the policy of the Company to bear the administrative costs other than withdrawal fees and member requested services for the Plan. These fees are charged directly to the participant's account and are included in administrative expenses. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts – Pooled separate accounts are value at the net asset value (NAV) of shares held by the Plan at year end as reported by the fund managers (level 2 inputs). The pooled separate accounts invest in single mutual funds which are generally identified in the name of the pooled separate account. Investments in these funds can be redeemed daily upon request and have redemption prices that are determined by the fund's net asset value per unit.

Collective trust fund – Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the Statements of Net Assets Available for Benefits – Modified Cash Basis.

**4. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company and Principal Life Insurance Company (the trustee and custodian of the Plan).

**5. Related-Party and Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Principal Financial Group, which is a party-in-interest. Fees paid by the Plan for administrative expenses were \$48,218 and \$5,602 for the years ended December 31, 2024 and 2023, respectively.

Fees incurred by the Plan for investment related expenses are included in net appreciation of fair value of investments. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**6. Plan Termination and Partial Plan Termination**

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

During the year ended December 31, 2022, the Company began to close one of its locations, leading to more than 20% of employees being terminated. This qualified as a partial termination, in which employees terminating employment in 2022 and 2023 became 100% vested in their accounts.

**7. Tax Status**

During the year ended December 31, 2022, the Company restated its existing plan document by adopting a pre-approved plan document from Principal Financial Group, effective January 1, 2023. The IRS has determined and informed the plan document submitter by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
