Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Chipman Design Architecture Inc. Employee Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 – DESCRIPTION OF PLAN

Chipman Design Architecture, Inc. sponsors the Chipman Design Architecture Inc, Employee Retirement Savings Plan (the Plan). The following description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Effective January 1, 2023, the Plan was restated to reflect required regulatory changes and legislative changes for The Bipartisan Budget Act of 2018 and Final Regulations Relating to Hardship Distributions and Tax Cuts and Jobs Act.

General

The Plan is a defined contribution plan established for the benefit of the Company's employees, except for non-resident aliens, collective bargaining employees and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Nonexcluded employees who have reached the age of 21 and who have completed 1,000 hours of service within a twelve-month period are eligible to participate in the Plan. Participants may enroll in the Plan on the first day of the quarter after satisfying eligibility requirements.

Contributions

Participants may contribute up to the 401(k) plan limit set by the IRS which was \$23,000 in 2024. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan and may modify or transfer existing balances each business day.

At its sole discretion, Chipman Design Architecture Inc. may make a matching contribution equal to a 25% of employee salary deferrals. Matching contributions are invested into investment options in proportion to the participants' investment selection for elective contributions. Matching contributions of \$151,737 and \$136,177 were made for years ended December 31, 2024 and 2023, respectively.

Contributions (Continued)

Also, at its sole discretion, Chipman Design Architecture Inc may make an additional annual profit-sharing contribution. The profit-sharing contribution is allocated to the participants based on the ratio that his/her compensation bears to the compensation of all eligible participants. Profit Sharing contributions are invested into investment options in proportion to the participants' investment selection for elective contributions. No profit-sharing contribution was made for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of Chipman Design Architecture Inc's matching and profit-sharing contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer contribution and profit-sharing portion of their accounts ranges from 20% after one year to 100% after five years of credited service.

Payment of Benefits

Benefits under the Plan are payable to participants or their beneficiaries upon death, retirement, disability, proven financial hardship or severance of employment. Benefits are to be paid in a lump-sum. Balances that do not exceed \$7,000 must be distributed upon severance of employment.

Forfeited Accounts

In event of termination of employment before full vesting, the non-vested portion is forfeited upon certain conditions as specified in the Plan document, with such forfeitures being used to reduce future employer contributions and the Plan's ordinary and necessary administrative expenses. \$8,407 and \$6,664 of forfeited non-vested accounts reduced employer contributions for the years ended December 31, 2024 and 2023, respectively.

Administrative Expenses

Chipman Design Architecture Inc., at its discretion, pays certain administrative expenses of the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive investment contracts are reported at contract value because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on an accrual basis. Net change in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment related expenses are included in net change in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Corrective Distributions

Corrective distributions are netted against contributions received.

Subsequent Events

The Plan has evaluated subsequent events through September 22, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASURES

Financial Accounting Standards Board established a three-tier hierarchy to measure the fair value of an asset or liability. Level 1 inputs include reported prices in active markets for identical assets or liabilities. Level 2 inputs include market data that are directly or indirectly observable. Level 3 inputs are unobservable and corroborated by little or no market data.

Pooled separate accounts are valued using the net asset value (“NAV”) as a practical expedient which represents the price at which the fund is able to initiate a transaction. NAV is determined using the fair value of the underlying investments held by the funds less their liabilities and adjusted for contractual expense factors. These investments are excluded from the fair value hierarchy. Units are valued daily.

The valuation methodologies described above may generate a fair value calculation that may not be indicative of net realizable value or future fair values. While the Plan believes the valuation methodologies used are appropriate, the use of different methodologies or assumptions in calculating fair value could result in a different fair value measurement at the reporting date.

NOTE 4 – CERTIFIED INVESTMENTS

Participants direct the investment of their accounts, as listed on Schedule A-1. The Plan’s custodian, John Hancock Life Insurance Company (USA) provides a menu of investment options from which participants may select. Participants may modify or transfer existing balances each business day. The plan custodian executes all investment transactions and Schedule A-1 summarizes the fair value of investments at December 31, 2024.

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (USA).

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

As the Plan sponsor, the Company is a party-in-interest with respect to the Plan.

Certain administrative expenses, totaling approximately \$20,295, were paid by the Company on behalf of the Plan for the year ended December 31, 2024. The Company does not expect reimbursement from the Plan for these expenses. Certain administrative functions are performed by officers and employees of Chipman Design Architecture, Inc. No officer or employee receives compensation from the Plan for these services.

Recordkeeping service fees and investment advisory fees totaled approximately .25% of net assets available for benefits and are included in net appreciation in the fair value of investments, rather than direct payment.

NOTE 6 – INCOME TAX STATUS

The Internal Revenue Service (“IRS”) has determined and informed the Plan by a letter dated March 22, 2021 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan administrator and the Plan sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, Chipman Design Architecture Inc has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
