### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Trends International, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. ### 1. DESCRIPTION OF PLAN

The following description of the Trends International, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan sponsored by Trends International, LLC (the Employer or Plan Sponsor) and covers employees who are age 21 years or older and have completed three months of service. Employees must also be a participant in the Plan for at least one day of the Plan year to be eligible for discretionary profit-sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### Contributions

Each year, participants may defer a portion of their annual compensation, as defined in the Plan, up to the maximum amount allowable by the Internal Revenue Code (IRC). These contributions can be made through a combination of pre-tax contributions (traditional 401(k)) and after-tax contributions (Roth 401(k)). Participants may also contribute amounts representing qualified rollover distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. They may change their investment options among those investments provided at any time during the plan year.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and their contributions invested in mutual funds qualifying as default investment alternatives under Department of Labor (DOL) regulations until changed by the participant.

The Employer contributes 100 percent of the first 4 percent of elective deferrals that the participant contributes to the Plan. The Plan also allows for discretionary matching and nonelective (profit sharing) contributions as determined by the Plan Sponsor. The Employer contribution is invested as directed by the participant. Contributions are subject to certain Internal Revenue Service (IRS) limitations. During the year ended December 31, 2024, there were no discretionary matching or nonelective contributions made by the Employer to the participants of the Plan.

#### Automatic Deferral Escalation

The Plan has an automatic escalation of deferral percentage provision whereby employees contributing to the Plan under the auto-enrollment provision automatically increase their deferral percentage by 1 percent annually, up to a maximum of 12 percent, unless they expressly decline the increase. Automatic deferral percentage increases become effective on April 1<sup>st</sup> of each year going forward.

### Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions and the Employer's contributions, as well as allocations of plan earnings (or losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants become vested in the Employer's matching and profit sharing contribution portions of their accounts plus actual earnings (or losses) thereon based on years of service. A participant vests on a graduated schedule and becomes fully vested after five years of credited service. If not already vested, a participant becomes fully vested upon the occurrence of the participant's attainment of Normal Retirement Age, death while employed by the Employer, or satisfying the requirements for Disability Retirement.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance in the participants account during the prior twelve-month period, or 50 percent of the participant's vested account balance. The note term may not exceed five years, unless such note is for the purpose of the participant's primary residence. The notes are secured by the balance in the participant's account and bear interest at a fixed rate determined by the plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest are paid ratably through payroll deductions.

### Payment of Benefits

On termination of service due to attainment of Normal Retirement Age (as defined), death, disability, or other reasons, a participant with an account balance greater than \$5,000 may elect to receive a lump-sum distribution, installment payments, have the balance directly rolled over to an eligible retirement plan, or leave the funds in the Plan for a distribution at a later time. A participant who has terminated employment and has a vested balance that does not exceed \$1,000 will receive a lump-sum distribution. A participant who has terminated employment and has a vested balance between \$1,000 and \$5,000 may elect to receive either a lump-sum distribution or have the account balance rolled over to an eligible retirement plan.

### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$50,818 and \$26,475, respectively. The non-vested portion of former participants' accounts may be used to reduce future employer contributions or pay administrative expenses of the Plan. During the year ended

December 31, 2024, the Company did not use non-vested forfeitures to reduce the Company's employer contribution or pay administrative expenses.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the modified cash basis of accounting. The modified cash basis differs from accounting principles generally accepted in the United States of America in that contributions and dividend and interest income are recorded when received, and expenses are recorded when paid.

Although the modified cash basis of accounting represents a departure from accounting principles generally accepted in the United States of America, it is an allowable method of accounting for employee benefit plans under the reporting requirements of ERISA.

#### Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded as of the settlement date, which does not differ materially from the trade date. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Effective January 1, 2024, the Plan allows notes receivable from participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are paid. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024.

#### Payments of Benefits

Benefits are recorded when paid.

### Expenses of the Plan

The Plan Sponsor provides administrative and accounting services to the Plan at no cost. Certain administrative expenses of the Plan are paid directly by the Plan Sponsor including legal and other expenses of the Plan. Administrative expenses incurred by the Plan include third-party administrator fees, independent investment advisor fees, notes receivable fees, distribution fees charged directly to participants' accounts and audit fees.

### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits (modified cash basis).

### Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to the statement of net assets available for benefits (modified cash basis) date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is September 25, 2025.

## **3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants information reflected on the accompanying statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, the schedule of assets at December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024.

## **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- *Money Market Mutual Fund* – Generally transact subscription and redemption activity at a \$1 stable net asset value (NAV); however, on a daily basis, the funds are valued at their daily NAV calculated using the amortized cost of the securities held in the fund.
- *Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The investment in a money market mutual fund is considered to be a Level 2 investment. All remaining investments are considered to be Level 1 assets within the preceding fair value hierarchy.

### **5. PARTIES-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others.

Fidelity Management Trust Company is the trustee of the Plan, and receives payments for contract administrative services, as well as direct payment from participants on a transactional basis for processing distributions. Blue & Co., LLC is the independent auditor for the Plan and receives payment from the Plan for its services, which are recorded as administrative expenses. Morgan Stanley is the investment advisor for the Plan and receives payment from the Plan for these services.

### **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their employer contributions.

### **7. TAX STATUS**

The Plan has adopted a pre-approved plan document sponsored by FMR LLC, which has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
