## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of The Independent Order of Foresters 401 (k) Savings & Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Independent Order of Foresters 401 (k) Savings & Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Independent Order of Foresters 401(k) Savings & Retirement Plan, and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Independent Order of Foresters 401(k) Savings and Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

## 1. DESCRIPTION OF THE PLAN

The following brief description of The Independent Order of Foresters 401(K) Savings & Retirement Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

### (a) General

The Plan is a defined contribution 401(k) plan established as of January 1, 1986 to provide retirement benefits for eligible employees of The Independent Order of Foresters ("Foresters Financial"). Foresters Financial is the Plan Administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

### (b) Eligibility

The Plan covers all Foresters Financial U.S. employees who have at least six months of service and are not a leased employee, contract employee, classified as a non-employee on the employer's records, and are not covered by a collective bargaining agreement, unless such agreement expressly provides for participation. As of December 31, 2024, and 2023 the Plan had 70 and 71 active participants, respectively.

### (c) Contributions

Each year, participating employees may contribute up to 15% of their compensation, as defined in the Plan document and subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for a matching contribution equal to \$1 for every \$2 of pre-tax deferrals (including catch-up contributions) participants elect to make, except that participant contributions in excess of 6% of participant compensation in any one payroll period will not be matched. After tax contributions are not matched.

Participants direct the investments of the matching contributions into various investment options offered by the Plan.

The Plan also provides for a fixed contribution equal to 3% of participant compensation. Participants direct the investments of the fixed contributions into various investment options offered by the Plan.

### (d) Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) Foresters contribution and (b) Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### (e) Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in Foresters contribution portion of their accounts is based on years of continuous service.

Participants become fully vested in all employer contributions after three years of service. Participants fully vest immediately upon attainment of age 65, or in the event of death or permanent and total disability, as defined under the applicable Foresters long-term disability plan.

### **(f) Forfeitures**

Terminated participant accounts are reduced for non-vested amounts as of the earlier of (a) the date the participant receives a distribution of his or her entire vested account or (b) the first date that the participant has not been an employee for five years. Non-vested amounts are used to reduce Foresters' future required contributions.

At December 31, 2024, the forfeited non-vested accounts were \$0 (2023 - \$0). During 2024, Foresters contributions to the plan were reduced by \$17,127 (2023 - \$22,281) due to contribution credits received for terminated employees' forfeited non-vested balances. Forfeitures relate only to employer contributions.

### **(g) Payment of benefits**

Upon termination of service, a participant may receive the value of his or her vested account as a lump sum distribution or in installments. The lump sum may take the form of a direct payment to the participant or a rollover on behalf of the participant.

Hardship and other in-service withdrawals by eligible participants are permitted under the Plan upon specified criteria being met.

### **(h) Plan expenses**

Investment management fees, audit expenses and third-party recordkeeping expenses are paid by the Plan. The cost of operating the Plan is paid for by Foresters Financial. Day-to-day administration expenses are paid for by Foresters Financial.

### **(i) Loans to participants**

Participants may take loans up to the lesser of \$50,000 or 50% of the participant's vested interest in the Plan. The loans bear an interest rate of between 5.25% and 10.50% as of December 31, 2024 (5.25% and 10.50% as of December 31, 2023). The loans are repaid through payroll deductions over a maximum period of five years.

## **2. SIGNIFICANT ACCOUNTING POLICIES**

The following are significant policies followed by the Plan:

### **(a) Basis of accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

### **(b) Use of estimates**

The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **(c) Risks and uncertainties**

The Plan provides various investment options in pooled separate accounts, common/collective trusts and registered investment companies.

Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in various risk factors, in the near term, could materially affect participants' account balances and the amounts reported in the financial statements.

Participants are able to determine their own investment mix by directing their investments among any of several investment funds. There are no guarantees of performance and Foresters does not provide investment advice or insure or otherwise guarantee the value or performance of any investment chosen by a participant. The Plan is intended to constitute a plan described in Section 404(c) of ERISA and in Title 29 of the Code of Federal Regulations, Section 2550.404c-1. This means that the Plan fiduciaries are not liable for any losses that are the direct and necessary result of investment instructions given by participants. Participants have no voting rights with respect to the shares held in their accounts.

Recent market conditions have resulted in an unusually high degree of volatility and increased the risks and short-term liquidity associated with certain investments held by the Plan, which could impact the value of investments after the date of these financial statements.

Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

### **(d) Investment valuation and income recognition**

Investments are reported at fair value (except for the fully-benefit responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See (note 3) for discussion of fair value measurements.

Net appreciation/(depreciation) in fair value of investments is reflected in the Statement of Changes in Net Assets Available for Benefits and includes realized gains and losses on investments bought and sold and the change in appreciation/ (depreciation) from one period to the next. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Acquisition costs are included in the cost of investments purchased, and sales are recorded net of selling expenses.

### **(e) Payment of benefits**

Benefit payments are recorded when paid.

### 3. FAIR VALUE MEASUREMENTS

The Plan follows a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
  - If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following valuation methodologies are adopted by the Plan:

- Pooled separate accounts: Valued at the net asset value ("NAV") of shares held by the plan at year end.
- Registered investment companies: Valued at quoted market prices.

The methods described above may produce a fair value calculation that is not indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. INVESTMENTS

As of and for the years ended December 31, 2024 and 2023, the Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator has obtained certifications from Principal Trust Company and Principal Life Insurance Company that all information relating to the Plan's investments and related investment income is complete and accurate. Information as to the value of the investments in the trust fund managed by the trustees, investment income (loss), and all information in the supplemental schedule of assets held at the end of the year is presented in reliance solely upon those certifications.

The Principal Stable Value Fund managed by Principal Global Investors Trust Company is valued at contract value because it is fully benefit responsive. The contract value at December 31, 2024 and 2023 was \$3,059,423 and \$2,665,205, respectively.

Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed interest account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. The Plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. The guaranteed investment contract does not

permit the insurance company to terminate the agreement prior to the scheduled maturity date.

## 5. TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed Foresters Financial, by a letter dated September 25, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC") and that the related trust is tax-exempt. There have been amendments to the Plan since the September 2017 IRS determination letter, but the Plan Administrator has no reason to believe that the amendments have compromised the Plan's status in this regard. An application for a current determination letter is pending with the IRS. The Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC, and the Plan Administrator's tax counsel has no reason to believe otherwise. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## 6. PLAN TERMINATION

Although it has not expressed any intent to terminate the Plan, Foresters Financial has the right under the Plan to discontinue its contributions at anytime or to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts with respect to Foresters contributions that were not already vested by reason of attaining service or age vesting requirements.

## 7. RELATED PARTY TRANSACTIONS

Principal Life Insurance Company ("Principal") is the record keeper for the Plan and the investment manager for the pooled separate accounts held by the Plan and, therefore, Principal is considered a party-in-interest to the Plan under ERISA rules. Fees paid to Principal in 2024 were \$42,337 (2023 - \$21,831).

### **9. COMPLIANCE TESTING**

The Plan passed the Actual Deferral Percentage and Actual Contribution Percentage (ADP/ACP) tests for the year ended December 31, 2024. As a result, there were no excess contributions that were recorded as a liability in the accompanying Statement of Net Assets Available for Benefits.

In addition, the Plan passed the Ratio Percentage Test for 2024. Qualified Non-elective Contributions (QNEC) were therefore not required in 2024 for employees.

### **10. SUBSEQUENT EVENTS**

Foresters has evaluated subsequent events from the balance sheet date through October 6, 2025 the date at which the financial statements were issued and determined there are no other items to disclose.
