We have performed audits of the financial statements of the Robot-O Logistics, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). **Note 1
Description of the Plan**

The following description of the Robot-O Logistics, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Robot-O Logistics, LLC (the “Company” or “Sponsor”), and is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Company adopted the Robot-O Logistics, LLC 401(k) Plan effective January 1, 2022.

Eligibility

The Plan covers substantially all employees of the Company who have completed three (3) months of service and have attained the age of eighteen (18).

Contributions

Each year, participants may elect to contribute their eligible pre-tax compensation to the Plan up to the amount allowable under the Plan document and current income tax regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants can also make contributions to the Plan under the provisions of a Roth feature, wherein the contributions are taxed to the employee. The subsequent disbursements under the Roth feature are non-taxable at the time of the distribution. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 7% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatic enrollment deferral contributions are increased by 1% each year subsequent to enrollment up to 15%. The Company has elected Safe Harbor status and makes Safe Harbor matching contributions equal to 100% of the matched employee contributions that are not in excess of 1% of total employee eligible earnings, plus 50% of the amount of the matched employee contributions that exceed 1% of total employee eligible earnings, but that do not exceed 6% of total employee eligible earnings. The Company may also, in its sole discretion, make nonelective contributions to the Plan on behalf of eligible participants, although the Company is not required to do so. Contributions are subject to regulatory limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and the Company’s Safe Harbor matching contributions as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of the participant's assets is based on years of continuous service. For matching contributions, a participant becomes 100% vested after 18 months of credited service. For nonelective contributions, a participant becomes 100% vested after six years of credited service, at a rate of 20% per year beginning after the second year of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is determined by the Wall Street Journal prime rate on the date of the loan, plus 1% per annum. Principal and interest is paid ratably through weekly payroll deductions.

Cash and Cash Equivalents

Cash equivalents are considered to be all highly liquid investments with a maturity at the time of purchase of three months or less.

Payment of Benefits

On termination of service for reasons other than death, a participant will generally receive the value of the vested interest in the participant's account as a lump sum distribution. On termination of service due to death, distributions generally must be completed within five years, unless an election is made by the beneficiary to receive annuity payments over the life expectancy of the beneficiary.

Forfeitures

Any forfeitures of employer contributions may be used to reduce employer contributions for the Plan year in which the forfeitures occur, to pay Plan expenses, and/or to restore previously forfeited account balances as provided for under the Plan. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,537, and \$6,234, respectively. For the year ended December 31, 2024, employer contributions were reduced by \$9,156 from forfeited non-vested accounts.

**Note 2
Summary of Significant Accounting Policies and Use of Estimates**

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP"), using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note Receivable from Participant

Note receivable from participant is measured at unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of December 31, 2024, the rate of interest on the outstanding loan is 9.50% with the maturity date in April 2027. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent accounts are treated as a deemed distribution when a distributable event occurs (i.e. termination of employment).

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of note receivable from participant are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Note 3
Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 4
Tax Status**

The IRS has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5
Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Companies (Mutual Funds): Shares of registered investment company funds (or mutual funds) are valued at the net asset value (NAV) of shares held by the Plan and are valued at the closing price reported on the active market on which the individual securities are traded, which are estimated to be level 1 measurements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including cash and cash equivalents and investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (the trustee of the Plan).

**Note 7
Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**Note 8
Related Party and Party-In-Interest Transactions**

Certain Plan investments are in funds and accounts that are managed by Matrix Trust Company. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

Note 10
Untimely Contributions

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

In July 2025, the Plan Sponsor entered into a Custodial Services Agreement with Vestwell Trust Company and a Plan Services Agreement with Vestwell Holdings, Inc. for the purpose of transferring the Plan into a Pooled Employer Plan named Vestwell DSP PEP. The Sponsor anticipates the transfer will be effective by October 31, 2025.
