To the Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Lobar Associates, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Opinion

Basis for Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Supplemental Schedules Required by ERISA

The supplemental schedule of Assets Held for Investment Purposes at End of Year as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF PLAN

The following description of the Lobar Associates, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

A. GENERAL

The Plan is a defined contribution plan established by Lobar Associates, Inc. (the Company) on January 1, 1995. The Plan provides retirement benefits and additional incentives to eligible employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Management is responsible for the oversight of the Plan and has engaged a fiduciary to assist with determining the appropriateness of the Plan's investment offerings and monitors investment performance.

B. ELIGIBILITY

The Plan covers all employees of the Company and of Lobar Site Development Corporation (a controlled group based on the brother-sister group definition), who are at least 18 years of age and have completed 500 hours of service and six months of employment, except for union members and non-resident aliens. Eligible employees may become participants on January 1 or July 1 coinciding with the date that the employee meets the eligibility requirements set forth above.

C. CONTRIBUTIONS

Each year, participants may contribute up to the maximum limit established by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a stable value fund (common collective trust).

The Company may make matching contributions equal to a dollar amount of each participant's deferral contributions, up to a maximum of \$1,000 per calendar year. To be eligible to receive a match for a calendar year, participants must be employed by the Company on that last day of that calendar year, except in the case of reaching normal retirement age (60), disability or death. The Company may also make discretionary contributions to the Plan. For the years ended December 31, 2024 and 2023, the Company did not make any discretionary contributions. Contributions are subject to certain IRS limitations.

1. DESCRIPTION OF PLAN (CONTINUED)

D. PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution, employer matching contribution, an allocation of the Company's discretionary contributions, and an allocation of the Plan's earnings. Participants are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specified participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

E. VESTING

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions is based on years of continuous service. A participant is 100% vested after attaining a total of three years of service. Regardless of the vesting schedule, participants become fully vested upon attaining normal retirement age, death, or total and permanent disability.

F. NOTES RECEIVABLE FROM PARTICIPANTS

Participants may not borrow from their fund accounts.

G. PAYMENT OF BENEFITS

Upon termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a single lump sum payment or an eligible rollover distribution. If employment is terminated and the value of a participant's nonforfeitable account balance is \$7,000 or less, the Plan may immediately distribute the participant's account. Participants who have attained age 59 ½ may elect to receive in-service distributions. The Plan also provides for hardship withdrawals that may be requested for certain deemed immediate and heavy financial needs, such as medical expenses, the purchase of a home, educational expenses, payments to prevent participant's eviction from a principal residence or foreclosure, payments for certain burial or funeral expenses, repairs to a principal residence that would qualify for the casualty deduction under the Internal Revenue Code, or expenses and losses incurred on account of a federally declared disaster. The distribution can be taken from eligible funds in the participant's account balance.

H. FORFEITURES

As of December 31, 2024 and 2023, the Plan held zero forfeitures. Any forfeiture arising from nonvesting or other provisions of the Plan shall be used to pay administrative expenses or to reduce the contributions made by the Company, if not allocated to participants' accounts. For the years ended December 31, 2024 and 2023, no forfeitures were utilized to offset administrative expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

B. USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (NOTE 4). Management determines the Plan's valuation policies utilizing information provided by Capital Bank and Trust, the Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. EXCESS CONTRIBUTIONS PAYABLE

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 and 2024 excess contributions to the applicable participants prior to March 15 of the subsequent year, as required by the IRC.

E. PAYMENT OF BENEFITS

Benefits are recorded when paid.

F. ADMINISTRATIVE EXPENSES

Substantially all of the Plan's administrative expenses are paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in administrative fees.

G. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through July 9, 2025, the date the financial statements were available to be issued.

3. CERTIFIED INVESTMENTS

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, Capital Bank and Trust, the trustee of the plan, has certified the following information, which has not been subject to audit by independent auditors, to be complete and accurate:

- Investment balances included in the statements of net assets available for benefits as of December 31, 2024 and 2023, and in the notes to the financial statements.
- Investment income balances included in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and in the notes to the financial statements.
- Information included in the accompanying schedule of assets held for investment purposes at end of year.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurement* are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 or 2023.

Mutual Funds: Valued at the net asset value of the shares held by the Plan at year-end, quoted in an active market.

Common Collective Trust: The fair value of participation units held in the Federated Capital Preservation Fund (the Fund) is based on net asset value, as reported by the manager of the Fund, Federated Investors Trust Company, as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date. The Fund pursues stability of principal and current income by investing in stable value products, including traditional and synthetic guaranteed investment contracts (GICs) issued by major insurance companies and money market instruments. The use of net asset value as fair value is deemed appropriate as there are no imposed redemption restrictions and the Plan does not have any contractual obligations to further invest in the Fund.

5. RELATED PARTY AND PARTY-IN-INTEREST

Certain Plan investments are managed by Capital Bank and Trust. The Capital Group owns Capital Bank and Trust and American Funds. Capital Bank and Trust is the trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Capital Bank and Trust provides certain administrative and custodial services to the Plan pursuant to a Recordkeeping and Administrative Fee Agreement between the Company and Capital Bank and Trust. Fees paid by the Plan for distributions amounted to \$957 and \$505 for the years ended December 31, 2024 and 2023, respectively.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their accounts.

7. TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the volume-submitter prototype plan adopted by the Plan was designed in accordance with applicable sections of the IRC. The Plan has been amended and restated since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable sections of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
