NOTES TO FINANCIAL STATEMENTS

**Note 1 - Plan Description:**

The following description of the 3A Composites (“Company” or “Sponsor”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan Document and Summary Plan Description for a more complete description of the Plan’s provisions, which is available from Plan management.

**General**

The Plan is a defined contribution plan covering all eligible employees of 3A Composites and all eligible employees of Baltek, who are not members of a collective bargaining unit. An employee becomes eligible to participate in the Plan on their employment commencement date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was created July 16, 2010. Former employees of Alcan Composites were transferred into the Plan. The Plan was restated September 1, 2020, to include former Legacy Elmers division employees of Newell Brands. The Sponsor’s management team oversees governance of the Plan. They determine the appropriateness of the Plan’s investment offerings, monitor investment performance, and report to the Plan Sponsor.

**Contributions**

Each year, participants may contribute up to 100.00% of pre-tax annual compensation, as defined in the Plan. Participants may also contribute up to 100.00% of after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee contributions are not to exceed the Section 402(g) Internal Revenue Code (the IRC) limitation for the calendar year. Newly hired employees will be automatically enrolled in the Plan at a 6.00% deferral of their compensation unless they indicate a desire not to contribute or elect to enroll at a different percentage. Participants may also contribute amounts representing distributions from other qualified plans.

Participants are eligible to receive Company matching contributions on the employee’s employment commencement date. The 3A Composites matching contribution is equal to \$.50 cents on the dollar, up to 6.00% of the participant’s eligible compensation. The Baltek matching contribution is equal to \$.75 cents on the dollar, up to 6.00% of the participant’s eligible compensation.

Participants are also eligible to receive a discretionary profit-sharing contribution. For the years ended December 31, 2024 and 2023, the Company contributed 4.00% of eligible compensation for 3A Composites participants. The Baltek participants were excluded from this contribution.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers participants several different investment choices, including mutual funds, a money market fund, and a common/collective trust fund.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution, the Sponsor’s contribution, and an allocation of Plan earnings. Allocations are based on participant account balances and current contributions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100.00% vested in the Sponsor's matching contribution after two years of service. A participant is 100.00% vested in the Sponsor's profit-sharing contribution immediately.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50.00% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan terms range from one to five years, or up to fifteen years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with the prevailing prime rate plus 1.00%. Principal and interest are paid ratably through payroll deductions.

**Participant Loans - Defaulted**

Defaulted loans are loans resulting from the failure of a participant to make the required loan repayment on an outstanding loan. These loans are considered a distribution to the participant for which a Federal 1099 tax form is issued. For 2024, there were no defaulted loans.

**Payment of Benefits**

Upon separation of service due to death, disability, retirement or termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or substantially equal installments. If the participant's vested balance at termination of services is \$5,000 or less, the participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In-service withdrawals are allowed on attainment of age 59½. Participants may also withdraw their elective contributions in the case of financial hardship under guidelines promulgated by the Internal Revenue Service (IRS).

**Transfers from Union Plan**

Employees who change jobs with the Company that are no longer covered by a collective bargaining contract are eligible to participate in the Plan. Account balances of \$0 and \$900 were transferred into the Plan from another Company-sponsored 401(k) Plan during 2024 and 2023, respectively.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$426,301 and \$317,690, respectively. These accounts will be used to reduce future employer contributions. In 2024 and 2023, employer matching contributions were reduced by \$0 from forfeited non-vested accounts.

**Note 2 - Accounting Policies:**

**Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivables from participants are included in administrative expenses and charged directly to the participant's account.

**Note 3 - Income Tax Status:**

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself, and several amendments have been made to the Plan. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Note 4 - Plan Termination:**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100.00% vested in their employer contributions.

**Note 5 - Fair Value Measurements:**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust fund:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Money market fund:* Valued based on fair market value; this fund is based on cash held at year-end.

**Note 6 - Related Party Transactions:**

Certain Plan investments are shares of mutual funds, a money market fund, and the common/collective trust fund provided through Vanguard. Vanguard is the record-keeper and trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

Certain administrative costs incurred by the Plan are paid by the Sponsor. The total costs paid by the Sponsor were \$56,021 and \$54,978 for the years ended December 31, 2024 and 2023, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note 7 - Information Prepared and Certified by Trustee:**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard, the trustee of the Plan.

**Note 7 - Information Prepared and Certified by Trustee (Continued):**

During 2024 and 2023, the Plan held an interest in the Vanguard Retirement Savings Trust (VRST) III, a common/collective trust fund (CCT). The CCT invests solely in the VRST Master Trust. The underlying investments of VRST Master Trust are primarily in a pool of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by bond funds and trusts or wrap contracts. The CCT is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer of the wrap contract guarantees a minimum rate of return and provides full benefit responsiveness, provided that all terms of the wrap contract have been met. The fair value of the CCT equals the total of the fair value of the underlying assets plus the total wrap contract rebid value.

Certain events limit the ability of the Plan to transact at contract value with the wrap issuer. However, the Plan's management is not aware of the occurrence or likely occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants. The issuer may terminate a wrap contract for cause at any time.

**Note 8 - Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9 - Subsequent Events:**

Subsequent events were evaluated through October 7, 2025, which is the date the financial statements were available to be issued.
