INDEPENDENT AUDITOR'S REPORT

To the Trustees of
Matenaer Corporation 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Matenaer Corporation 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Matenaer Corporation 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Matenaer Corporation 401(k) Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 – Description of Plan

The following description of the Matenaer Corporation 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

A. Nature of the Plan

The Plan provides a defined contribution plan with elective deferral 401(k) and Roth 401(k) features covering eligible employees of Matenaer Corporation (the Company) over the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee of the plan is Fidelity Management Trust Company.

The Plan's federal identification number is 39-1744505 and the Plan number is 001.

B. Contributions

Each year, participants may contribute up to 100% of pretax annual compensation subject to the maximum deferral amount allowed by the IRS. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company match is discretionary. Matching contributions were 25% of the eligible participant's elective deferrals that do not exceed 10% of the participant's compensation for the year ended December 31, 2024.

C. Participant Accounts and Rollovers

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) Plan earnings, losses, and (c) forfeitures of terminated participant's nonvested accounts. Allocations of Plan earnings and losses are based on participant earnings or account balances, as defined, and allocations of Company contributions are based on participants' compensation, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan permits the transfer of funds from other qualified plans to a separate participant's rollover account.

D. Forfeitures

If a participant terminates employment, any non-vested Company contributions are forfeited when the participant incurs five consecutive 1 year breaks in service, or when the participant receives a distribution of their entire vested balance, whichever occurs first. The forfeited amounts can be used to reduce Company matching contributions or pay Plan expenses. For the year ended December 31, 2024, Plan expenses were reduced by \$15,919 from forfeited non-vested accounts. At December 31, 2024 and 2023, forfeited, non-vested accounts totaled \$6,046 and \$1,072, respectively.

E. Investment Options

Upon enrollment in the Plan, a participant may direct contributions in any of the investment options offered under the Plan. Additionally, participants can invest in the insurance company general account. Participants may change their investment options daily.

F. Vesting

Participants are immediately vested in their elective deferral contributions and rollover contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants become vested in the matching contribution and discretionary profit-sharing contribution in accordance with the following schedule:

G. Payments of Benefits

Upon termination of service due to death, disability, or retirement (age 65), a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, an in-service withdrawal of funds can be made for any reason after attainment of at least age 59 ½ years, provided certain conditions are met. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Mandatory distributions are required for all terminated employees with balances less than \$1,000.

H. Notes Receivable from Participants

Notes receivable from participants are not permitted.

NOTE 2 – Summary of Significant Accounting Policies

A summary of the Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements are as follows.

A. Method of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

NOTE 2 – Summary of Significant Accounting Policies (continued)

B. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive contracts, which are reported at contract value. The fair value of the registered investment companies is based on the fair value of their underlying assets as reported to the Plan by Fidelity Management Trust Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Payment of Benefits

Benefits are recorded when paid.

E. Administrative Expenses

Fidelity Workplace Services, LLC is the third-party administrator and Fidelity Management Trust Company and Matrix Trust Company are the custodians and trustees of the Plan. The custodians are responsible for investing and safekeeping all of the Plan assets. Costs of administering the Plan are paid by the Company and the Plan.

F. Subsequent Events

For the year ended December 31, 2024, the Company has evaluated subsequent events for potential recognition and disclosure through September 30, 2025, the date the financial statements were available for issuance.

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820-10, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 1 inputs were available to the Plan, so Level 2 and 3 inputs were not used.

Mutual funds are valued at the net asset value of the shares held by the Plan at year end as determined by quoted market prices.

The collective trust held by the Plan requires twelve months' notice for a complete liquidation, however the trustee, at their discretion, may waive the twelve month waiting period. Participant directed redemptions are allowed daily with no restrictions. There are no unfunded commitments.

The collective trust is valued at net asset value of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

NOTE 4 – Custodian's Certification and Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at year end, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company and Matrix Trust Company (the custodians of the Plan).

NOTE 5 – Fully Benefit-Responsive Investment Contract

The Plan has entered into a fully benefit-responsive investment contract with CMFG Life Insurance Company, which maintains the contributions in separate accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits at contract value. Contract value, as reported to the plan by CMFG Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$-0- and \$4,773, respectively.

NOTE 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, the Plan Agreement including all rights, titles, powers, duties, discretions and immunities imposed upon or reserved to the Trustee and the Company will continue in effect until all assets have been distributed by the Trustee as directed by the Company. Each Plan participant's amounts credited to their accounts will become 100% vested in the event the Plan is terminated.

NOTE 7 – Tax Status

The Plan has received a favorable determination from the Internal Revenue Service, which qualifies it for tax-exempt status. The Plan obtained its latest determination letter on July 29, 2020 in which the Internal Revenue Service stated that the Plan was in compliance with applicable requirements of the Internal Revenue Code and are, therefore, not subject to tax under present income tax law. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – Party-In-Interest Transactions

Parties-in-interest are defined under the Department of Labor's (DOL) Rules and Regulations as any fiduciary of the Plan, and party rendering services to the Plan, the Company, and certain others. Certain Plan investments are shares of mutual fund accounts managed by Fidelity Management Trust Company and Matrix Trust Company. As such, transactions conducted with Fidelity, Matrix, and the Company qualify as party-in-interest transactions.

NOTE 9 – Supplemental Schedule

Disclosures required by regulations include separate schedules of: (1) assets (held at end of year) and assets (acquired and disposed of within the year), (2) loans in default or uncollectible, (3) leases in default or uncollectible, (4) reportable transactions, (5) nonexempt transactions with parties in interest and (6) delinquent participant contributions.

Schedules 2, 3, 4, 5, and 6 are not included herein as they are not applicable to this Plan as of or for the year ended December 31, 2024.

NOTE 10 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

To the Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Matenaer Corporation 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

NOTE 1 – Description of Plan

The following description of the Matenaer Corporation 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

A. Nature of the Plan

The Plan provides a defined contribution plan with elective deferral 401(k) and Roth 401(k) features covering eligible employees of Matenaer Corporation (the Company) over the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee of the plan is Fidelity Management Trust Company.

The Plan's federal identification number is 39-1744505 and the Plan number is 001.

B. Contributions

Each year, participants may contribute up to 100% of pretax annual compensation subject to the maximum deferral amount allowed by the IRS. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company match is discretionary. Matching contributions were 25% of the eligible participant's elective deferrals that do not exceed 10% of the participant's compensation for the year ended December 31, 2024.

C. Participant Accounts and Rollovers

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) Plan earnings, losses, and (c) forfeitures of terminated participant's nonvested accounts. Allocations of Plan earnings and losses are based on participant earnings or account balances, as defined, and allocations of Company contributions are based on participants' compensation, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan permits the transfer of funds from other qualified plans to a separate participant's rollover account.

D. Forfeitures

If a participant terminates employment, any non-vested Company contributions are forfeited when the participant incurs five consecutive 1 year breaks in service, or when the participant receives a distribution of their entire vested balance, whichever occurs first. The forfeited amounts can be used to reduce Company matching contributions or pay Plan expenses. For the year ended December 31, 2024, Plan expenses were reduced by \$15,919 from forfeited non-vested accounts. At December 31, 2024 and 2023, forfeited, non-vested accounts totaled \$6,046 and \$1,072, respectively.

E. Investment Options

Upon enrollment in the Plan, a participant may direct contributions in any of the investment options offered under the Plan. Additionally, participants can invest in the insurance company general account. Participants may change their investment options daily.

F. Vesting

Participants are immediately vested in their elective deferral contributions and rollover contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants become vested in the matching contribution and discretionary profit-sharing contribution in accordance with the following schedule:

G. Payments of Benefits

Upon termination of service due to death, disability, or retirement (age 65), a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, an in-service withdrawal of funds can be made for any reason after attainment of at least age 59 ½ years, provided certain conditions are met. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Mandatory distributions are required for all terminated employees with balances less than \$1,000.

H. Notes Receivable from Participants

Notes receivable from participants are not permitted.

NOTE 2 – Summary of Significant Accounting Policies

A summary of the Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements are as follows.

A. Method of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

NOTE 2 – Summary of Significant Accounting Policies (continued)

B. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive contracts, which are reported at contract value. The fair value of the registered investment companies is based on the fair value of their underlying assets as reported to the Plan by Fidelity Management Trust Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Payment of Benefits

Benefits are recorded when paid.

E. Administrative Expenses

Fidelity Workplace Services, LLC is the third-party administrator and Fidelity Management Trust Company and Matrix Trust Company are the custodians and trustees of the Plan. The custodians are responsible for investing and safekeeping all of the Plan assets. Costs of administering the Plan are paid by the Company and the Plan.

F. Subsequent Events

For the year ended December 31, 2024, the Company has evaluated subsequent events for potential recognition and disclosure through September 30, 2025, the date the financial statements were available for issuance.

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820-10, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 1 inputs were available to the Plan, so Level 2 and 3 inputs were not used.

Mutual funds are valued at the net asset value of the shares held by the Plan at year end as determined by quoted market prices.

The collective trust held by the Plan requires twelve months' notice for a complete liquidation, however the trustee, at their discretion, may waive the twelve month waiting period. Participant directed redemptions are allowed daily with no restrictions. There are no unfunded commitments.

The collective trust is valued at net asset value of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

NOTE 4 – Custodian's Certification and Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at year end, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company and Matrix Trust Company (the custodians of the Plan).

NOTE 5 – Fully Benefit-Responsive Investment Contract

The Plan has entered into a fully benefit-responsive investment contract with CMFG Life Insurance Company, which maintains the contributions in separate accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits at contract value. Contract value, as reported to the plan by CMFG Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$-0- and \$4,773, respectively.

NOTE 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, the Plan Agreement including all rights, titles, powers, duties, discretions and immunities imposed upon or reserved to the Trustee and the Company will continue in effect until all assets have been distributed by the Trustee as directed by the Company. Each Plan participant's amounts credited to their accounts will become 100% vested in the event the Plan is terminated.

NOTE 7 – Tax Status

The Plan has received a favorable determination from the Internal Revenue Service, which qualifies it for tax-exempt status. The Plan obtained its latest determination letter on July 29, 2020 in which the Internal Revenue Service stated that the Plan was in compliance with applicable requirements of the Internal Revenue Code and are, therefore, not subject to tax under present income tax law. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – Party-In-Interest Transactions

Parties-in-interest are defined under the Department of Labor's (DOL) Rules and Regulations as any fiduciary of the Plan, and party rendering services to the Plan, the Company, and certain others. Certain Plan investments are shares of mutual fund accounts managed by Fidelity Management Trust Company and Matrix Trust Company. As such, transactions conducted with Fidelity, Matrix, and the Company qualify as party-in-interest transactions.

NOTE 9 – Supplemental Schedule

Disclosures required by regulations include separate schedules of: (1) assets (held at end of year) and assets (acquired and disposed of within the year), (2) loans in default or uncollectible, (3) leases in default or uncollectible, (4) reportable transactions, (5) nonexempt transactions with parties in interest and (6) delinquent participant contributions.

Schedules 2, 3, 4, 5, and 6 are not included herein as they are not applicable to this Plan as of or for the year ended December 31, 2024.

NOTE 10 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
