Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Oregon Tilth 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Oregon Tilth 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement and amendments for a more complete description of the Plan's provisions.

A. General

The Plan was established on 10/31/2005, by Oregon Tilth, Inc (the "Plan Sponsor"). The Plan was most recently amended and restated effective 1/1/2024, which resulted in no material changes to the Plan. The Plan is a defined contribution plan intended to qualify under Section 401(k) of the Internal Revenue Code ("IRC") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Oregon Tilth 401(k) Plan is a defined contribution retirement plan that excludes leased employees, certain union-represented employees, and non-resident aliens without U.S. source income. Employees become eligible to participate upon reaching age 21 and completing either 250 hours of service within a 3-month period or 1,000 hours within a 12-month period. Participation begins immediately once eligibility is met. The Plan features automatic enrollment at a 1% deferral rate with no auto-escalation. Eligible participants receive matching contributions equal to 100% of their deferrals, up to 4% of their compensation. Eligible employees begin participating immediately after which the employee meets the eligibility requirements set forth in the Plan.

B. Administration

The Plan is administered by the Plan Sponsor. Certain administrative functions are carried out by officers or employees of the Plan Sponsor, none of whom receive any compensation from the Plan for such services

C. Contributions

Contributions to the Plan consist of employee contributions. Additional amounts may be contributed at the option of the Company's board of directors. Participants direct the investment into various investment options offered by the Plan. All contributions are invested through the Matrix Trust company.

Contributions are subject to certain limitations. The limits include:

D. Participant Accounts

Each participant's account is credited with an allocation of the Company's contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

E. Vesting Schedule

Participants vest according to a schedule based on years of service. A year of service is credited for each plan year during 100% vested at five or more years of service. A participant becomes 100% vested at normal retirement, disability, or death.

F. Distribution of Benefits

Benefits under the Plan are distributable upon normal retirement at age 65 and termination of employment by reason of retirement, disability, death, or other separation from service. A participant will receive a lump sum amount equal to the value of the participant's vested interest in his or her account.

G. Participant Loans

Participant may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance on the participant's account. Loans must bear a reasonable rate of interest commensurate with local prevailing interest. Principal and interest are paid ratably through monthly payroll deductions.

H. Forfeited Accounts

Forfeitures stay under the Plan and are used to offset the next contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,847 and \$0, respectively. These accounts will be used to reduce future employer contributions.

I. Rollovers Contributions

Participants may elect to rollover amounts from other qualified plans or individual retirement accounts into the Plan, provided that certain conditions are met. As of December 31, 2024 and 2023, the Plan had participant rollovers amounting to \$248,840 and \$12,499 respectively.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

Basis of accounting refers to when revenues and expenditures or expenses are recognized in the accounts and reported in the financial statements. The financial statements have been prepared under the accrual basis of accounting. Revenues are recognized when they are earned, and expenses are recognized when they are incurred.

B. Use of Estimates

The preparation of the plan statements in conformity with U.S generally accepted accounting principles ("GAAP") requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period.

C. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the plan valuation policies utilizing information provided by investment advisors, custodians, and insurance company. See note 4 for a discussion of fair value measurements. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the plan at year-end. Investment contracts are valued at fair value, which is determined by the trustee.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis.

Management fees and operating expenses charged to the Plan for investment in mutual funds are reflected as a reduction of net assets in the Statement of Changes in Net Assets Available for Benefits.

D. Loans to Participants

Loans to participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024, and 2023, the outstanding balances are \$1,221 and \$19,377, with no defaulted loan.

E. Contributions

Contributions from employees and the employer are recorded in the period in which the employer transfers the funds to the Plan.

F. Distributions

Distributions requested by participants are recorded when paid.

G. Administrative Expenses

The Oregon Tilth 401(k) Plan may charge participants for certain administrative and transaction-related services. These charges, which may be deducted directly from participant accounts, are disclosed in accordance with the Department of Labor's 404(a)(5) participant fee disclosure requirements. Participants may incur fees for services such as post-termination distributions, required minimum distributions, hardship or in-service (non-hardship) withdrawals, and processing of qualified domestic relations orders (QDROs). In addition, if a participant takes a loan from the Plan, loan processing and ongoing maintenance fees may apply as outlined in the Plan's loan policy. All such fees are subject to the amounts disclosed in the Plan's 404(a)(5) participant fee notice and may change over time.

NOTE 3 - TAX STATUS

The Plan is intended to qualify under Section 401(k) of the Internal Revenue Code (IRC), and the Plan administrator believes the Plan has been designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Organization has taken an uncertain tax position that is more likely than not to be sustained upon examination by the federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

NOTE 4 - INFORMATION CERTIFIED BY THE TRUSTEE

Oregon Systems has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rule and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Matrix Trust company, a qualified institution, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments and notes receivable from participants as reported on the Statements of Net Assets Available for Benefits as of December 31, 2024;
- Net investment gain and interest income on notes receivable from participants as shown on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024;

At the request of the Oregon, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 5 - FAIR VALUE MEASUREMENTS

The Internal Revenue Service has determined that the form of the Plan and related trust are designed by applicable section 401 of the Internal Revenue Code (IRC). The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 5 - FAIR VALUE MEASUREMENTS - CONT'D

Level 3-Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds: Values at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There were no Level 2,3 assets as of December 31, 2024 and 2023.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants will become 100% vested in their accounts in the event of Plan termination.

NOTE 7 - PARTY-IN-INTEREST TRANSACTION

Certain Plan investments are managed by the Matrix Trust company. Matrix Trust company is the trustee as defined by the Plan, and therefore, these transactions are recognized as exempt party-in-interest transactions.

Participant loans are considered exempt party-in-interest transactions as defined by ERISA.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 9 - ERISA FIDELITY BOND

In accordance with ERISA Section 412, Plan covers a fidelity bond intended to protect Plan from the risk of loss due to fraud or dishonesty on the part of persons who handle funds or other property on behalf of the Plan.

NOTE 10 - SUBSEQUENT EVENTS

The management evaluated all subsequent events through October 03, 2025, the date on which the financial statements were available to be issued, and have determined that no adjustments are necessary to the amounts reported in the accompanying financial statements, nor have any subsequent events occurred, the nature of which would require disclosure.




Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Oregon Tilth 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement and amendments for a more complete description of the Plan's provisions.

A. General

The Plan was established on 10/31/2005, by Oregon Tilth, Inc (the "Plan Sponsor"). The Plan was most recently amended and restated effective 1/1/2024, which resulted in no material changes to the Plan. The Plan is a defined contribution plan intended to qualify under Section 401(k) of the Internal Revenue Code ("IRC") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Oregon Tilth 401(k) Plan is a defined contribution retirement plan that excludes leased employees, certain union-represented employees, and non-resident aliens without U.S. source income. Employees become eligible to participate upon reaching age 21 and completing either 250 hours of service within a 3-month period or 1,000 hours within a 12-month period. Participation begins immediately once eligibility is met. The Plan features automatic enrollment at a 1% deferral rate with no auto-escalation. Eligible participants receive matching contributions equal to 100% of their deferrals, up to 4% of their compensation. Eligible employees begin participating immediately after which the employee meets the eligibility requirements set forth in the Plan.

B. Administration

The Plan is administered by the Plan Sponsor. Certain administrative functions are carried out by officers or employees of the Plan Sponsor, none of whom receive any compensation from the Plan for such services

C. Contributions

Contributions to the Plan consist of employee contributions. Additional amounts may be contributed at the option of the Company's board of directors. Participants direct the investment into various investment options offered by the Plan. All contributions are invested through the Matrix Trust company.

Contributions are subject to certain limitations. The limits include:

D. Participant Accounts

Each participant's account is credited with an allocation of the Company's contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

E. Vesting Schedule

Participants vest according to a schedule based on years of service. A year of service is credited for each plan year during 100% vested at five or more years of service. A participant becomes 100% vested at normal retirement, disability, or death.

F. Distribution of Benefits

Benefits under the Plan are distributable upon normal retirement at age 65 and termination of employment by reason of retirement, disability, death, or other separation from service. A participant will receive a lump sum amount equal to the value of the participant's vested interest in his or her account.

G. Participant Loans

Participant may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance on the participant's account. Loans must bear a reasonable rate of interest commensurate with local prevailing interest. Principal and interest are paid ratably through monthly payroll deductions.

H. Forfeited Accounts

Forfeitures stay under the Plan and are used to offset the next contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,847 and \$0, respectively. These accounts will be used to reduce future employer contributions.

I. Rollovers Contributions

Participants may elect to rollover amounts from other qualified plans or individual retirement accounts into the Plan, provided that certain conditions are met. As of December 31, 2024 and 2023, the Plan had participant rollovers amounting to \$248,840 and \$12,499 respectively.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

Basis of accounting refers to when revenues and expenditures or expenses are recognized in the accounts and reported in the financial statements. The financial statements have been prepared under the accrual basis of accounting. Revenues are recognized when they are earned, and expenses are recognized when they are incurred.

B. Use of Estimates

The preparation of the plan statements in conformity with U.S generally accepted accounting principles ("GAAP") requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period.

C. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the plan valuation policies utilizing information provided by investment advisors, custodians, and insurance company. See note 4 for a discussion of fair value measurements. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the plan at year-end. Investment contracts are valued at fair value, which is determined by the trustee.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis.

Management fees and operating expenses charged to the Plan for investment in mutual funds are reflected as a reduction of net assets in the Statement of Changes in Net Assets Available for Benefits.

D. Loans to Participants

Loans to participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024, and 2023, the outstanding balances are \$1,221 and \$19,377, with no defaulted loan.

E. Contributions

Contributions from employees and the employer are recorded in the period in which the employer transfers the funds to the Plan.

F. Distributions

Distributions requested by participants are recorded when paid.

G. Administrative Expenses

The Oregon Tilth 401(k) Plan may charge participants for certain administrative and transaction-related services. These charges, which may be deducted directly from participant accounts, are disclosed in accordance with the Department of Labor's 404(a)(5) participant fee disclosure requirements. Participants may incur fees for services such as post-termination distributions, required minimum distributions, hardship or in-service (non-hardship) withdrawals, and processing of qualified domestic relations orders (QDROs). In addition, if a participant takes a loan from the Plan, loan processing and ongoing maintenance fees may apply as outlined in the Plan's loan policy. All such fees are subject to the amounts disclosed in the Plan's 404(a)(5) participant fee notice and may change over time.

NOTE 3 - TAX STATUS

The Plan is intended to qualify under Section 401(k) of the Internal Revenue Code (IRC), and the Plan administrator believes the Plan has been designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Organization has taken an uncertain tax position that is more likely than not to be sustained upon examination by the federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

NOTE 4 - INFORMATION CERTIFIED BY THE TRUSTEE

Oregon Systems has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rule and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Matrix Trust company, a qualified institution, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments and notes receivable from participants as reported on the Statements of Net Assets Available for Benefits as of December 31, 2024;
- Net investment gain and interest income on notes receivable from participants as shown on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024;
- Investment amounts included in the Notes to Financial Statements;
- All investment information included in the Supplemental Schedule of Assets (Held at End of Year) - As of December 31, 2024.

At the request of the Oregon, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 5 - FAIR VALUE MEASUREMENTS

The Internal Revenue Service has determined that the form of the Plan and related trust are designed by applicable section 401 of the Internal Revenue Code (IRC). The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 5 - FAIR VALUE MEASUREMENTS - CONT'D

Level 3-Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds: Values at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There were no Level 2,3 assets as of December 31, 2024 and 2023.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants will become 100% vested in their accounts in the event of Plan termination.

NOTE 7 - PARTY-IN-INTEREST TRANSACTION

Certain Plan investments are managed by the Matrix Trust company. Matrix Trust company is the trustee as defined by the Plan, and therefore, these transactions are recognized as exempt party-in-interest transactions.

Participant loans are considered exempt party-in-interest transactions as defined by ERISA.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 9 - ERISA FIDELITY BOND

In accordance with ERISA Section 412, Plan covers a fidelity bond intended to protect Plan from the risk of loss due to fraud or dishonesty on the part of persons who handle funds or other property on behalf of the Plan.

NOTE 10 - SUBSEQUENT EVENTS

The management evaluated all subsequent events through October 03, 2025, the date on which the financial statements were available to be issued, and have determined that no adjustments are necessary to the amounts reported in the accompanying financial statements, nor have any subsequent events occurred, the nature of which would require disclosure.
