Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedules Required by ERISA**

The supplemental Schedule H, Line 4a-Schedule of Delinquent Participant Contributions and Schedule H, Line 4i-Schedule of Assets (Held at End of Year) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that

agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. Description of Plan**

The following brief description of Dondlinger & Sons Construction Co., Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan sponsored by Dondlinger & Sons Construction Co., Inc. and its affiliates (Company) for the benefit of its employees who have at least three months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors has assigned oversight of the Plan to the Trustees. The Trustees determine the appropriateness of the Plan's investment offerings, monitor investment performance and report to the Company's Board of Directors, as appropriate.

The Plan was established on September 1, 1991, and was most recently restated effective January 1, 2021 to incorporate recent legislative and regulatory changes. The Plan was amended effective January 1, 2024, to allow Roth 401(k) contributions.

***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 75% of their eligible compensation, as defined by the Plan. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation. The Company makes matching contributions of 25% of employees' salary deferral amounts up to the first 4% of employees' compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

***Participant Accounts***

Each participant has the option of directing his or her contributions into any of the various investment options offered by the Plan and may change the allocation daily. Participants who do not make an affirmative election have their contributions invested in a designated target-date fund until changed by the participant.

Each participant's account is credited with the participant's contributions, the Company's contributions and plan earnings and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participant's vesting in the Company contributions plus earnings thereon is based on years of continuous service per the following table. Participants may also become fully vested upon death or disability as defined by the Plan.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms may not exceed 5 years, and are secured by the balance in the participant's account. The loan interest rate, determined at the time of loan origination, is set at 2 percent above the prime rate, as defined. Principal and interest is payable ratably through weekly payroll deductions.

***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum payment in an amount equal to the value of the vested interest in their account. If a participant's vested balance, excluding rollovers, is greater than \$5,000, any distribution must be approved by the participant (with his/her spouse's consent, if required) and may be paid in a lump sum or in installments over a specified period of time subject to required minimum distributions. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan also allows for in-service distributions from the vested balance when a participant reaches age 62, which is the Plan's normal retirement age.

***Forfeited Accounts***

Forfeited nonvested accounts totaled \$13,101 for the year ended December 31, 2024. These amounts may be used to pay plan expenses or applied to employer contributions. For the year ended December 31, 2024, employer contributions were reduced by \$12,471 from forfeited nonvested accounts. The balance remaining in the forfeiture account as of December 31, 2024 and 2023, totaled \$639 and \$26, respectively.

***Administration of the Plan***

The Plan's assets are held in a group annuity contract provided and administered by Principal Life Insurance Company and its affiliated entities (Principal). Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**2. Summary of Significant Accounting Policies**

***Basis of Presentation***

The financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies utilizing information provided by Principal. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Participant loans are reclassified as distributions if an outstanding balance exists at the time of the participant's termination. Related fees are recorded as administrative expenses and are expensed when incurred.

***Payment of Benefits***

Benefits are recorded when paid. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not been paid, as of December 31, 2024.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**3. Information Certified by Asset Custodians (Unaudited)**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the asset custodians have certified that the following data included in the financial statements and the supplemental Schedule H, Line 4i-Schedule of Assets (Held at End of Year) is complete and accurate.

The following information was certified by Principal Life Insurance Company and Principal Trust Company, the asset custodians, as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments presented in Schedule H, Line 4i – schedule of assets (held at end of year) as of December 31, 2024.

**4. Investments/Fair Value Measurements**

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**5. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments include shares of mutual funds and investment contracts managed by Principal. Principal is a custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Principal also provides third party administration and recordkeeping services to the Plan which qualify as exempt party-in-interest transactions. The Plan incurred fees directly from Principal totaling \$29,855 for the year ended December 31, 2024. Other fees related to the Plan's operations may be paid by the Company on behalf of the Plan.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100 percent vested in their employer accounts.

**7. Tax Status**

The Plan operates under a standardized adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust sponsored by Hinkle Law Firm, LLC. This prototype plan document has been filed with the appropriate agency and has obtained its latest determination letter from the Internal Revenue Services (IRS), dated June 30, 2020, stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore believe the Plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**9. Delinquent Participant Contribution**

During the year ended December 31, 2024, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. A participant loan repayment in the amount of \$52 was withheld on January 23, 2024, but was not remitted to the Plan until May 10, 2024. The Company determined the amount of lost earnings and remitted them to the Plan on October 2, 2025.

**10. Subsequent Events**

The Company has evaluated subsequent events through October 6, 2025, the date which the financial statements were available to be issued.
