Note 1. Description of the Plan

The following description of Southeastern Spine Institute 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan and covering substantially all employees of Southeastern Spine Institute, LLC (collectively known as the "Company"), but does exclude union employees and non-resident aliens. Employees are automatically enrolled at a 3% deferral rate in the Plan after completing 3 months of service following their employment commencement date and will be entered into the plan on the 1st day ending after the quarter ending in March, June, September, December. To participate in the nonelective employer contributions, the employee must have one year of service of at least 1,000 hours. The Plan was restated April 7, 2023 under IRS Cycle 3 restatement for defined contribution plans. The plan was amended on June 3, 2023 to change the name of the plan from Spine Management, LLC 401(k) Profit Sharing Plan to Southeastern Spine Institute 401(k) Profit Sharing Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - Each year, participants may contribute a percentage between 0% and 100% of their pretax and after-tax compensation, as defined by the Plan, not to exceed the annual limits as defined by the Internal Revenue Code. Participants who have attained the age of 50 before the end of the year are eligible to make catch-up contributions. Participants may contribute amounts representing rollover distributions from other qualified plans. Participants direct the investment of their contributions into various investment options and participants may change their allocations among the various investment options at any time.

The Company provides safe harbor contributions equal to 3% of compensation. The Company did not make a discretionary nonelective contributions for year ended December 31, 2024. During the year ended December 31, 2024, the employer safe harbor contribution and the employer discretionary profit sharing contributions were \$305,626.

Vesting - Plan participants are always 100% vested in elective deferrals including Roth 401(k) deferrals and catch-up contributions, rollover contributions and safe harbor contributions. Discretionary nonelective contributions and any earnings thereon will be vested in accordance with the following schedule:

Note 1. Description of the Plan (continued)

Participant Accounts - Each participant's account is credited with the participant's contributions, Company discretionary nonelective contributions, rollover contributions, safe harbor contributions, and earnings, and is charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers money market funds, mutual funds, and self-directed brokerage accounts as investment options for participants.

Forfeitures - Forfeitures represent the non-vested portion of employer contributions that are forfeited by participants upon termination of employment before becoming fully vested. In accordance with the provisions of the Plan, forfeitures may be used to reduce future employer contributions, pay plan expenses, or be reallocated to participants. During the years ended December 31, 2024 and 2023 respectively, forfeitures in the amount of \$0 and \$6,000 were used to reduce employer contributions or pay plan expenses. As of December 31, 2024 and 2023 the balance of unallocated forfeitures available for future use was \$24,332 and \$1,737.

Notes Receivable from Participants - Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50 percent of their account balances, whichever is less. The source of the loaned funds is restricted to the portion of the non-forfeitable account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined appropriate by the plan administrator. Principal and interest are paid ratably through payroll deductions over a period of not more than 5 years, unless a principal residence was purchased and repayment terms then can be deemed by the administrator.

Payment of Benefits - Payment of benefits from a participant's account may be made only for the following reasons: termination of employment, financial hardship, in-service at 59^{1/2}, retirement, early retirement at age 55 and 5 years of service, qualified reservist, death or disability. Upon occurrence of one of these events and upon election of the participant, the Plan will distribute to the participant 100% of the participant's vested account balance. A participant may receive lump sum amount equal to the value to the participant's vested interest in his or her account. The Plan Sponsor may elect to distribute funds to terminated participants through the mandatory involuntary cash-out provision, for account balances between \$1,000 and \$5,000; amounts will be rolled over to an individual retirement account on behalf of the participant and for any account balances less than \$1,000; amounts will be paid directly to the participant.

Recordkeeping and Investment Expenses - The Plan's fees and expenses are paid either by the Plan or the Plan Sponsor as provided by the Plan document.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting - The accompanying financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States.

Payment of Benefits - Benefits paid to participants are recorded when paid.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Use of Estimates - The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States requires that the Plan administrator make estimates and use assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates. The Plan administrator is not aware of any condition or event that is likely to severely affect its estimates in the near-term.

Administrative Expenses—Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Investments are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair market value of investments for such investments.

Contributions - Contributions from Plan participants are recorded in the year in which the employee contributions are withheld and the matching contributions from the Employer are recorded in the year in which participant compensation is earned.

Note 3. Information Prepared by and Certified by the Trustee

As permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA, and as instructed by the Plan administrator, no audit procedures have been performed on certain information certified as complete and accurate by the Fidelity Management Trust Company, (“the Trustee”), except to compare such information to the information included in the accompanying financial statements and supplemental schedule. Information certified by the Trustee includes investments and notes receivable from participants included in the Statements of Net Assets Available for Benefits at December 31, 2024 and 2023, investment related income and interest on notes receivable from participants as included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and investments included in the Schedule of Assets (Held at End of Year).

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by the observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Money Market Funds: Valued at the reported amount on deposits held by the plan at year end.

Mutual Funds – Mutual funds are registered investment companies that pool the funds of multiple investors into a portfolio. The fund offers shares of the portfolio, which an investor may redeem for current value (NAV, or net asset value) of the fund’s assets through a public market.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds, money market funds and common stocks that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as an international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 6. Income Tax Status

The Plan has timely adopted a restated, non-standard defined contribution pre-approved plan 401(k) profit sharing plan. The non-standardized defined contribution pre-approved plan has received an advisory letter from the IRS dated June 30, 2020, whereby the IRS stated that the non-standardized defined contribution pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). While the Plan cannot rely on the non-standardized defined contribution pre-approved plan advisory letter, the Plan administrator believes that the Plan has been operated in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be substantiated upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Plan Termination

The Company reserves the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In connection with the Company's decision to transition employees out of the 401(k) Plan during the upcoming years, participants will become fully vested in their accounts and arrangements will be made for all account balances to be distributed or transferred in accordance with applicable regulations.

Note 8. Exempt Party-In-Interest Transactions

Fees related to the administration of notes receivable from participants, distributions and rollovers are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 9. Plan Amendments

Effective January 1, 2022, the plan was amended on December 9, 2024 to include HSA Contributions to be included in Compensation for all sources of contributions

Note 11. Prohibited Transactions

During the plan year ended December 31, 2023, the Plan Sponsor did not remit to the plan's trust certain employee contributions including loan repayments totaling \$19,694 within the period prescribed by Department of Labor regulations. Delays in remitting contributions to the trust were due to administrative errors, and the Plan Sponsor intends to calculate lost earning and make corrections to the affected participants' accounts. Plan management has not corrected these late deposits in accordance with U.S. Department of Labor and/or Internal Revenue Service guidelines.

Management corrected late deposits, restored lost earnings, and filed the Form 5330 during the year ended December 31, 2024.

Note 12. Subsequent Events

The Plan has evaluated subsequent events through the September 9, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, Novant Health acquired substantially all of the assets of Company, excluding cash and accounts receivable as of December 31, 2024. Company retained all liabilities, including those related to the Plan. The Plan was not merged into Novant's 403(b) Plan and the employees of company as of December 31, 2024, who became Novant employees, were given an option to transfer their account balances into the Novant 403(b) Plan.
