Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Sparrow Health System Associate Retirement Plan for 403(b) Transfers (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Sparrow Health System Associate Retirement Plan for 403(b) Transfer's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

1. Description of Plan

The following brief description of the Sparrow Health System Associate Retirement Plan for 403(b) Transfers (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan covering employees (caregivers) of the Sparrow Health System and certain affiliated entities, including Edward W. Sparrow Hospital Association and Sparrow Community Care, (collectively referred to as the Company) who are not eligible to participate in certain qualified cash or deferred arrangements of the participating employers. The Plan was amended December 18, 2012, with an effective date of January 1, 2013, to merge the Sparrow Health System 403(b) Savings Plan into the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective April 1, 2023, Sparrow Health System finalized a partnership with University of Michigan Health System. Effective April 1, 2024, Sparrow is doing business as University of Michigan Health – Sparrow.

Based on changes to the Company's non-ERISA 403(b) plans effective in 2024, certain participants from these Company sponsored non-ERISA 403(b) plans have transferred their contracts to this Plan in 2024, in accordance with plan provisions. In 2024, approximately \$5,800,000 has been transferred into the Plan related to these participants.

Contributions

The Plan provides for elective deferral contributions by caregivers subject to the dollar limitation contained in the Internal Revenue Code (Code) Section 402(g). The Plan also allows catch up contributions for participants age 50 or over.

Participant Accounts

Each participant's account is credited with the participant's contributions and plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings and expenses, or account balances, as defined. Participant contributions are invested in various investment options offered by the Plan as directed by the participant and allocated to each participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon.

Payment of Benefits

Participants are eligible to receive distributions upon reaching normal retirement age of 65, termination, or separation due to death or disability. In-service distributions are also allowed upon attaining age 59 1/2. Hardship withdrawals are also permitted for certain qualifying reasons, not to exceed the immediate and heavy financial need. Benefits are paid as lump-sum amounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except the fully benefit responsive contract. The fair values of mutual fund investments and personal choice retirement accounts (self-directed investments) are determined by obtaining quoted prices on nationally recognized securities exchanges.

The fully benefit-responsive contract consists of interest in the Transamerica Guaranteed Investment Option which is a group annuity contract that is considered a traditional investment contract. The contract value is determined based on contributions plus interest credited, minus withdrawals. The contract guarantees a fixed rate of interest and is backed by the general account assets of Transamerica Life Insurance Company. The contract has certain withdrawal restrictions including a restriction upon contract discontinuance that allows money to be withdrawn subject to a market value adjustment (MVA) or according to a withdrawal schedule. Withdrawal restrictions could also apply upon a merger, layoffs, bankruptcy, the creation of competing funds within the Plan, and various other events defined in the contract between the Plan and the fund.

These withdrawal restrictions are not probable of occurring. Participant withdrawals can be taken without a MVA for hardship, death, retirement, disability, in-service withdrawals, loans, transfers to a non-competing fund, or separation from service. Participant-initiated elective withdrawals may be limited to a percentage of the contract or subject to a 90-day provision.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Any revenue-sharing generated by an investment fund is reallocated to the fund for the benefit of Plan participants investing in the fund, net of amounts paid to National Financial Services, a securities broker.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain administrative and professional fees are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets available for benefits and changes therein. Actual results could differ from those estimates.

Subsequent Events

Plan management has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.

3. Investments – Unaudited Information

Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value and the fully benefit-responsive contract at contract value held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by State Street Bank and Trust Company (State Street), the trustee of the Plan. This certified information has not been audited by independent auditors.

4. Parties-in-Interest

Parties-in-interest are defined under the Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, the auditor, and certain others. The Plan holds investments managed by Transamerica Capital, Inc., Transamerica Life Insurance Company, and State Street (affiliates of Transamerica Retirement Solutions) and Charles Schwab Institutional (a securities broker for the Plan). Transamerica Retirement Solutions (Transamerica) is the Plan recordkeeper and State Street is the trustee of the Plan. Therefore, these are considered party-in-interest investments. Fees of \$38,557 were paid by the Plan to Transamerica during 2024 (\$8,765 in 2023). Indirect compensation in the form of revenue sharing was paid to National Financial Services in 2024 and 2023.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan document to terminate the Plan at any time, subject to the provisions of ERISA.

6. Tax Status

The Plan adopted a volume submitter 403(b) plan document sponsored by Transamerica. The Internal Revenue Service issued an opinion letter March 31, 2017 indicating that the volume submitter plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Code. Although the Plan has been amended since receiving the opinion letter, Plan management believes the Plan is designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally, tax years 2021 through the current year remain open to examination. Plan management does not believe that the results from any examination of these open years would have a material effect on the Plan.

7. Fair Value Measurements

As defined in current authoritative guidance, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In determining fair value, the Plan uses various methods including market, income, and cost approaches. Based on these approaches, the Plan often utilizes certain assumptions that market participants would use in pricing the asset or liability, including assumptions about risk and/or the risks inherent in the inputs to the valuation technique. These inputs can be readily observable, market corroborated, or generally unobservable inputs.

7. Fair Value Measurements (continued)

The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques, the Plan is required to provide information according to the fair value hierarchy. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values. Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

- Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.
- Level 2 – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 – Significant unobservable inputs that reflect a Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

For the years ended December 31, 2024 and 2023, the application of valuation techniques applied to similar assets and liabilities has been consistent.

The Plan believes its valuation methods are appropriate and consistent with other market participants. The use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
