Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of B. Fernández & Hnos., Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 - Description of the plan

The following description of the B. Fernández & Hnos., Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all employees of B. Fernández & Hnos., Inc., Pan Pepín, Inc. and Marvel International, Inc., who have completed six months of service. The Plan sponsor is B. Fernández & Hnos., Inc., (the "Sponsor" or the "Company"). The Company's Employee Benefit Plan Committee controls and manages the operation and administration of the Plan. B. Fernández & Hnos., Inc. serves as the trustee of the Plan. Empower Trust Company, LLC (the "Custodian") holds the Plan's assets and executes investment transactions. The Plan is qualified under the provisions of Section 1081.01 of the Internal Revenue Code of Puerto Rico (the Code), as amended, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan amendment

Effective January 1, 2023, the Company amended the Plan to change the eligibility service requirements from 12 month and 21 years old to 6 months and no minimum age requirement.

Further resolved, that the Company amended the Plan effective as soon as administrative possible on or after January 1, 2024, to include an auto enrollment feature as described in the Plan's Adoption Agreement, for employees hire after January 1, 2024.

Contributions

Each year, participants may contribute an amount of their compensation, as defined in the Plan, not exceeding the maximum deferral specified by local law. The Sponsor contributes .50 cents for each dollar of a participant's matchable contributions. However, the Sponsor will not make matching contributions on matchable contributions that exceed 6% of the participant's compensation during any matching period. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Notes to Financial Statements – (Continued)

December 31, 2024 and 2023

Note 1 - Description of the plan – (continued)

Participant accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Sponsor's matching contribution, and allocations of the Sponsor's discretionary contributions, forfeitures of Sponsor's contributions and Plan earnings, and charged with withdrawals and allocation of Plan losses and administrative expenses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon and in the Sponsor's contribution portion.

Investments

The Sponsor's and participants' contributions are invested in various participant directed investment funds provided by the Custodian, as permitted in the Trust Agreement.

Notes receivable from participants

Notes receivable from participants are not permitted.

Payment of benefits

On termination of service due to death, disability or retirement, a participant or his/her beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or periodic installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures accounts

Upon participant's termination from employment or withdrawal from the Plan for any reason other than death, retirement or disability, the employer contributions on behalf of the participants not then vested are forfeited. At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$12,037 and \$16,752, respectively. These accounts shall be used to reduce future Company contributions and to reduce the Plan's administrative expenses.

Note 2 - Summary of accounting policies

Following are the significant accounting policies followed by the Plan:

Basis of accounting and presentation

The accompanying financial statements have been prepared in an accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative expenses

Administrative expenses of the Plan, unless paid by the Company, will be paid from the trust fund and will be charged against participant's account.

Note 2 - Summary of accounting policies – (continued)

Payment of benefits

Benefits payments to participants are recorded upon distribution.

Plan termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Benefits payable

Plan accounts for benefits payable in accordance with the guidance provided by the AICPA Audit and Accounting Guide, Audits of Employee Benefit Plans. This guidance requires that benefits payable to persons who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as a liability of the Plan. As of December 31, 2024 and 2023, net assets available for benefits include benefits payable of nil and \$227,511, respectively, due to participants who withdrew from their participation in the Plan.

Note 3 - Information Certified by Custodian (Unaudited)

The plan administrator has elected the method of compliance permitted by Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian of the Plan, Empower Trust Company, LLC, (the Custodian), has certified as to the completeness and accuracy of all investment related information reflected in the accompanying financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024, and the related notes to the financial statements, and the Schedule H, Part IV, Line 4i - Schedule of Assets (held at end of year) as of December 31, 2024. The Custodian maintains all records, executes investment transactions, and holds all the assets of the Plan.

The Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciation in value by \$1,787,294 during the year ended December 31, 2024.

Note 4 - Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) No. 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair values.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active market that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds are valued at the net asset value of shares held by the Plan at year end.

Fixed annuities are valued based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable values. Furthermore, although the plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During the year ended December 31, 2024, the Plan Sponsor remitted participant's contributions to the Plan in a timely manner, as defined by the Department of Labor's Rules and Regulations. However, during the years ended December 31, 2023, 2022, 2021, 2019, and 2018 the Plan Sponsor did not remit certain participant contributions to the Plan in a timely manner, amounting to \$1,734, \$8,215, \$6,597, \$29,449 and \$3,308, respectively.

Note 7 - Income taxes

The plan constitutes a qualified plan exempt from income taxes under the provision of Section 1081.01 of the Internal Revenue Code for a New Puerto Rico (the Code), as amended.

The plan obtained its latest determination letter on July 23, 2015, in which the Commonwealth of Puerto Rico tax authorities stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code.
