Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Sparrow Health System Affiliate 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Sparrow Health System Affiliate 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

1. Plan Description

The following brief description of the Sparrow Health System Affiliate 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

Effective January 1, 1989, Mid-Michigan Physicians, P.C. implemented a defined contribution plan. Mid-Michigan Physicians, P.C. was acquired by Sparrow Development, Inc. (Company) effective June 1, 1991. The Plan was amended and adopted as the Sparrow Development, Inc. Employee Deferred Compensation Plan effective as of June 1, 1991. The plan was restated effective July 1, 2000 and adopted as the Sparrow Health System Affiliate 401(k) Plan. The Plan covers employees (caregivers) of the following entities: Physicians Health Plan, Inc. (formerly Physicians Health Plan of Mid-Michigan); MAC Restaurant, LLC; and East Lansing Athletic Club, Inc. (d/b/a Michigan Athletic Club). Effective December 18, 2011, all caregivers of Sparrow Development, Inc. and Pharmacy Plus, Inc. became caregivers of Sparrow Community Care and are therefore no longer eligible to participate in the Plan. The Plan was restated on January 1, 2021, becoming a multiple employer Plan, as Physicians Health Plan ceased to be in the same controlled group. The Plan was subsequently amended effective, January 1, 2022, to remove Physicians Health Plan as a participating employer and remove the multiple employer plan election. Physicians Health Plan has announced its intention to cease operations by December 31, 2025.

Effective April 1, 2023, Sparrow Health System finalized a partnership with University of Michigan Health System. Effective April 1, 2024, Sparrow is doing business as University of Michigan Health – Sparrow.

During 2025, an amendment is planned to allow the merger of the Plan into the Sparrow Health System Associate Retirement Savings Plan. The assets and participant balances are expected to be merged in 2026.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The terms of the Plan are intended to comply with the Internal Revenue Code (Code) Sections 401(a) and 401(k) and the Treasury regulations issued thereunder in order that the trust may qualify as a tax-exempt, profit-sharing trust under Code Section 501(a).

1. Plan Description (continued)

Eligibility

A caregiver shall become eligible to participate on the first day of the month thereafter coinciding with, or next following, the date upon which the caregiver attains age 18 and one year of service (501 hours). Leased caregivers, caregivers hired prior to July 1, 2007 who were eligible to participate in another defined contribution plan on or after July 1, 2007 sponsored by the Company, caregivers hired by Physician Health Plan on or after July 1, 2007, and effective January 1, 2022, any employee employed with Physician Health Plan, are excluded from the Plan.

Contributions

The Plan provides for elective deferral contributions by caregivers subject to the dollar limitations contained in Code Section 402(g). The Plan also allows catch up contributions for participants age 50 or over.

Payment of Benefits

Participants are eligible to receive distributions upon reaching normal retirement age of 65, termination, or separation due to death or disability. In-service distributions are also allowed upon attaining age 59 ½. Benefits are paid as a lump-sum amount equal to the value of the account or a direct transfer to another plan that satisfies the requirements of Code Section 401(a). Hardship withdrawals are permitted if the participant has already taken all available non-taxable loans and other available in-service withdrawals.

Loans to Participants

Plan management may direct the trustee to make a loan or loans to a participant. Important Plan provisions include:

- The period of repayment shall not exceed five years. If the loan is used to acquire, construct, reconstruct, or substantially rehabilitate a dwelling that is to be used within a reasonable time as the principal residence of the participant or a member of his/her family, the repayment period shall be determined by the Plan's management and trustee, but will not exceed 30 years.
- Each loan shall be made against collateral including the assignment of the borrower's entire right, title, and interest in and to the Plan, supported by the borrower's collateral promissory note for the amount of the loan.

Loans to Participants (continued)

- Each loan shall be charged interest at a rate commensurate with the rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate will be the prime rate as stated in the Wall Street Journal, plus 2%.
- The amount of the participant's or beneficiary's loan from this Plan and all other outstanding balances of all other loans from the Plan shall not exceed the lesser of (a) \$50,000 or (b) 50% of the participant's or beneficiary's account balance.

Participant Accounts

Participant contributions are invested in various investments offered by the plan as directed by the participant and allocated to each participant's account. Earnings and expenses are allocated based on the participant's account balance.

If a caregiver was a participant prior to January 1, 1992, such participant may also have employer contribution accounts derived from employer matching and discretionary contributions. Each participant is 100% vested in these accounts.

The benefit to which a participant is entitled is based on the value of the participant's elective deferral account and, if applicable, employer contribution accounts.

Vesting

Each participant is 100% vested in his or her elective deferrals and, if applicable, employer contributions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except the fully benefit-responsive contract. The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges.

The fully benefit-responsive contract consists of interest in the Transamerica Guaranteed Investment Option which is a group annuity contract that is considered a traditional investment contract. The contract value is determined based on contributions plus interest credited, minus withdrawals. The contract guarantees a fixed rate of interest and is backed by the general account assets of Transamerica Life Insurance Company. The contract has certain withdrawal restrictions including a restriction upon contract discontinuance that allows money to be withdrawn subject to a market value adjustment (MVA) or according to a withdrawal schedule.

Withdrawal restrictions could also apply upon a merger, layoffs, bankruptcy, the creation of competing funds within the Plan, and various other events defined in the contract between the Plan and the fund. These withdrawal restrictions are not probable of occurring. Participant withdrawals can be taken without a MVA for hardship, death, retirement, disability, in-service withdrawals, loans, transfers to a non-competing fund, or separation from service. Participant-initiated elective withdrawals may be limited to a percentage of the contract or subject to a 90-day provision.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Any revenue-sharing generated by an investment fund is reallocated to the fund for the benefit of Plan participants investing in the fund, net of amounts paid to National Financial Services, a securities broker.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Upon a distributable event, delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses

Administrative expenses are paid by the Plan or Edward W. Sparrow Hospital Association, an affiliated entity of the participating employers of the Plan, as provided in the plan document. Expenses that are paid by Edward W. Sparrow Hospital Association are excluded from these financial statements.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets available for benefits and changes therein. Actual results could differ from those estimates.

Subsequent Events

Plan management has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.

3. Investments – Unaudited Information

Certain information disclosed in the accompanying financial statements and supplemental schedule, including mutual fund investments at fair value, fully benefit-responsive contract at contract value, interest receivable on notes receivable from participants, and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by State Street Bank and Trust Company (State Street), the trustee of the Plan. This certified information has not been audited by independent auditors.

4. Parties-In-Interest

Parties-in-interest are defined under the Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, auditor, and certain others.

The Plan holds investments managed by Transamerica Capital, Inc., State Street, and Transamerica Life Insurance Company (affiliates of Transamerica Retirement Solutions). Transamerica Retirement Solutions (Transamerica) is the Plan's recordkeeper and State Street is the trustee of the Plan; therefore, these are considered party-in-interest investments. Fees of \$8,291 were paid to Transamerica during 2024 (\$8,521 in 2023). Other professional fees are paid by Edward W. Sparrow Hospital Association, an affiliated entity of the participating employers of the Plan, on behalf of the Plan. Indirect compensation in the form of revenue sharing was paid to National Financial Services in 2024 and 2023. Notes receivable from participants are also considered party-in-interest transactions since employees are considered parties-in-interest under ERISA.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan document to terminate the Plan at any time, subject to the provisions of ERISA. See Note 1 for discussion on a planned merger.

6. Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan document sponsored by Transamerica. The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the document adopted by the Plan, as then designed, was in compliance with applicable requirements of the Code. Although the Plan has been amended since receiving the opinion letter, plan management believes the Plan is designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally, tax years 2021 through the current year remain open to examination. Plan management does not believe that the results from any examination of these open years would have a material effect on the Plan.

7. Fair Value Measurements

As defined in current authoritative guidance, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In determining fair value, the Plan uses various methods including market, income, and cost approaches.

Based on these approaches, the Plan often utilizes certain assumptions that market participants would use in pricing the asset or liability, including assumptions about risk and/or the risks inherent in the inputs to the valuation technique. These inputs can be readily observable, market corroborated, or generally unobservable inputs.

The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques, the Plan is required to provide information according to the fair value hierarchy. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values.

7. Fair Value Measurements (continued)

Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

- Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.
- Level 2 – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 – Significant unobservable inputs that reflect a company's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

For the years ended December 31, 2024 and 2023, the application of valuation techniques applied to similar assets and liabilities has been consistent.

The Plan believes its valuation methods are appropriate and consistent with other market participants. The use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
