### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lindsay Automotive Family Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - The information in the accompanying financial statements related to assets held by a qualified institution and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1. Plan Description

The following description of Lindsay Automotive Family Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all eligible employees of Lindsay Cadillac Company; Alexandria Motor Cars, Inc.; Dulles Volkswagen, LLC dba Lindsay Volkswagen of Dulles; Lindsay Ford, LLC; Lindsay Management Company, LLC; Lindsay Chevrolet, LLC; Lindsay Motors, LLC; Lindsay Automotive of Manassas, LLC; Manassas Cycles, LLC; Warrenton Motors, LLC; Lindsay Virginia Motors LLC; and Front Royal Motors LLC (collectively, the Company). The Board of Directors is responsible for oversight of the Plan. The Board of Trustees determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan amendment:** Effective August 1, 2024, the Plan was amended to increase the maximum auto-escalation deferral rate from 6% to 8%.

**Eligibility:** Employees covered by a collective bargaining agreement with the Company and leased employees are not eligible to participate in the Plan. Eligible employees may participate in the Plan following one year of continuous service and attainment of age 21, as defined in the Plan agreement. The Plan entry dates are January 1, April 1, July 1 and October 1, the beginning of each calendar quarter.

**Contributions:** Participants may contribute a percentage up to 50% of their pretax or after-tax compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Unless they elect otherwise, participants are automatically enrolled in the Plan when they become eligible with 4% of their eligible compensation contributed to the Plan on a pretax basis. Participants' deferral election will automatically increase by 1% each year on January 1 until they reach a deferral rate of 8% unless the participant makes a different deferral election.

Employer contributions include employer matching contributions and discretionary contributions. The Company provides fixed matching contributions equal to 50% of the participant's pretax contribution up to a maximum of 4% of the participant's eligible compensation. Employer discretionary profit-sharing contributions are determined by the Company's Board of Directors and are allocated to participants employed on the last day of the plan year in the same ratio as each participant's eligible compensation bears to the total eligible compensation of all participants. There were no discretionary contributions during the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Code (IRC) limitations.

**Investment options:** Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Board of Trustees in 1% increments. Participants may change their investments options daily.

**Participant accounts:** Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of any discretionary contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Note 1. Plan Description (Continued)

**Vesting:** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. The portion of the participant's account attributable to Company contributions plus actual earnings thereon is vested ratably over five years of service as follows: 20% after completing one year of service (defined as 1,000 hours in a plan year) and 20% for each additional year with 100% vesting after five years of service. Participants also become fully vested upon death, disability or attainment of age 65 while actively employed by the Company.

**Payment of benefits:** The Plan provides for distributions of accumulated benefits upon separation of service, death or disability. If the participant's vested balance does not exceed \$1,000, a lump-sum distribution will automatically be made to the participant. The Plan also offers in-service distributions for hardships, attainment of age 59½ years and from after-tax source balance for any reason. Hardship distributions are permitted based on specific criteria. Benefits are payable in lump-sum payments with certain exceptions allowed.

**Forfeitures:** Forfeitures are used to reduce future employer contributions or pay plan expenses. Forfeited nonvested accounts totaled \$13,992 and \$1,786 at December 31, 2024 and 2023, respectively. During 2024, \$23,706 was used to reduce employer matching contributions and \$0 was used to pay administrative expenses.

**Notes receivable from participants:** Participants who incur a financial hardship may borrow from their vested balances a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested portion account balance. The \$50,000 maximum loan amount is reduced by the participant's highest outstanding loan balance in the previous 12 months. Terms of general loans are between 12 to 60 months, and terms of residential loans are between 61 to 180 months. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% as determined on the date the loan was granted. As of December 31, 2024, active loans have interest rates of 4.25% to 9.50%, and the loans have maturity dates through 2039. Principal and interest are paid ratably through payroll deductions.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

#### Note 2. Summary of Significant Accounting Policies (Continued)

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Contributions:** Contributions are recognized upon authorization and in the year the underlying compensation is paid. All participant and employer contributions are participant-directed. Participant contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction in contributions.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain record-keeping fees paid by the Plan. Investment-related expenses are included in net appreciation of fair value of investments.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified or Provided by Capital Bank and Trust Company (Trustee)

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### Note 5. Related Parties and Party-in-Interest Transactions

Capital Bank and Trust Company is the trustee of the Plan and an affiliate of American Funds, issuer of the Plan's investment options; therefore, transactions with the trustee and American Funds qualify as party-in-interest transactions. The Company also paid certain administrative expenses of the Plan.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### Note 7. Tax Status

The Plan adopted a nonstandardized form of a preapproved plan sponsored by Capital Group Retirement Plan Services. The preapproved plan has received an opinion letter from the IRS as to the preapproved plan's qualified status. The preapproved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
