Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lane Enterprises, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note A - Description of Plan

The following description of Lane Enterprises, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all eligible employees of Lane Enterprises, Inc. (the Company), who have one year of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan, including reviewing the appropriateness of the Plan's investment offerings and monitoring investment performance.

1. Contributions

Participants may enter into an elective deferral agreement authorizing the employer to withhold a portion of such participant's compensation to deposit to the Plan, subject to IRS limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions of amounts received from other tax-qualified retirement plans.

The Company may make matching contributions as defined in the Plan and approved by the Board of Directors. In 2024 and 2023, the Company matched 25 percent of each eligible participant's contribution up to 15 percent of compensation. The Company's actual contribution may be reduced by certain available forfeitures, if any, during the Plan year. The Plan also allows for an additional discretionary contribution at the option of the Board of Directors. No discretionary contribution was made for the years ended December 31, 2024 and 2023.

2. Participant accounts

Each participant's account is credited with the participant's contributions, the Company's matching contribution, plan earnings or losses, an allocation of the Company's discretionary contribution, if any, and charged with an allocation of administrative expenses. Allocation of the Company's discretionary contribution is based upon the ratio that each participant's compensation for the plan year bears to the total compensation of all participants for the plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

3. Vesting

Participants are immediately vested in their salary deferral, rollover contributions, and related earnings. Participants vest ratably and are fully vested in the employer's discretionary profit-sharing and matching contributions allocated to their account after six years of credited service. A participant becomes fully vested, regardless of the years of service, upon attainment of retirement due to total and permanent disability or death.

4. Participant loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is lower. The loan is secured by the balance in the participant's account. The loan interest rate is set at 2 percent above the prime rate as defined. Principal and interest is paid ratably through payroll deductions.

5. Investment options

Each participant may direct account balances to be invested in one or any combination of investment options offered by the Plan and may change the allocation daily. The Plan does not have any nonparticipant-directed investments.

6. Payment of benefits

The Plan provides for payment of benefits upon death, disability, retirement, or termination of employment. A separated participant with a vested balance exceeding \$5,000 may elect to receive a lump-sum amount equal to the value of his or her account. Effective August 15, 2018, a participant with a vested balance exceeding \$5,000 who is required to receive lifetime required minimum distributions (RMDs) may elect to receive installments payable in monthly, quarterly, or annual installments equal to or exceeding the annual RMD amount. If a separated participant has a vested balance that does not exceed \$5,000, they will receive a lump-sum distribution rather than receiving installments.

7. Forfeited accounts

At December 31, 2024, forfeited nonvested accounts totaled \$430. At December 31, 2023, forfeited nonvested accounts totaled \$929. In 2024, \$1,824 was used to reduce employer contributions and \$4,684 was applied to reduce trustee and recordkeeping fees.

Note B - Summary of Accounting Policies

A summary of significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

1. Basis of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

2. Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

3. Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note D for discussion of fair value measurements).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Net appreciation (depreciation) in fair value of investments

The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains and losses and the unrealized appreciation (depreciation) on those investments.

5. Participant loans

Participant loans are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

6. Payment of benefits

Benefits are recorded when paid.

7. Expenses

Certain expenses of maintaining the Plan are paid by the Company and, therefore, are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for the administration of participant loans are included in administrative expenses and charged directly to the participant's account.

8. Date of management's review and subsequent events

Subsequent events were evaluated through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

Note C - Party-in-Interest Transactions

All plan investments are held by INTRUST Bank, N.A., the plan custodian. The Plan paid \$37,390 of commissions and fees to INTRUST Bank, N.A. during 2024. These transactions qualify as party-in-interest transactions.

Note D - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Quoted prices in active markets for identical assets or liabilities.
- Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 Unobservable inputs supported by little or no market activity and significant to the fair value of the assets or liabilities.

Note D - Fair Value Measurements - Continued

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note E - Income Tax Status

On June 30, 2020, the Internal Revenue Service stated that the nonstandardized pre-approved agreement adopted by the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal taxing authorities. Management is not aware of any uncertain tax positions taken by the Plan. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note F - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note G - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will immediately become fully vested in their accounts.

Note H - Reportable Transactions under ERISA

The Plan had no loans, fixed income obligations, or leases at December 31, 2024. All plan assets are in an investment contract with INTRUST Bank, N.A.
