Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Placon Corporation Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Note 1. Description of the Plan

The following description of Placon Corporation Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established to provide retirement benefits to employees of Placon Corporation (the Company) who have attained 18 years of age. The 401(k) Investment and Education Committee is responsible for oversight of the Plan. The 401(k) Investment and Education Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants are permitted to make elective pretax contributions pursuant to a salary reduction agreement which authorizes the Company to defer wages through the Plan, subject to certain limitations, as defined. Participants are permitted to designate all or any part of their elective deferrals as after-tax contributions, known as Roth 401(k) deferrals. The Plan includes an auto-enrollment provision whereby all newly eligible employees, who have not completed a salary reduction agreement, are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of the participant's eligible compensation, and such withholding will increase each year by 1% up to a maximum of 10% of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company has elected to make discretionary matching contributions equal to 100% of salary reduction contributions for nonunion employees up to 3% of their compensation. The Company may also make an additional discretionary contribution annually. There was no additional discretionary contribution for the year ended December 31, 2024.

Participant accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, (b) Plan earnings and (c) charged with an allocation of administrative expenses. Allocations are based on compensation, participant account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested account.

Vesting: All participants are 100% vested in their salary reduction and rollover contributions plus actual earnings thereon. Discretionary Company matching contributions, and earnings thereon, vest immediately for participants hired prior to March 1, 2012, and vest ratably over four years of service for participants hired on or after March 1, 2012. All other Company contributions, and earnings thereon, vest after one year of service for nonunion employees and ratably over six years of service for union employees.

Investment options: Upon enrollment in the Plan, a participant may direct their accounts in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. The repayment period is limited to five years or less unless the note is being used for the purchase of a primary residence.

Note 1. Description of the Plan (Continued)

Payment of benefits: Upon termination of service for any reason, a participant may elect to receive benefits either in a lump-sum payment, partial payment or in a series of installments. Participants may elect to withdraw all or any part of their voluntary after-tax or rollover contributions at any time subject to any applicable penalties and may withdraw the immediately vested elective deferrals upon attaining age 59½. Hardship withdrawals are also permitted if a participant meets certain conditions defined in the Plan document.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$5,800 and \$2,900, respectively. These accounts may be used to pay plan expenses or reduce future Company contributions. During 2024, \$248,200 of forfeited nonvested accounts were used to reduce Company contributions. No amount was used to pay plan expenses for the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Investment and Education Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

Payment of benefits: Benefits paid to participants are recorded when paid.

Administrative expenses: Administrative expenses can be paid either by the Company or from plan assets.

Subsequent events: The plan administrator has evaluated events through October 7, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Shares of registered investment companies are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Related-Party and Party-in-Interest Transactions

The Plan's investments include shares of registered investment companies managed by Fidelity Management & Research Company (FMR). FMR provides management, investment advisory and shareholder services for the Fidelity mutual funds. Fidelity Investments Institutional Operations Company, Inc. (FIIOC) is a wholly owned subsidiary of FMR. FIIOC serves as the contractual record-keeping agent for the retirement plan administrative products marketed and sold by the trustee. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to FIIOC amounted to approximately \$11,100 for the year ended December 31, 2024.

The Plan has arrangements with service providers to provide investment advisory services. These transactions are party-in-interest transactions under ERISA. Fees paid by the Plan to the investment advisor were approximately \$18,400 for the year ended December 31, 2024.

Certain employees of the Company provide administrative services for the Plan and are not reimbursed for their services from the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan and are excluded from these financial statements.

Note 6. Income Tax Status

The Plan has adopted a pre-approved plan sponsored by FMR LLC. The pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes that the Plan is designed, and is being operated, in compliance with the applicable provisions of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Termination of the Plan

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue Company contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants are permitted to make elective pretax contributions pursuant to a salary reduction agreement which authorizes the Company to defer wages through the Plan, subject to certain limitations, as defined. Participants are permitted to designate all or any part of their elective deferrals as after-tax contributions, known as Roth 401(k) deferrals. The Plan includes an auto-enrollment provision whereby all newly eligible employees, who have not completed a salary reduction agreement, are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of the participant's eligible compensation, and such withholding will increase each year by 1% up to a maximum of 10% of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company has elected to make discretionary matching contributions equal to 100% of salary reduction contributions for nonunion employees up to 3% of their compensation. The Company may also make an additional discretionary contribution annually. There was no additional discretionary contribution for the year ended December 31, 2024.

Participant accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, (b) Plan earnings and (c) charged with an allocation of administrative expenses. Allocations are based on compensation, participant account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested account.

Vesting: All participants are 100% vested in their salary reduction and rollover contributions plus actual earnings thereon. Discretionary Company matching contributions, and earnings thereon, vest immediately for participants hired prior to March 1, 2012, and vest ratably over four years of service for participants hired on or after March 1, 2012. All other Company contributions, and earnings thereon, vest after one year of service for nonunion employees and ratably over six years of service for union employees.

Investment options: Upon enrollment in the Plan, a participant may direct their accounts in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. The repayment period is limited to five years or less unless the note is being used for the purchase of a primary residence.

Note 1. Description of the Plan (Continued)

Payment of benefits: Upon termination of service for any reason, a participant may elect to receive benefits either in a lump-sum payment, partial payment or in a series of installments. Participants may elect to withdraw all or any part of their voluntary after-tax or rollover contributions at any time subject to any applicable penalties and may withdraw the immediately vested elective deferrals upon attaining age 59½. Hardship withdrawals are also permitted if a participant meets certain conditions defined in the Plan document.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$5,800 and \$2,900, respectively. These accounts may be used to pay plan expenses or reduce future Company contributions. During 2024, \$248,200 of forfeited nonvested accounts were used to reduce Company contributions. No amount was used to pay plan expenses for the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Investment and Education Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

Payment of benefits: Benefits paid to participants are recorded when paid.

Administrative expenses: Administrative expenses can be paid either by the Company or from plan assets.

Subsequent events: The plan administrator has evaluated events through October 7, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Shares of registered investment companies are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Related-Party and Party-in-Interest Transactions

The Plan's investments include shares of registered investment companies managed by Fidelity Management & Research Company (FMR). FMR provides management, investment advisory and shareholder services for the Fidelity mutual funds. Fidelity Investments Institutional Operations Company, Inc. (FIIOC) is a wholly owned subsidiary of FMR. FIIOC serves as the contractual record-keeping agent for the retirement plan administrative products marketed and sold by the trustee. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to FIIOC amounted to approximately \$11,100 for the year ended December 31, 2024.

The Plan has arrangements with service providers to provide investment advisory services. These transactions are party-in-interest transactions under ERISA. Fees paid by the Plan to the investment advisor were approximately \$18,400 for the year ended December 31, 2024.

Certain employees of the Company provide administrative services for the Plan and are not reimbursed for their services from the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan and are excluded from these financial statements.

Note 6. Income Tax Status

The Plan has adopted a pre-approved plan sponsored by FMR LLC. The pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes that the Plan is designed, and is being operated, in compliance with the applicable provisions of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Termination of the Plan

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue Company contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
