## INDEPENDENT AUDITOR'S REPORT

### Note 1 - Description of the Plan

#### General

The Consolidated Crane Company, Inc. 401(k) Plan (the "Plan") is a defined contribution plan that was established on January 1, 1995 by Consolidated Crane Company, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement, including amendments thereto, for a more complete description of the Plan's provisions.

#### Administration

The Plan Sponsor and named Plan Administrator is the Company. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and fees, and reports to the Plan's Trustees. The Plan's Trustee and Investment Custodian is Reliance Trust Company. The Investment Custodian holds all of the Plan's assets and executes all of the Plan's transactions. The Company has retained T. Rowe Price Retirement Plan Services, Inc. ("T. Rowe Price") to perform recordkeeping and administration services.

#### Eligibility

The Plan covers all full-time employees of the Company except for union employees, and nonresident aliens. All eligible employees must have reached 18 years of age and completed two consecutive months of service, with the Plan entry date being the first day of the month coinciding with or next following the date the eligibility requirements are met.

#### Contributions

Each participant may elect to contribute a percentage of annual compensation to the participant's deferral account. The maximum percentage that a participant may elect to contribute is 100% of annual compensation, subject to limitations imposed by the Internal Revenue Code ("IRC"). Additionally, participants who are at least 50 years of age are permitted to make catch up contributions. Participants may also make contributions to a Roth account. If a participant fails to make an elective deferral contribution election after receiving a notice from the Plan administrator, participants are deemed to have made an election in the amount of 3% of their compensation.

The Company may elect to make discretionary matching contributions to the Plan equal to a percentage of the employees' deferrals. There were no matching contributions for the year ended December 31, 2024.

The Company may also elect to make discretionary profit-sharing contributions to the Plan. There were no profit-sharing contributions for the year ended December 31, 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan by updating and monitoring their elections online or completing a change request form with the Plan sponsor. The Company's contributions are allocated in the same manner as that of the participant's elective contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution(s) and Plan earnings or losses and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing portions of their accounts plus actual earnings thereon is based on continuous service. Participants are vested in the Company discretionary matching and profit-sharing contributions based on the following table:

Notes Receivable from Participants

Under the provisions of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of the lesser of \$50,000 or 50% from the vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan fund. Generally, loan terms may not exceed five years unless the loan is for the purchase of a primary residence, in which case the Plan administrator may permit a longer repayment term.

Participants are limited to one outstanding loan at a time. The loans are collateralized by the vested balance in the participant's account and bear interest at rates comparable to the rate a lending institution would charge on a similar loan. Principal and interest are repaid ratably through periodic payroll deductions.

Benefit Payments

On termination of service, a participant who has a vested interest in their account which is less than or equal to \$5,000 shall receive a lump sum equal to the vested interest in their account. Participants who have a vested interest in their account which exceeds \$5,000 may elect to receive a lump sum payment equal to the vested interest of their account or rollover the account balance to an individual retirement account or to another employer's tax qualified plan. If a participant's balance is greater than \$5,000 on the date of termination, and the participant does not request a distribution, the Plan administrator will roll over the account balance into an individual retirement account.

Under the terms of the Plan, participants who attain retirement age or become totally disabled prior to their retirement date will receive all amounts credited to their accounts. Upon death of the participant while actively employed, the distribution is made in accordance with the participant's previous direction.

Participants may make early withdrawals up to the full balance of their elective deferral contributions in their account under the hardship provision of the Plan. A participant may make unrestricted withdrawals of the vested interest of their accounts on or after age 59 1/2.

### Forfeited Accounts

Forfeitures consist of the non-vested portion of terminated participant account balances and may be used by the Plan to pay for Plan expenses or reduce any employer matching contributions. The forfeiture account balance totaled \$5,541 and \$5,276 as of December 31, 2024 and 2023. During 2024, no forfeitures were used to fund employer matching contributions or pay for Plan expenses.

### **Note 2 - Summary of Significant Accounting Policies**

#### Basis of Accounting

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Income from investments is recorded when it is earned. Expenses are recorded in the accounting period in which they are incurred.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes realized gains and losses and unrealized appreciation or appreciation in the market value of investments held at year-end.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan and excluded from these financial statements. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 6, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Unaudited Investment Information Certified by Trustee**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by the Trustee as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditor:

- All investment balances reflected in the statements of net assets available for benefits as of December 31, 2024 and 2023,
- All investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024,
- All investment-related information included in the Supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and
- Notes receivable from participants as of December 31, 2024 and 2023 and the related income on notes receivable from participants for the year ended December 31, 2024.

**Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interest-bearing cash:* Interest-bearing cash consists of money market funds that are valued at the net asset value of shares held by the Plan at year end.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective trust funds:* Valued at fair value based on the Net Asset Value (NAV) of units held of the collective fund. The NAV, as provided by the Trustee/Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. This practical expedient is not used with it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(b) The objective of the Collective Trust fund is to provide a moderate total return over a full market cycle with commensurate risk. The fund pursues its investment objective by investing primarily in a professionally managed portfolio of registered investment companies and collective investment trusts, which in turn invest in equity securities and fixed income securities.

**Note 5 - Plan Amendment and Tax Status**

The Plan is utilizing a volume submitter plan, which has been filed with the IRS and has received a favorable opinion letter dated June 30, 2020 from the IRS. The Plan Sponsor has not elected to apply for an individual IRS Determination Letter upon adoption of the Plan nor on any subsequent amendments. However, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code and, therefore, that the Plan is qualified under Section 401(a) and that the related Trust is tax-exempt as of December 31, 2024.

The Plan permitted provisions of SECURE Act 2.0 during the years ended December 31, 2024 and 2023. Written amendments to the plan document to reflect these operational changes will be adopted at a later date in accordance with the deadlines pursuant to applicable laws and IRS guidance.

The plan document was most recently amended and restated, effective October 25, 2023 to bring the plan into compliance with the legislative and regulatory changes set forth in IRS Notice 2017-37 (i.e., cycle 3 restatement).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would qualify for either recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, all participants will have a 100% vested interest in their accounts and the net unallocated assets would be allocated among the participants and beneficiaries of the Plan in the order provided for by ERISA.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8 - Related Party and Party-In-Interest Transactions**

Certain Plan investments are managed by T. Rowe Price. During the year ended December 31, 2024, the Plan paid direct compensation to T. Rowe Price for services rendered. Transactions involving these investments are considered party-in-interest transactions; however, these transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

**Note 9 - Correction of an Error**

During the current plan year, management identified an error in the prior year's valuation of the common trust fund investment. The investment was incorrectly adjusted from fair value to contract value, whereas it should have been reported at net asset value (NAV) in accordance with ASC 820, Fair Value Measurement. This resulted in an understatement of net assets available for benefits by approximately \$17,609 as of the prior year-end.

Management evaluated the error and determined that it was not material to the prior year financial statements. Accordingly, the error has been corrected in the current year as an out-of-period adjustment. The beginning balance of net assets available for benefits for the year ended December 31, 2024, has been adjusted to reflect this correction.

The correction did not impact participant account balances or plan operations.
