We have performed audits of the financial statements of ASCM 401(k) Plan (formerly APICS, Inc. 401(k) Plan) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of ASCM 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Effective September 5, 2024, the Plan changed its name from APICS Inc. 401(k) Plan to ASCM 401(k) Plan.

General

The Plan is a defined contribution plan covering substantially all employees of Association for Supply Chain Management, Inc., d/b/a ASCM, APICS (ASCM) who are age 20½ or older. The Plan does not cover union employees or nonresident aliens. Participation in the Plan may begin immediately upon satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Name Change

Effective September 5, 2024, the APICS, Inc. 401(k) Plan was amended to change its name to the ASCM 401(k). This amendment was adopted in accordance with the plan's governing procedures and does not affect the plan's benefit structure, funding status, or financial position.

The change is administrative in nature and does not result in any modification to participant rights or obligations. All references to the plan in this report reflect the updated name. The plan continues to operate under the same EIN and plan number as previously reported.

Contributions

The Plan provides for employee 401(k) deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make after-tax Roth 401(k) contributions and rollover contributions from other qualified defined benefit or defined contribution plans.

ASCM makes a discretionary matching contribution equal to 100 percent of a participant's deferral contributions, up to a maximum of 6 percent of compensation. Participants must complete six months of service in order to be eligible to receive employer matching contributions.

ASCM may also make discretionary nonelective contributions. Participants must complete at least 501 hours of service during the plan year or be employed by ASCM on the last day of the plan year in order to receive an allocation of this contribution. All participants who become disabled, retire, or die during the plan year are exempt from the last day and hours of service requirement. No such contribution was made for the year ended December 31, 2024.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates determined quarterly by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Note 1 - Plan Description (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the employer's matching contribution, and allocations of the employer's nonelective contribution and plan earnings and charged with an allocation of administrative expenses and plan losses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of the funds held in their accounts into various investment options offered by the Plan.

Vesting

Participants are fully vested at all times in all participant contributions and plan earnings. Participants are vested in employer contributions as follows:

Benefit Payments

Upon death or other termination of employment, a participant may elect to receive the value of the participant's vested interest in their account in the form of a lump-sum payment or equal periodic installments. In-service withdrawals starting at age 59½ are also permitted by the Plan.

Participants may request all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future employer contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$0.

For the year ended December 31, 2024, the Plan used \$28,015 to reduce employer contributions.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by American United Life Insurance Company (AUL) and its affiliates. AUL is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, ASCM has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except as noted below.

The fully benefit-responsive group annuity contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Note 2 - Summary of Significant Accounting Policies (Continued)

The registered investment companies are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. See Note 4 for additional information.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expense

Various administrative costs of the Plan were paid by the Plan to the extent not paid by ASCM; these costs qualify as party-in-interest transactions.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 16, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

AUL (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

- (3) This class represents investments in actively managed registered investment companies with investments in both equity and fixed-income securities. Asset allocation is based on anticipated target retirement horizons.
- (4) This class represents investments in actively managed registered investment companies with investments in real estate. The investments may include real estate property or real estate investment trusts.

The Plan's policy is to recognize transfers between levels of the fair value hierarchy as of the actual date of the event of change in circumstances that caused the transfer. There were no transfers between levels of the fair value hierarchy during 2024.

Note 5 - Investment Contracts

The Plan has a benefit-responsive group annuity contract with AUL. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 2 percent. When establishing interest crediting rates for this product, AUL considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

Note 6 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
