## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the Blue Raven Solutions LLC 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Blue Raven Solutions LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). **1. Description of Plan**

The following description of the Blue Raven Solutions LLC 401(k) Plan (the “Plan”), formerly known as the Triman Holdings, LLC 401(k) Plan, provides only general information. The Plan was originally effective January 1, 2001 and was most recently amended and restated effective January 1, 2024 (see Note 9). Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Blue Raven Solutions, LLC (the “Company”), formerly known as Triman Holdings, LLC. To be eligible for deferral purposes, employees must have attained the age of 18 and can enter the Plan immediately following the satisfaction of the eligibility requirements (see Note 9). To be eligible to receive safe harbor matching contributions, discretionary qualified nonelective contributions, and additional discretionary contributions from the Company, employees must attain the age of 18 and complete 120 days of service, as defined by the Plan document. Employees who are covered by a collective bargaining agreement for which retirement benefits have been the subject of good faith negotiations are not eligible to participate in the Plan. Employees who are nonresident aliens with no income from a U.S. source, and independent contractors are also ineligible for participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

Each year, participants may contribute up to 100 percent of their pretax annual compensation, as defined in the Plan document, provided that in no event shall a participant elect to contribute more than the maximum allowed by law. Contributions may also be designated as Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan provides for safe harbor matching contributions equal to 100% of elective deferral contributions that do not exceed 3% of compensation, plus 50% of elective deferral contributions exceeding 3% but not 5% of compensation. The Company may also make additional discretionary contributions and discretionary qualified nonelective contributions. The Company did not make any additional discretionary contributions or discretionary qualified nonelective contributions for the year ended December 31, 2024.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution, and the Company’s safe harbor matching contributions, as well as allocations of the Company’s discretionary qualified nonelective contributions and additional discretionary contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

A participant, at all times, has a fully vested (100%) interest in their own contributions, rollover contributions, safe harbor matching contributions, and discretionary qualified nonelective contributions from the Company, including actual earnings thereon. Participants become 20% vested in the additional discretionary contributions after two years of service and vest an additional 20% each year until they are fully 100% vested after six years of service. Forfeitures may also arise from participants whose balances were transferred into the Plan as part of a merger which are subject to the vesting schedule of the prior plan.

Notwithstanding the above, participants will become 100% vested in the additional discretionary contribution portion of their accounts upon their attainment of normal retirement age (65), death, or disability.

**Forfeited Amounts**

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$4,477, respectively. Forfeitures may be used to pay administrative expenses, reduce Company contributions or be reallocated to participant accounts. During the year ended December 31, 2024, \$8,248 of forfeitures were used to offset employer contributions, \$3 of forfeitures were used to pay administrative expenses of the Plan and no amounts were reallocated to participant accounts.

**Payment of Benefits**

On termination of service due to death, disability, retirement or otherwise, a participant may elect to receive a lump sum or partial payment from the participant's vested interest in his or her account. In circumstances when a terminated participant has a vested account balance less than \$7,000 (\$5,000 prior to modification to allowed by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022, "SECURE ACT 2.0"), the participant's vested account balance shall be distributed in a lump sum. In the event of a mandatory distribution greater than \$1,000, if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan administrator. Hardship and in-service distributions are also permitted from participant accounts, based on the terms of the Plan document.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum generally equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate at the time of borrowing. Principal and interest are repaid ratably through payroll deductions over a period of five years or less, with the exception of loans made for the purchase of a primary residence, where the repayment period may be up to and including ten years. Participants are limited to two outstanding loans at one time. Interest rates on notes receivable from participants ranged from 4.25% to 9.50% as of December 31, 2024.

**2. Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by trustees, custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payments of Benefits**

Benefits are recorded when paid.

**Contributions**

Contributions from Plan participants and safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Discretionary qualified nonelective contributions and additional discretionary contributions from the Company, if any, are recorded in the year in which the related compensation is earned.

**Administrative Expenses**

All reasonable administrative expenses, including trustee, custodial and third-party administration fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

**3. Information Certified by Qualified Institution**

The Plan administrator, having determined that it is permissible in the circumstances, elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Delaware Charter Guarantee & Trust Company, d/b/a Principal Trust Company ("Principal"), trustee of the Plan and a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for all mutual funds, collective investment trusts, pooled separate accounts, and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedules.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at the NAV or equivalent based on units of the pooled separate accounts. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the pooled separate accounts less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

*Collective investment trusts:* Valued at the NAV or equivalent based on units of the collective investment trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the collective investment trust less its liabilities. This practical expedient is not used when it is determined to be probable that the collective investment trust will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of levels 1, 2, or 3.

The Plan's collective investment trusts and pooled separate accounts are invested in a variety of funds designed to mirror the investment strategies of similar registered investment companies (mutual funds), including equity style funds, fixed income style funds and real estate investment trust ("REIT") funds. The objective of collective investment trusts and pooled separate accounts invested in equity investments is to approximate the risk of return characterized by various indexes; to seek long term capital appreciation; provide diversified exposure representative of various segments of the U.S. or foreign equity market; and/or to seek income. The objective of the common collective trusts invested in fixed income is to provide investment results that approximate the overall performance of certain bond indices and/or to provide a predictable rate of return while preserving the safety of capital and minimizing market risk. The objective of collective investment trusts invested in REIT funds is to provide high current income, with capital appreciation as a secondary objective, by investing in higher-yielding debt and equity commercial real estate-related investments. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a collective investment trust and/or pooled separate account, the trustee and/or insurance company reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

**5. Tax Status**

Effective January 1, 2024, through the adoption of a Principal Financial Group Pre-Approved Document for Savings Plans, the Plan was amended and restated. The Internal Revenue Service (“IRS”) issued an opinion letter dated June 30, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with applicable Internal Revenue Code (“IRC”) requirements as of that date. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in any employer contributions for which they were not already vested and the trustee would distribute account balances as permitted by the Plan document.

**7. Risks and Uncertainties**

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**8. Related-Party and Party-In-Interest Transactions**

Certain Plan investments are shares of collective investment trusts and pooled separate accounts managed by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company or its affiliates. Principal Trust Company is the trustee of the Plan. During the year ended December 31, 2024, the Plan paid \$30,556 to Principal Life Insurance Company, the recordkeeper of the Plan. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant’s account balance.

During 2023, the Company failed to remit to the Plan’s trustee certain participant contributions and loan repayments totaling \$32,898, within the period prescribed by the Department of Labor regulations. During 2025, the Plan Sponsor made contributions to the affected participants’ accounts to compensate the participants for potential lost income due to the processing delays. The Plan Sponsor believes that these transactions do not affect the tax status of the Plan and took action prescribed by the regulations to remedy such errors.

**9. Plan Amendments**

Effective January 1, 2024, the Plan was amended and restated to change the entry date for newly eligible participants from the first day of the month to immediately following the satisfaction of the eligibility requirements.

**10. Subsequent Events**

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.
