## Notes to Financial Statements

### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### ***Basis of Presentation***

The financial statements of the Brighton Center, Inc. Employee Pension Plan (the "Plan") are prepared under the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### ***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Benefit Payments***

Benefit payments are recorded when paid.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent participant loans may be reclassified as distributions based upon the terms of the Plan.

#### ***Subsequent Events***

In preparing the financial statements, the Plan has evaluated subsequent events to the statement of net assets available for benefits through October 1, 2025, which is the date the financial statements were available to be issued.

### Notes to Financial Statements (Continued)

#### NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan covering all employees of Brighton Center, Inc. and Brighton Properties (collectively, the Organization). All eligible employees may participate in the Plan as of the first day of employment. Employees are eligible for employer discretionary contributions on the first of the month following 60 days of service. Employees that were eligible to participate prior to the January 1, 2008 amendment will remain participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2018, all newly eligible employees are automatically enrolled in the Plan and defer 2% of compensation unless otherwise opting out of the Plan.

##### ***Contributions***

Participants may elect to contribute a specific percentage of their compensation, as defined in the Plan, on a pre-tax or after-tax Roth deferral basis, up to the total annual deferral limits established by the Internal Revenue Code. The Organization makes a matching contribution of up to 2% of salary deferrals for participants hired after January 1, 2008. In addition, the Organization may make discretionary non-elective profit sharing contributions up to 6% of salary for participants hired prior to January 1, 2008 and 4% of salary for participants hired on or after January 1, 2008. The Organization made the maximum discretionary non-elective profit sharing contribution for 2024 and 2023. For certain high-ranking participants, the Organization may make an additional discretionary non-elective contribution. In 2024 and 2023, the Organization made an employer discretionary contributions of \$-0- and \$29,664, respectively. Participants may also rollover funds previously held in another employee benefit plan to the Plan.

##### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and the Organization's matching contributions, as well as allocations of the Organization's non-elective contributions and the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Vesting***

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Organization's contributions portion of their accounts, plus actual earnings thereon, is based on years of continuous services. Vesting begins upon the completion of the first year of service and a participant is 100% vested after five years of credited service.

##### ***Forfeited Accounts***

For the year ended December 31, 2024, \$18,862 and \$63,696 of forfeitures were used to reduce employer contributions and pay certain Plan expenses, respectively. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$44,385 and \$41,326, respectively. These accounts will be used to reduce future employer contributions or pay certain Plan expenses.

### Notes to Financial Statements (Continued)

#### NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

##### ***Payment of Benefits***

Participant contributions, rollovers contributions, vested Organization contributions and related earnings may be withdrawn for any reason after a participant reaches age 59 ½. Participant contributions may be withdrawn at any age if a participant demonstrates financial hardship. Upon termination of service, death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, periodic installments over a specific period, or an annuity for life. Benefit payments to participants are recorded upon distribution.

##### ***Expenses***

The Plan permits the payment of Plan expenses to be made from the Plan assets. If they are not paid from the Plan's assets, then generally the expenses paid will be allocated among the accounts of all participants in the Plan. Investment related expenses are included in net appreciation of fair value of investments.

##### ***Related-Party Transactions***

Certain Plan investments are investments in mutual funds managed by Empower Annuity Insurance Company of America and Nationwide Financial Services, Inc. Both are the asset custodians and trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

The Organization provides administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Organization for these services.

##### ***Investments***

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers money market funds, fixed annuities, variable annuities and mutual funds as investment options for participants. Participants may change their investment options and make transfers at any time.

##### ***Notes Receivables from Participants***

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. No loan in an amount less than \$1,000 will be made. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% at the time funds are borrowed. Principal and interest are paid ratably through payroll deductions. All loans must be paid within five years unless the loan is used to acquire a principal residence in which the loan must be paid within 15 years.

#### NOTE 4 FAIR VALUE MEASUREMENTS

Applicable GAAP accounting for fair value measurements and disclosures establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value:

*Money market fund:* Valued at the net asset value ("NAV") of shares held by the Plan at year end.

#### NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Fixed annuities:* The reported values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

*Pooled separate accounts:* The NAV of the pooled separate accounts are based on the market value of the underlying investments. The NAV of the pooled separate accounts are not publicly-quoted prices in an active market. The pooled separate accounts invest in various mutual funds, equity and debt securities and commercial real estate to generate their investment return.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 5 FEDERAL INCOME TAX STATUS**

The Plan obtained its latest determination letter on March 31, 2017, in which the Internal Revenue Service stated that the Plan qualifies under the applicable provisions of the Internal Revenue Code and therefore, is exempt from federal income taxes. The Plan has been amended and restated since receiving the determination letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan's income tax returns are subject to review and examination by federal authorities.

#### **NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
