Year Ended December 30, 2024

Furst-McNess Company Pension Plan was approved in October of 2021 to be terminated by the Board of Directors. As of December 30, 2024, the Furst-McNess Company plan did not have any participants remaining in the plan and has satisfied all distribution commitments to participants.

All remaining assets of the Pension Plan, after all commitments were satisfied, were consolidated into an account with Fidelity. The remaining balance has been approved to be contributed to active employees of the Furst-McNess 401(k) Plan, with one contribution made March 2023 and another in September 2025.
