INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the igus Bearings, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the igus Bearings, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the igus Bearings, Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the igus Bearings, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023**

1. Description of Plan

The following description of the igus Bearings, Inc. (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1998. As a non-standardized pre-approved profit sharing plan, the Plan is entitled to be treated as a qualified plan under Internal Revenue Code (“IRC”) Sections 401(a) and 401(k). The Plan is a defined contribution plan of the Company that covers substantially all eligible employees who have reached the age of 21 for elective employee deferrals and who have reached the age of 21 and twelve months of service for employer non-elective contributions. The Plan entry date is the first day of each quarter coincident with or following the remaining eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Directors is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

On March 27, 2020, in response to the economic impact caused by the Coronavirus (COVID-19) pandemic, the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act was signed into law. As part of the CARES Act, certain universal changes were implemented related to retirement plans, including waiving required minimum distributions for the 2020 calendar year and waiving the 10% early distribution penalty tax for participants affected by the pandemic. The CARES Act also contained provisions which allowed for Plan administrators to make amendments and elections to the Plan to provide greater access to retirement funds for participants impacted by the pandemic. Some of the allowable elections contained within the CARES Act included allowing expanded in-service distributions, increasing Plan limits on loans to \$100,000 or 100% of the participant’s vested balance, and offering suspensions of loan repayments, without default, until December 31, 2020. The Plan administrator had the ability to choose which elections the Plan would make; there was no requirement for Plans to adopt any of these provisions. The Plan administrator made the election to adopt only the expanded in-service distribution provision during the Plan year ending December 31, 2020. While the provision was, operationally, enacted immediately upon the Plan administrator’s election, the Plan was not formally amended to incorporate these changes until April 2023.

In 2019, the Setting Every Community Up for Retirement Enhancement (“SECURE”) Act was signed into law and, in 2022, the SECURE 2.0 Act was signed into law. The SECURE Act and SECURE 2.0 Act introduced several optional withdrawal provisions that Plan administrators may elect to adopt. The new optional withdrawal provisions consist of (1) qualified birth or adoption distributions, (2) emergency expense withdrawals, (3) withdrawals for federally declared disasters, and (4) withdrawals for domestic abuse victims. There is no requirement for Plans to adopt any of these provisions. The Plan administrator made the election to adopt all of the above withdrawal provisions effective November 1, 2024.

General (continued)

While the provisions were, operationally, enacted upon the Plan administrator's election, the Plan will not have to be formally amended to incorporate these changes until December 31, 2026. The Plan administrator has indicated that it is their intention to amend the Plan by that date.

Contributions

Each year, participants may contribute a minimum of 1% of their eligible compensation, up to the maximum percentage allowable by the IRC, through a salary reduction agreement. For the years ended December 31, 2024 and 2023, total participants' deferrals may not exceed \$23,000 and \$22,500, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the IRC limit (\$7,500 in 2024 and 2023). Participants may also contribute amounts representing distributions from other qualified plans. The Plan has also adopted 401(k) safe harbor provisions in which the Company makes qualified non-elective safe harbor contributions of 3% of a participant's eligible compensation.

Participants hired on or after January 15, 2024 are automatically enrolled in the Plan after meeting eligibility requirements at a contribution percentage of 1% of eligible compensation, as defined by the Plan, unless they opt out, with contributions invested in a designated fund until changed by the participant. Each December 31, any participants that have been automatically enrolled into the Plan will have their deferral increased by 1% up to a maximum of 3%. The automatic deferral is a pre-tax elective deferral.

See the Plan document for the definition of eligible compensation. Participants direct the investment of their contribution into various investment options offered by the Plan. All contributions to the Plan are participant directed.

Participant accounts

Each participant's account is credited with the participant's contributions, rollover contributions, the Company's non-elective safe harbor contributions, as well as allocations of Plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary, rollover, and non-elective safe harbor contributions plus actual earnings thereon.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years or up to ten years for the purchase of a primary residence and participants may have up to two loans outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at a rate equal to the Wall Street Journal prime interest rate (7.50% and 8.50% at December 31, 2024 and 2023, respectively) plus 1% on the last day preceding the quarter. Principal and interest is paid ratably through payroll deductions.

Payment of benefits

Upon termination of service, due to death, disability, retirement, termination of employment or attainment of age 59½, a participant may elect to receive either a lump-sum amount, installment payments, partial distributions or defer payment until further notification if the account balance is in excess of \$5,000. If a participant terminates employment for any reason and his or her vested account balance is between \$1,000 and \$5,000 and the participant does not elect to take a distribution, the Plan Administrator may make a lump sum distribution to a direct rollover individual retirement account. If a participant's vested account balance is below \$1,000 upon termination of employment, the Plan Administrator may make a lump sum distribution directly to the participant without consent of the participant. A participant attains normal retirement age under the Plan at sixty-five years old.

Effective November 1, 2024, the Plan allows for certain distributions for qualified birth or adoption expenses, emergency expenses, federally declared disaster related expenses and expenses related to victims of domestic abuse in accordance with the SECURE Act and SECURE 2.0 Act.

Forfeited accounts

For the Plan years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$29,215 and \$14,604, respectively. Forfeitures may be used to offset employer contributions or to reduce Plan expenses.

For the Plan years ended December 31, 2024 and 2023, \$89,923 and \$0, respectively, of forfeitures were disbursed to offset employer contributions and pay administrative expenses.

2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the

Use of estimates (continued)

financial statements, the reported amount of changes in net assets available for benefits during the reporting period, and disclosure of contingent assets and liabilities. Estimates are principally used in the determination of the fair value of investments. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from their compensation. Safe harbor non-elective employer contributions are recorded in the year to which they relate, based on the Company's funding policy and the Plan's provisions.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, that participant loan balance is reduced, and a benefit payment is recorded.

Payments of benefits

Benefits are recorded when paid.

Other income and expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distributions to participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation of fair

value of investments. The Plan has entered into a custodial account agreement with Fidelity (its trustee) in accordance with IRC section 401(f)(2). Under the terms of the agreement, the Plan receives certain revenue credits from Fidelity, which are classified as other income. These credits may only be used for the exclusive benefit of Plan participants, their beneficiaries, or reasonable expenses of Plan administration. Plan expenses paid out of the custodial account are included in administrative expenses, and any remaining revenue credits are transferred to the forfeiture account and can be used to offset employer contributions.

Subsequent events

Except as disclosed in Note 10, the Plan did not have any subsequent events through September 26, 2025, the date the financial statements were available to be issued for events requiring recording or disclosure in the financial statements for the year ended December 31, 2024.

3. Information prepared and certified by trustee

Certain information presented in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest, dividends, interest income on notes receivable from participants and other income for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee. Fidelity Management Trust Company, the trustee, provided certifications as of and for the years ended December 31, 2024 and 2023.

4. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) *Accounting Standards Codification* (“ASC”) 820, *Fair Value Measurements and Disclosures* are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for Plan investments. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common collective trust:

Valued at the net asset value ("NAV") of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. See Note 5 for more information.

Money market fund:

Valued at amortized cost.

Mutual funds:

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment contract with common collective trust

The Plan invested in the Galliard Stable Return Fund M as of December 31, 2024 and 2023, which is a fully benefit-responsive investment contract through common collective trust in the Plan. The common collective trust's contract value is a relevant measurement attribute since the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Therefore, this is the value included in Plan investments for the 2024 and 2023 Plan years. One of the primary risks involved with investment contracts is credit risk of the contract issuer; there are no reserves against contract value for credit risk of the contract issuer or otherwise if termination of the contracts were to occur.

6. Related party and party-in-interest transactions

All expenses of administration may be paid out of the participants' accounts unless paid out of the custodial account or by the Company. Plan investments are shares of funds managed by Independence Financial Partners, investment adviser, for the Plan years ended December 31, 2024 and 2023. Fidelity Management Trust Company is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. The Plan also issues loans to participants which are secured by the balances in their accounts. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments.

The Plan is administered by a directed trustee appointed by the Board of Directors of the Company. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in all amounts allocated to their accounts.

8. Tax status

The Company has adopted a non-standardized pre-approved profit sharing plan document and is relying on the non-standardized pre-approved profit sharing plan sponsor's opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020. The letter states that the non-standardized pre-approved profit sharing plan and related trust are designed in accordance with applicable sections of the IRC.

Although the non-standardized pre-approved profit sharing plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

8. Tax status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. Subsequent events

Effective January 1, 2025, the Plan was amended to remove the continuing eligibility requirements of 1,000 hours of service during the Plan year and being employed on the last day of the contribution period to receive safe harbor non-elective employer contributions.
