INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ball Chain Manufacturing Company, Inc 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the Ball Chain Manufacturing Company, Inc. 401(k) Profit Sharing Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan covering generally all employees of Ball Chain Manufacturing Company, Inc. (the Employer) that have completed one year of service (1,000 hours). Eligible employees may enter the Plan on the date on which the employee satisfies the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer is also the Plan Administrator. As Plan Administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC (collectively, Empower) are the custodians of the Plan. Empower Trust Company, LLC is the appointed trustee of the Plan and acts at the direction of the Plan Administrator.

Contributions

Each year, participants may contribute a percentage of their eligible pretax compensation, not to exceed annual limitations as provided by the Internal Revenue Code (IRC). Effective January 1, 2024, participants may designate some or all of their elective deferrals as Roth 401(k) deferrals. Participants age 50 and older may also make catch-up contributions. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan provides for an automatic enrollment feature, whereby eligible employees are automatically enrolled to defer 3% of eligible compensation in the Plan. Participants may elect out of participation in the automatic enrollment provision of the Plan.

The Employer makes safe harbor contributions equal to 3% of the participant's eligible compensation. In addition, the Employer may elect to make a discretionary profit-sharing contribution to the Plan. To be eligible for the discretionary profit-sharing contribution, participants must complete 1,000 hours of service in the Plan year and must be employed on the last day of the Plan year. Discretionary profit-sharing contributions are allocated based on a participant's compensation as a percentage of all eligible participants' compensation. No Employer discretionary profit-sharing contributions were made during the Plan year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and their allocations of the Employer's contributions, Plan earnings and losses and any expenses incurred. Allocations are based on individual participant account balances, as defined in the agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, Employer safe harbor contributions and actual earnings on those contributions. Participants become vested in the Employer discretionary profit-sharing contributions and the actual earnings on those contributions as follows: 20% after 2 years, 40% after 3 years, 60% after 4 years, 80% after 5 years, and 100% after 6 years. In the event of death, disability or attainment of retirement age, the participant shall immediately become 100% vested in their account.

Participant Notes Receivable

Participants may borrow from their account a minimum of \$1,000. The maximum loan amount that a participant may request is \$50,000 or 50% of the vested account balance, whichever is less (the \$50,000 is reduced by the highest outstanding loan balance during the past 12 months or any existing loan balances on the date a new loan is made, whichever is greater). Participants are only allowed to have two outstanding loans at a time. Note terms range from 1 to 5 years, or up to a period of 15 years for the purchase of a primary residence. The notes are secured by the vested balance in the participant's account and bear interest at the prime rate plus 1%, as defined in the Plan document. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On retirement, death, disability or termination of service, a participant (or participant's beneficiary in the event of death) can elect to receive a single lump-sum or partial distribution, a distribution in installments, a rollover of the balance to a qualified retirement account or can defer receiving payments until their required minimum distribution age.

Participant vested account balances that are \$5,000 or less upon termination are to be automatically distributed from the Plan. If a participant's vested balance is equal to or less than \$1,000 or the terminated participant has reached age 62, the participant will receive an immediate cash-out of their vested account balance. If a participant's vested balance exceeds \$1,000 and is equal to or less than \$5,000 and the participant is below age 62, the amount will be rolled over to an individual retirement account designated by the Employer unless otherwise directed by the participant.

If a participant has reached age 59½, distributions may be made, at the participant's election, from any accounts which are 100% vested without requiring the participant to terminate employment.

Participants may request a financial hardship withdrawal from their accounts, subject to the limitations imposed by the IRC.

Forfeitures

When termination of participation in the Plan occurs, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are removed from a participant's account upon taking a distribution from the Plan. Forfeitures are available to reduce future Employer contributions or to pay administrative expenses of the Plan. There were \$50,929 and \$46,359 of forfeitures available to reduce future Employer contributions at December 31, 2024 and 2023, respectively. The Plan did not use any forfeitures to offset Employer contributions or pay administrative expenses during 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments and Income Recognition

Investments are reported at fair value, except for the group annuity contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents investments at cost plus accrued interest income, less amounts withdrawn to pay benefits. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor, insurance company and trustee (Notes 3 and 4).

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent notes receivable from participants are reclassified as distributions based on terms of the Plan document.

Contributions

Participant and Employer safe harbor contributions are recorded weekly when the Employer remits the payroll deductions for investment into the Plan. Employer discretionary profit-sharing contributions are made at the end of each year, if applicable.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries.

Administrative Expenses

Certain expenses incurred in the administration of the Plan are paid by the Employer, unless the Employer directs that such expenses be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in three mutual funds that accounted for approximately 56% and 57% of total Plan investments as of December 31, 2024 and 2023, respectively.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the trustee's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value on a recurring basis:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of December 31, 2024 and 2023, the Plan's investments in mutual funds are reported at level 1 within the fair value hierarchy.

4. Fully Benefit-Responsive Investment Contract

The Plan's investment in the Key Guaranteed Portfolio Fund is a fully benefit-responsive investment contract. Contributions to the fund are deposited into the Empower Annuity Insurance Company of America (EAICA) general account, which invests in a range of fixed-income asset classes such as asset-backed securities, mortgage-backed securities and private equity.

The insurance company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Pursuant to the contract, the effective annual interest rate will never be less than 0%. The crediting interest rate is based on a formula agreed upon with the issuer and is reviewed on a quarterly basis for resetting.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value. Certain events limit the Plan's ability to transact with EAICA. Such events include the following: amendments to the Plan documents, changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Employer or other Employer events that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with Plan participants is not probable.

5. Plan Termination

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants. Any Plan termination would be subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

6. Income Tax Status

The Plan is an adoption of a non-standardized prototype plan that received an opinion letter dated November 14, 2022 in which the IRS determined the Plan was operating in accordance with the applicable sections of the IRC. The Plan has since been amended, but the Plan Administrator believes the Plan and the related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Summary of Financial Data Certified by the Custodian

The following is a summary of financial information and data certified by Empower, the custodian.

Statements of Net Assets Available for Plan Benefits at December 31, 2024 and 2023, except for contributions receivable, if any;

Investment income and interest income from participant notes receivable on the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024; and

Investment information provided in the supplemental schedule, Schedule of Assets (Held at End of Year) at December 31, 2024.

8. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

9. Related Party Transactions and Party-in-Interest Transactions

Plan investments are held and managed by Empower, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to Empower for administrative services of \$20,525 for the year ended December 31, 2024. The Plan also made payments of \$40,474 to an independent investment advisor during 2024. Participant notes receivable also qualify as party-in-interest transactions.

10. Subsequent Events

Effective January 1, 2025, the Plan adopted a provision of the Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0, which increased the catch-up contribution limit for participants between the ages of 60 and 63 to the greater of \$10,000 or 150% of the regular catch-up contribution.
