As explained in Note 4, the financial statements include investments valued at approximately \$3,050,000 (17 percent of net assets) at December 31, 2024 and \$3,118,000 (19 percent of net assets) at December 31, 2023 whose fair values have been estimated by management in the absence of readily determinable market values. Management's estimates are based on information provided by TIAA-CREF. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## Notes to Financial Statements

December 31, 2024 and 2023

### Note 1 - Plan Description

The following description of American Society for Clinical Pathology Pension Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all full-time employees of American Society for Clinical Pathology (the "Company") who have completed 19 hours per week of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

The Plan is administered by American Society for Clinical Pathology. The administrator appointed Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) (collectively, TIAA-CREF) as recordkeeper and contract administrator of the Plan. All information relating to the value of the Plan's assets and related investment income was obtained from TIAA-CREF.

#### **Contributions**

The Company makes a monthly contribution to the Plan on behalf of each participant. The contribution is equal to a percentage of the participant's biweekly earnings. The company contributions are set forth in the table below. As of December 31, 2002, participants may only make rollover or restoration contributions to the Plan. Any after-tax contributions made by the participant to the Plan, when previously permitted, will continue to be held in the participant's account.

#### **Vesting**

Participants become vested in the Company's contributions and earnings thereon based on years of service, as presented in the table below:

#### **Participant Accounts**

Each participant's account is credited with the Company's contribution and an allocation of plan earnings and charged with withdrawals and an allocation of plan administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

#### **Benefit Payments**

Distribution of a participant's vested balance is payable upon termination of employment, the incurrance of a disability, or attainment of age 59½. Distributions may be received in the form of a lump sum, partial payments, installment payments, or an annuity amount. Certain amounts invested in the TIAA Traditional Annuity group annuity contract may not be distributed in a lump sum (see redemption restrictions below).

### Note 1 - Plan Description (Continued)

#### ***Redemption Restrictions***

Certain contracts under the TIAA Traditional Annuity investment have limits on the ability of the participant to transfer or withdraw from the fund. Transfers from the Group Retirement Annuity (GRA) must be paid out in 10 annual installments. Transfers from the Retirement Choice (RC) contract must be paid over 84 monthly systematic payments. Transfers from the Transfer Payout Annuity (TPA) contracts must be paid over either 10 annual installments if the underlying contract is GRA or 84 monthly systematic payments if the underlying contract is RC. Lump-sum withdrawals from the GRA and RC contracts are available within 120 days after termination of employment subject to a 2.5 percent surrender charge.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by TIAA-CREF; TIAA Trust, N.A. or their affiliates. TIAA-CREF is a service provider of the Plan, and TIAA Trust, N.A. is a custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions. At December 31, 2024 and 2023, forfeited account balances totaled \$2,950 and \$577, respectively. No forfeited amounts were used to offset employer contributions in 2024.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. The mutual funds are based on quoted prices reported in active markets.

The registered investment companies are valued at net asset value (NAV) per share (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.

The pooled separate account investment is valued at NAV per share (or its equivalent) of the fund, which is based on the fair market value of the fund's underlying net assets, which consist primarily of rental property subject to long-term leases, and has been estimated on the basis of future rental receipts and estimated residual values discounted at interest rates commensurate with risks involved. There are no redemption restrictions or unfunded commitments on this investment.

The TIAA Traditional Annuity is a guaranteed annuity account issued by TIAA that invests in the general assets of TIAA. TIAA considers the Group Retirement Annuity (GRA), the Retirement Choice (RC), and Transfer Payout Annuity (TPA) contracts to be non-benefit responsive, and these contracts are stated at fair value. Since there are no specific securities in TIAA's general account related to these contracts, contract value is the best estimate of fair value for the non-benefit-responsive contracts. Contract value represents principal invested, plus interest earned, less any withdrawals.

### Note 2 - Summary of Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net realized and unrealized gains and losses on investments include gains and losses on investments bought and sold, as well as held, during the year. See Note 4 for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### ***Benefit Payments***

Benefits are recorded when paid. There were benefit payments requested but not paid (due to redemption restrictions) totaling \$38,546 and \$50,322 as of December 31, 2024 and 2023, respectively.

#### ***Allocated Insurance Contracts***

The Plan has allocated insurance contracts for retirees who were covered under the Plan in prior years. These contracts remain intact, and additional contracts have been purchased. The Plan receives no income from these allocated insurance contracts.

#### ***Administrative Expenses***

Administrative expenses of the Plan are paid by the Company, as provided in the plan agreement.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 10, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

TIAA-CREF and TIAA Trust, N.A. hold the Plan's investments and execute related investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by TIAA-CREF and TIAA, as agent for TIAA Trust, N.A.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
