## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Hoffman Hospice of the Valley, Inc. 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.



**FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023**

**NOTE 1 – DESCRIPTION OF PLAN**

General

The following description of the Hoffmann Hospice of the Valley, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a 403(b) plan covering all eligible employees of Hoffmann Hospice of the Valley, Inc. (the Company). The Plan was originally effective in 1998; the effective date of the Plan's amendment and restatement is January 1, 2020. All employees become eligible and may begin to participate in the Plan beginning on their date of hire.

The Plan was formally amended as of January 1, 2015. The Company added the option of making employer matching contributions to participants that contribute through salary deferrals. In addition, participants have to be employed on the last day of the Plan year to receive an allocation of any applicable employer contributions.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a portion of their pretax annual compensation up to the maximum deferral limit. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may elect to make voluntary matching and/or profit-sharing contributions to the Plan. Participants are eligible to receive an allocable share of any employer contributions and gains thereon, if they have completed twelve-months of service and they are employed by the Company on the last day of the Plan year. During the years ended December 31, 2024 and 2023, the Company elected to contribute \$268,299 and \$247,702, respectively, to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution; allocation of the Company's contribution, if applicable; and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on a group determination for profit sharing contributions, deferrals for matching contributions, and account balances or specific participant transactions for administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants become immediately 100% vested in employer contributions plus earnings thereon. Participants are always 100% vested in employee contributions and earnings thereon.

Forfeitures

The Plan does not account for forfeitures as participants are immediately 100% vested in employer and employee contributions.

## **NOTE 1 – DESCRIPTION OF PLAN** (Continued)

### Administration of Plan Assets

The Plan's assets were held in trust by Nationwide Financial Services, Inc., (Nationwide) for the years ended December 31, 2024 and 2023. The trustee provided record-keeping and investment-related services to the Plan during their period of service. The trustee also invested contributions received and investment income, made distributions to participants, and managed Company contributions.

### Funding Policy

The Plan is funded through employee and employer contributions made to the Nationwide trust accounts and an insurance contract. The trust accounts and insurance contract were held by Nationwide for the entire years ended December 31, 2024 and 2023.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum amount of 50% of their account balance. Participants may have one loan outstanding and may not refinance their loan. The loans are secured by the balance in the participant's account. Loans bear a rate of interest, which is determined at the original date of the loan. Principal and interest is paid ratably through biweekly payroll deductions.

### Payment of Benefits

On termination of service due to resignation, discharge, death, disability, or retirement, a participant may receive an amount equal to the value of the participant's vested interest in his or her account.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided at year-end by Nationwide. Please see Note 5 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Investment earnings are recorded as income when credited by Nationwide.

The guaranteed interest contract held with Nationwide is stated at contract value as determined at year-end by Nationwide. The contract is considered fully benefit-responsive. The contract does have a guaranteed interest rate, and the deposits are guaranteed in both principal and interest. Please see Note 6 for discussion on fully benefit-responsive investments.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES** (Continued)

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis of accounting. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. Fees related to specific participant transactions are charged directly to the participant's account and are included in expenses. Administrative fees are allocated among participants' accounts and are included in expenses. Investment related fees are included in net appreciation (depreciation) in fair value of investments.

## **NOTE 3 – INCOME TAX STATUS**

Per Internal Revenue Service (IRS) Procedure 2013-22 in IRS Bulletin 2013-18, the IRS has set forth the procedures for 403(b) pre-approved plans to apply for and receive opinion letters. The IRS began accepting applications as of June 28, 2013. The prototype plan that the Plan currently utilizes to operate was submitted for approval and an opinion letter was received in 2017. The IRS' opinion is that the form of the Plan is acceptable under Section 403(b).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

## **NOTE 4 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.

## **NOTE 5 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**NOTE 5 – FAIR VALUE MEASUREMENTS** (Continued)

*Level 2:* Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation of other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

*Annuities:* Valued at the net asset value (NAV) of units of the separate accounts. The NAV, as provided by Nationwide, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Please see Note 7 for discussion on NAV.

*Mutual funds:* Valued at the NAV of units of the separate accounts. The NAV, as provided by Nationwide, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Please see Note 7 for discussion on NAV.

## **NOTE 6 – INVESTMENT CONTRACT WITH NATIONWIDE**

The Plan holds a fixed annuity investment contract with Nationwide. The contract is backed by the general account of Nationwide. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value is the relevant measurement attribute for that portion of net assets available for benefits attributed to the contract. Contract value, as reported to the Plan by Nationwide, represents contributions made under the contract, plus earnings, less participant withdrawals and expenses. From a contractual standpoint, the fixed annuity contract does not qualify as fully benefit-responsive under SOP 94-4-1 insofar as the contract restricts participant-directed exchanges. The contract value at December 31, 2024 and 2023, was \$446,432 and \$344,000, respectively.

The investment contract is a non-tradable obligation of Nationwide. If an event should occur such that realization of full contract value is no longer probable, the contract's classification could be further impacted. However, the occurrence of such an event is not considered probable as the contract is an obligation of Nationwide.

## **NOTE 7 – FAIR VALUE OF INVESTMENTS THAT USE NAV**

## **NOTE 8 – FIELD ASSISTANCE BULLETIN (FAB) 2009-02**

Per FAB No. 2009-02, the Plan is allowed to exclude certain participants and their accounts that meet specified guidelines. The Plan is allowed to exclude accounts provided that: (1) the contract or account was issued to a current or former employee before January 1, 2009, (2) the employer ceased to have any obligation to make contributions and in fact ceased making contributions to the contract or account before January 1, 2009, (3) all of the rights and benefits under the contract or account are legally enforceable against the insurer by the individual owner of the contract or account without any involvement by the employer, and (4) the individual owner of the contract or account is fully vested in the contract.

The Plan has elected to exclude certain participants and their accounts and related transactions that meet the above specifications. At December 31, 2024 and 2023, the value of excluded accounts was \$13,030 and \$11,885, respectively.

**NOTE 9 – INFORMATION PREPARED AND CERTIFIED TO BY TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements and supplemental Schedule of Assets Held at End of Year, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified to as complete and accurate by the trustee of the Plan. The trustee prepared and certified the below information.

**NOTE 10 – SURRENDER CHARGES**

The Plan has assets that are invested in participant-directed annuity contracts. The annuity contracts may be subject to surrender charges based on the value of the annuity at time of surrender.

**NOTE 11 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Nationwide, the trustee. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments. The Company pays directly any other fees related to the Plan's operations.

Ameriprise Financial Services is both an owner of RiverSource Life Insurance Company and a Service Provider with respect to the plan investments. Therefore, these transactions qualify as party-in-interest transactions.

**NOTE 12 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 13 – RECENTLY ISSUED PRONOUNCEMENTS APPLICABLE TO FUTURE YEARS**

Accounting Standards Update (ASU) 2022-3 – *Fair Value Measurement*. This amendment is effective for fiscal years beginning after December 15, 2024, and interim periods within those fiscal years. The amendment is meant to clarify the principles for measuring the fair value of an equity security subject to a contractual sale restriction and improve current accounting principles generally accepted in the United States of America by reducing the diversity in practice, reducing cost and complexity in measuring fair value, and increasing comparability of financial information across reporting entities that hold investments. Management has not yet determined the impact of this update on its financial statements.

**NOTE 14 – SUBSEQUENT EVENTS**

For the years ended December 31, 2024 and 2023, the Company has evaluated subsequent events for potential recognition and disclosure through September 30, 2025, the date the financial statements were available to be issued. No material subsequent event items that required recognition or disclosure were identified.
