### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Merchants & Marine Bank 401(k) Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Note 1. Description of the Plan**

The following description of Merchants & Marine Bank 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

**General**

The Plan is a defined contribution plan sponsored by Merchants & Marine Bank (Bank) for the benefit of its employees who have at least one month of service, as defined by the Plan, and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Bank is the plan sponsor and administrator. Reliance Trust Company (Reliance) was the plan custodian through September 15, 2023, and Pentegra Trust Company (Pentegra) is trustee of the Plan. Effective September 15, 2023, Empower Trust Company, LLC (Empower) became plan custodian.

On March 26, 2024, the Plan was amended to allow former employees of Mississippi River Bank, acquired by the Bank in 2024, to participate in the Plan. Prior service credit for purposes of eligibility, vesting, and contribution allocation was granted. The amendment also allows for the merger of the Mississippi River Bank 401(k) Plan into the Plan; however, as of December 31, 2024, that merger had not yet been executed.

**Contributions**

Each year, participants may contribute pretax annual compensation to the Plan subject to Internal Revenue Service (IRS) limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Bank makes Safe-Harbor contributions equal to 3% of eligible employees' salaries and may elect to make profit-sharing contributions. The profit-sharing contributions are discretionary as determined by the Bank's Board of Directors. There were no profit-sharing contributions during 2024 or 2023.

**Participant Investment Account Options**

The Plan currently offers various pooled separate accounts and an investment in a collective trust fund as investment options for participants through its contract with Pentegra. Participants have the option of directing their accounts into any of the separate investment funds and may change the investment options and allocation daily.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Bank's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions and employer Safe-Harbor contributions, plus earnings thereon. Vesting in the Bank's matching and discretionary contribution portions of their accounts plus earnings thereon are based on years of continuous service. A participant is fully vested in matching contributions and discretionary contributions after five years of continuous service. The nonvested balance is forfeited upon termination of service.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through biweekly payroll deductions.

***Payment of Benefits***

On termination of service or attainment of age 59 1/2, a participant with a vested balance of less than \$1,000 shall receive a lump-sum distribution. For accounts exceeding \$1,000, the participant may elect a lump-sum distribution or may elect to defer such distribution to any valuation date subsequent to his or her termination, but no later than the valuation date of his or her normal retirement date, or the participant may elect to roll over the distribution to another qualified plan.

***Forfeited Accounts***

At both December 31, 2024 and 2023, unallocated forfeited nonvested accounts totaled \$0. Forfeitures may be reallocated to participants or used to reduce employer contributions.

***Plan Termination***

Although it has not expressed an intent to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisers, custodians, and insurance companies. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Plan Tax Status***

The Plan operates under an adoption agreement in connection with a volume submitter profit-sharing plan and trust/custodial document sponsored by Pentegra Services, Inc. This prototype plan document has been filed with the appropriate agency and obtained an opinion letter from the IRS stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). The Plan is relying on the prototype plan's opinion letter rather than obtaining or requesting a plan-specific determination letter. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses of the Plan may be paid by the Bank or the Plan at the Bank's discretion.

**Note 3. Certification of Plan Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period from January 1, 2023 through September 15, 2023

Empower, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period from September 15, 2023 through December 31, 2023 and for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

**Note 4. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and certain others. The Plan paid \$23,859 and \$8,493 to Pentegra and Empower in 2024 and 2023, respectively, for administrative and recordkeeping services. The Bank provides certain administrative services at no cost to the Plan. The Plan had a party-in-interest investment in the Reliance Trust Stable Value Fund (collective trust) at December 31, 2023 of \$2,683,959. Reliance was no longer a party-in-interest as of December 31, 2024.

**Note 5. Disclosure About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value.

- Level 1** Quoted prices in active markets for identical assets or liabilities that the entity can access at the measurement date
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the

inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities would be classified within Level 3 of the hierarchy.

The collective trust is comprised of investments primarily in annuity contracts administered by an insurance company, and units of each share class of the collective trust are valued at NAV. The NAV per unit is calculated as of the close of trading on the New York Stock Exchange. The NAV per unit is computed by dividing total assets of the fund, less its liabilities, by the total number of units outstanding at the time of such computation. Unit purchases and redemptions are transacted at the NAV per unit determined as of the close of business each day. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan. There are no unfunded commitments by the Plan related to the collective trust.

**Note 6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7. Subsequent Events**

Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.
