Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Responsibilities of Management for the Financial Statements

Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed

to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Plan Description

The following description of the Rudy L. Hawkins (the “Company”) 401(k) Plan (the “Plan”) is provided for general information only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the Company. Employees of the Company become eligible to receive Company matching and non-elective contributions upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan allows participants to make voluntary deferral contributions up to the maximum percentage allowed not to exceed the limits of Code Section 401(k). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company currently provides for a safe harbor match equal to 100% of each employee’s contribution up to 1% of their wages, then 50% of wages from 1% to 6% determined each payroll. The Company may make a discretionary contribution in addition to the matching contribution.

Participant Accounts

Each participant's account is credited with the participant’s contribution and an allocation of the Company’s contribution, administrative expenses, and Plan earnings. Earnings are specifically allocated based on the earnings of the investments as directed by each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Vesting

Participants are immediately vested in their voluntary contributions. After one year of service, participants are fully vested in the Company’s elective “safe harbor” contributions. Other Company contributions and discretionary contributions vest at a rate of 20% per year, beginning with the completion of two years of service, and become 100% vested after six years of service.

Payment of Benefits

On termination of service for reasons of death, disability, or retirement, a participant will be entitled to 100% of their account balance. A participant may elect to receive either a lump-sum amount equal to the account balance, or the participant may elect to receive the amount in installments, as described in the Plan. If the participant’s accrued benefit is less than \$7,000, the participant is paid a lump-sum payment as soon as practicable after his/her termination date. If the employment is terminated for reasons other than death, disability, or retirement, a participant is entitled to receive only the vested percentage of the account balance and the remainder of the account will be forfeited. A hardship withdrawal may also be taken to satisfy an immediate and heavy financial need that cannot be satisfied from other financial resources. Hardship withdrawals may be taken for reasons as defined in the Plan document.

Administrative Expenses

Plan fees and administrative expenses are paid by the Company or the Plan on a discretionary basis.

Forfeitures

At December 31, 2024 and 2023, the forfeited non-vested account totaled \$1,208 and \$25,229, respectively. This account will be used to reduce future plan administration fees and employer contributions. During 2024, forfeited non-vested accounts reduced plan expenses by \$5,891 and reduced employer contributions by \$42,053.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefits payments are recorded when paid.

Tax Status

The Plan uses a volume submitter plan document of PBMares, LLP “Volume Submitter Profit Sharing Plan with CODA”. The volume submitter plan document has obtained an opinion letter from the *Internal Revenue Service (IRS)* dated June 30, 2020, which states that the volume submitter document satisfies the applicable provisions of the *Internal Revenue Code*. The Plan has not received a determination letter from the *IRS*; however, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the *Internal Revenue Code* and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America (GAAP) require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the *IRS*. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the accompanying financial statements.

Note 3 – Fair Value Measurements

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 consists of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Level 1 Fair Value Measurements

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

Level 2 Fair Value Measurements

The fair value of the collective trust fund is based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e. interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted price for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs. The collective trust fund invests in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While underlying asset values are quoted prices, the net asset value (NAV) of a unit in this fund is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are included in the computation of the NAV and are realized by the participant upon withdrawal. No distributions of income and gain or loss are made to participants.

Note 4 – Investment Contracts

The Plan has investments in the Reliance Trust Company Stable Value Fund Collective Investment Trust, Series 25053. Included in this fund are guaranteed investment contracts and certain wrapper contracts. These contracts are considered to be benefit-responsive and, since these contracts are purchased on the open market, are presented at fair value by the plan. The average yield for the fund was approximately 2.92% and 2.86% for 2024 and 2023, respectively. The objective of the fund is to provide stability of principal and high current income. The fund invests primarily in stable value products, including synthetic guaranteed investment contracts (GICs) issued by MetLife. The percentage of contributions allocated to this fund is determined by the participants.

Note 5 – Related-Party and Party-In-Interest Transactions

The Plan's investments include investment accounts administered by Ascensus Trust Company. Ascensus Trust Company is the trustee and Vanguard is the recordkeeper as defined in the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid for certain recordkeeping and investment services amounted to \$50,154 for the year ended December 31, 2024. Certain administrative functions are performed by employees of the Company. These employees are also Plan participants. No such employee receives compensation from the Plan.
