## Notes to Financial Statements

---

### 1. Plan Description

The following description of the Nite Ize, Inc. 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan was adopted by Nite Ize, Inc. (the Company) effective January 1, 2013, and was most recently amended and restated December 5, 2024. The Plan is a defined contribution plan covering eligible employees of the Company and Participating Employers. The Plan was established under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Trustee and Administration of the Plan*

The trustees of the Plan are two officers of the Company (Officers) and Reliance Trust Company (Trustee). The administrator of the Plan is the Company. T. Rowe Price Retirement Plan Services, Inc. (T. Rowe Price) provides recordkeeping, administrative, and related services to the Plan. The Company determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Each employee is eligible to become a participant in the Plan on the first day of the month coinciding with or following six months of service and reaching age 18. Leased employees, union employees, non-resident aliens, and residents of Puerto Rico are not eligible to participate in the Plan. Part-time employees who complete at least three (two starting January 1, 2025) consecutive 12-month periods in which they complete at least 500 hours of service will be eligible to participate in the Plan.

#### *Contributions*

Eligible participants may contribute, on a pre-tax or Roth after-tax basis, up to 100% of their qualifying annual compensation as elected in their salary deferral agreements. Participant contributions are subject to certain IRC limitations. The Plan also allows catch-up contributions for participants aged 50 or over subject to certain IRC limitations. Salary deferral agreements shall be made, terminated, or changed according to procedures and limitations set up by the plan administrator and the Plan Document.

The plan document provides for safe harbor employer matching contributions. For the year ended December 31, 2024, the Company made a safe harbor employer matching contribution of 100% of the first 3% of compensation, and 50% of the next 2%, deferred on an annual basis.

The plan document provides for discretionary employer matching contributions and discretionary nonelective employer contributions. For the year ended December 31, 2024, no discretionary matching or nonelective employer contributions were made.

Rollover contributions transferred from other qualified retirement plans may also be made subject to certain criteria.

### ***Participants' Accounts***

Participants' accounts are credited with the participants' pre-tax, Roth and catch-up contributions, safe harbor and discretionary employer matching contributions, discretionary nonelective employer contributions, and rollover contributions, as well as an allocation of Plan earnings or losses. Participants' accounts are charged with certain administrative fees that are paid by the Plan. Earnings or losses from investment funds are allocated to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment option. Participants may direct the investment of their account balances into various mutual funds and a stable value common/collective trust fund. The benefit to which participants are entitled is the vested portion of their accounts.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The note is secured by the participant's account and bears an interest rate based upon prevailing commercial lending rates and is fixed for the term of the note. The note may be for a term of up to five years, and is subject to certain other restrictions, as defined by the plan document, and applicable restrictions under the IRC. Principal and interest are paid ratably through payroll deductions. Interest rates for the notes outstanding as of December 31, 2024 ranged from 4.25% to 10%.

### ***Vesting and Forfeitures***

Participants are 100% vested in their participant deferral, safe harbor employer and rollover contributions, and the allocated earnings thereon. Discretionary employer matching and nonelective contributions are 100% vested after three years of service, as defined in the plan document. Participants are also fully vested upon reaching normal retirement age (65), death, disability, or termination of the Plan.

Forfeitures of unvested accounts may be used to offset future employer matching contributions or pay Plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$786 and \$749, respectively. No Forfeitures were used to offset employer matching contributions or pay Plan expenses during the year ended December 31, 2024.

### ***Benefit Payments***

Upon termination of service due to death; separation of service; attainment of normal retirement age (65); or disability, as defined, a participant may elect to receive his/her benefit payment in the form of a lump-sum amount equal to the vested portion of the participant's account balance, installment payments, remain in the Plan, or may roll over the amount to another qualified retirement plan or individual retirement account (IRA). Prior to January 1, 2024, Participants that had separated from service with a vested balance of \$1,000 or less may have been automatically rolled into an IRA. Effective January 1, 2024, distributions will be made to terminated participants with balances of \$7,000 or less, if the participant does not elect another form of distribution. Hardship withdrawals and certain other in-service withdrawals are also allowed by the Plan if certain criteria are met.

### *Plan Termination*

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. If the Plan is terminated for any reason, the participants' accounts will be fully vested and the Plan administrator is to distribute each participant's interest to the participant or their beneficiary.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value as further discussed in Note 4. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date exit price. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and Trustee.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income and capital gains are recorded on the ex-dividend date. The net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Management fees and operating expenses (in the form of an expense ratio) charged to the Plan for investments in the mutual funds and the stable value common/collective trust are deducted from income earned on a daily basis and reflected as a reduction of investment return for such investments.

### *Contributions*

Participant contributions and any related safe harbor matching and discretionary employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective contributions are recorded in the relevant period in accordance with the terms in the plan document. Contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions in the year the excess occurred.

### ***Benefit Payments***

Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid as of year-end.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at the unpaid principal balance. Any accrued, but unpaid interest was de minimis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Expenses of the Plan***

Fees are charged directly to the participant's account and are included in administrative fees. Under the service provider agreement with T. Rowe Price, certain revenue-sharing rebates received from certain mutual funds held by the Plan reduce recordkeeping fees. Fees in excess of rebates are charged to the Plan. Investment-related expenses (in the form of an expense ratio) are included in net appreciation in fair value of investments. All other expenses of the Plan for the year ended December 31, 2024, were paid by the Company and have been excluded from these financial statements.

## **3. Certified Investment Information**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee and T. Rowe Price Trust Company, the trustee of the T. Rowe Price Stable Value Common/Collective Trust Fund, qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as reported in the statements of net assets available for plan benefits as of December 31, 2024 and 2023.
- Net investment income and interest earned on notes receivable from participants as reported in the statement of changes in net assets available for plan benefits for the year ended December 31, 2024.
- Investment amounts included in the notes to financial statements.
- All investment information included in the supplemental Schedule H (Form 5500), Line 4i Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule and reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure

requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 4. Fair Value Measurements and Disclosures

Accounting Standards Codification (ASC) 820, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Government Money Fund* - The cash equivalents are valued at \$1 per unit, similar to a bank savings account, which approximates fair value, and are fully liquid.

*Stable Value Common/Collective Trust Fund* - The T. Rowe Price Stable Value Common/Collective Trust Fund is a stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of the units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the

reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the fund, the issuer reserves the right to require a 12-to-30-month notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The stable value fund is a direct filing entity.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Party-in-Interest and Related Party Transactions

The Plan invests in shares of mutual funds and units of a common/collective trust managed by T. Rowe Price. Certain investment fees are paid to T. Rowe Price and are reflected within the net investment income for the year, as well as certain other indirect fees from mutual fund companies. The Plan also issues loans to participants that are secured by the vested balance of the participants' accounts, and certain loan origination fees are paid to T. Rowe Price. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### 6. Income Tax Status

The Plan adopted a DST Retirement Solutions, LLC Pre-Approved Volume Submitter 401(k) Plan and Trust Document, which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, indicating that it is designed in accordance with the applicable section of the IRC. The Company believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, thus no provision for income taxes has been provided for in the accompanying financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### 7. Risks and Uncertainties

The Plan provides for various investments. Investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions in interest rates. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

### 8. Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued. There were no events or transactions discovered during the evaluation that require recognition or disclosure in the financial statements.
