## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the Piazza Management Company 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Piazza Management Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Piazza Management Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Plan management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that Plan management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Piazza Management Company 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedules are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

## **Responsibilities of Plan Management for the Financial Statements**

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. **1. Description of Plan**

The following description of the Piazza Management Company 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan that was established July 1, 1993, for the exclusive benefit of the employees of Piazza Management Company (the "Plan Sponsor") and affiliated adopting employers. Collectively bargained employees and non-resident aliens are not eligible to participate in the Plan. Management of the Plan Sponsor controls and manages the operation and administration of the Plan. Ascensus Trust Company serves as the trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

**Contributions**

Eligible employees ("participants"), those employees who are at least 21 years of age and have obtained six months of service, may contribute a portion of their compensation, as defined, as a tax-deferred contribution or as a Roth contribution, subject to certain Internal Revenue Code (“IRC”) limitations. In addition, participants who have attained age 50 before the close of the Plan year are eligible to make “catch-up” contributions up to the amount allowable under the IRC. Participants may enter the Plan on the first day of the Plan Year and the first day of the fourth, seventh, and tenth months of the Plan Year immediately following the date on which the eligibility requirements are satisfied. The Plan provides for an automatic enrollment of salary deferral contributions of 4% of eligible compensation, increasing by 1% annually on the first day of the Plan year up to a maximum of 10%, unless otherwise elected by the participant. The Plan Sponsor designates the age-appropriate target fund as the default investment for participants who do not make an affirmative election of an investment fund.

The Plan provides for a discretionary employer matching contribution and a discretionary profit-sharing contribution. For 2024, the Plan Sponsor provided a discretionary employer matching contribution of 15% of the employees’ contributions.

Participants must satisfy a 1,000 hours of service requirement and be employed on the last day of the Plan year in order to share in the discretionary profit-sharing contribution, in years when such contributions are declared by the Plan Sponsor. No discretionary profit-sharing contributions were declared by the Plan Sponsor for the 2024 Plan year.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

**Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Plan Sponsor's discretionary matching contributions, if any, as well as allocations of the Plan Sponsor’s discretionary profit-sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investments**

Participants direct the investment of their contributions, Plan Sponsor discretionary employer matching contributions, and Plan Sponsor discretionary profit-sharing contributions into various investment options offered by the Plan.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's discretionary employer matching contributions and discretionary profit-sharing contributions portion of their accounts is based on years of vesting service. Each eligible participant shall vest in accordance with the following vesting schedule:

0-1	0%
2	25%
3	50%
4	100%

Notwithstanding the above, participants will become 100% vested in the Plan Sponsor's discretionary employer matching contributions and discretionary profit-sharing contributions portion of their accounts upon their attainment of normal retirement age, death or becoming disabled.

**Forfeited Amounts**

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5,893 and \$5,237, respectively. These accounts may be used to pay expenses or to reduce future Plan Sponsor contributions. During the year ended December 31, 2024, forfeitures of \$20,873 were used to pay expenses of the Plan and no amounts were used to reduce employer contributions.

**Notes Receivable from Participants**

Loans to participants are permitted under the Plan and are treated as a participant-directed investment. The minimum loan is \$1,000. The maximum loan available is the lesser of \$50,000 or 50 percent of the participant's vested account balance. A participant may only have one loan outstanding at any time. All outstanding loans become due and payable in their entirety upon the occurrence of a distributable event (other than satisfaction of the conditions for an in-service distribution). Any loan shall bear interest at the prime rate plus 1% at the time of application. The interest rate on loans as of December 31, 2024 was 4.25% through 9.50% with the maturities ranging through 2051.

Loans are repayable within five years unless the loan was taken for the purpose of acquiring the participant's principal residence, in which case the term of the loan may be for a period longer than five years. Principal and interest are paid ratably through payroll deductions. The loans are secured by the balance in the participant's account.

**Benefit Payments**

Plan participants may elect to receive a distribution of vested benefits following the attainment of normal retirement age under the Plan in either a lump sum or partial payments. If a participant's vested account in the Plan is below \$7,000 (\$5,000 prior to modification allowed by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022, "SECURE Act 2.0") at the time of termination or retirement, the Plan may distribute the entire balance to the participant following termination. If a participant's vested account in the Plan is between \$1,000 and \$7,000 (\$5,000 prior to modification allowed by the SECURE Act 2.0) at the time of termination or retirement, the Plan may distribute the entire balance to an individual retirement account established on the participant's behalf. Hardship, disability and in-service distributions are also permitted from participant accounts. In addition, minimum payments must begin subject to Internal Revenue Service ("IRS") guidelines.

## **2. Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

### **Basis of Accounting**

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. Under the modified cash basis, the only assets recognized are: cash; notes receivable from participants (including the related accrued but unpaid interest); investments, which are recorded at fair value; and contributions receivable for amounts related to participant and the related employer matching contributions recorded in the year in which the participant's contributions are withheld from compensation by the employer but not yet received by the Plan. Cash receipts and disbursements transactions are recognized when made. Noncash transactions, except as noted within this summary of significant accounting policies, are not recognized. Accordingly, the accompanying financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in accordance with accounting principles generally accepted in the United States of America.

### **Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator and Plan sponsor determine the Plan's valuation policies utilizing information provided by the trustees, custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### **Contributions**

Contributions from Plan participants and the related discretionary employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Discretionary profit-sharing contributions are recorded in the year in which they are received by the Plan.

### **Payments of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

All reasonable administrative expenses, including trustee and third party administration fees necessary to operate and administer the Plan, are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses of maintaining the Plan that are paid directly by the Plan Sponsor are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. Management fees and operating expenses associated with investments in the mutual funds are deducted from income earned by these

funds on a daily basis and are not separately reflected. Consequently, management fees and operating expenses associated with investments are included in the net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

**3. Information Certified by a Qualified Institution**

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, cash, and notes receivable from participants, as shown in the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, dividends and interest income, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024.
- The information for all mutual funds, the collective investment trust, and participant loans listed in the schedule of assets (held at end of year) – modified cash basis as of December 31, 2024, as shown in the ERISA-required supplemental schedules.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The shares of mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trust:* Valued at the NAV or equivalent based on units of the collective investment trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the collective investment trust less its liabilities. This practical expedient is not used when it is determined to be probable that the collective investment trust will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan is applying the practical expedient as of December 31, 2024 and 2023 to its collective investment trust (Great Gray Collective Investment Trust III for MetLife Group Annuity Contract No. 25554), which is composed primarily of fully benefit-responsive investment contracts. Participants' ownership of the collective investment trust is represented in units. Participant transactions (purchases and sales) may occur daily. The investment objective is interest income and the preservation of capital. This investment option provides guaranteed interest rates, which are adjusted quarterly. MetLife guarantees the principal plus accrued interest, based on credited interest rates, for participant-initiated withdrawals as long as the contract remains active. Interest is credited to the contract at interest rates that reflect the performance of the underlying portfolio. MetLife resets the crediting interest rate by amortizing the difference between the market value of the portfolio and the guaranteed value over the weighted average duration of the underlying investments. Participants will receive the principal and accrued earnings credited to their accounts on withdrawal for allowed events. These events include transfers to other investment options of the Plan, and payments because of retirement, termination of employment, death, disability and in-service withdrawals to the extent allowable by the Plan. It is possible that these redemption rights may be restricted by MetLife in the future in accordance with underlying agreements, including termination of the contract by the Plan sponsor or a full redemption of the collective investment trust.

**5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits – modified cash basis.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts, and all remaining assets in the Plan are to be distributed to the participants by the trustee in accordance with the accrued benefits of such participants as of the date of termination.

**7. Tax Status**

Effective November 1, 2024 (see Note 9) and June 1, 2021, through the adoption of an Ascensus, LLC Pre-Approved Defined Contribution Plan, the Plan was amended and restated. The IRS issued an opinion letter dated June 30, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with applicable IRC requirements as of that date. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. While the accounts of the Plan are maintained and the accompanying financial statements have been prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America, the Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing

jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8. Related-Party and Party-in-Interest Transactions**

Transactions involving Ascensus Trust Company, trustee of the Plan, are considered party-in-interest transactions. Additionally, Vanguard Group, Inc. and affiliates (“Vanguard”) provides, through an outsourcing agreement with Ascensus, LLC, recordkeeping services and the Plan invests in registered investment companies managed by Vanguard. Fees paid by the Plan for administrative services were \$229,671 for the year ended December 31, 2024. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant’s account balance. Therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.

During 2023, the Plan Sponsor failed to remit to the Plan’s trustee certain employee contributions and loan repayments totaling \$7,143 within the period prescribed by the Department of Labor regulations. During 2024, the Plan Sponsor made contributions to the affected participants’ accounts to make the participants whole and compensate those participants for potential lost income due to the 2023 processing delays. The Plan Sponsor believes that these transactions do not affect the tax status of the Plan and has taken action prescribed by the regulations to remedy such errors.

During 2024, the Plan Sponsor failed to remit to the Plan’s trustee certain employee contributions and loan repayments totaling \$11,329 within the period prescribed by the Department of Labor regulations. During 2025, the Plan Sponsor plans to make contributions to the affected participants’ accounts to make the participants whole and compensate those participants for potential lost income due to the 2024 processing delays. The Plan Sponsor believes that these transactions do not affect the tax status of the Plan and is taking action prescribed by the regulations to remedy such errors.

**9. Plan Amendments**

Effective November 1, 2024, the Plan was amended and restated to make administrative updates to the Plan.
